2 An Act to authorize the issuance of special license plates bearing the legend: "DONT TREAD ON ME,"
3 bearing the national motto: "In God We Trust," for members and supporters of the Friends of the
4 Blue Ridge Parkway, Inc., and for supporters of the James River Park System; fees.

7 **Be it enacted by the General Assembly of Virginia:**8 1. § 1. Special license plates bearing the legend: *DONT TREAD ON ME*.9 On receipt of an application and following the provisions of § 46.2-725 of the Code of Virginia, the
10 Commissioner of the Department of Motor Vehicles shall issue to the applicant special license plates
11 bearing the legend: *DONT TREAD ON ME*.

12 § 2. Special license plates bearing the national motto: "In God We Trust."

13 On receipt of an application and following the provisions of § 46.2-725 of the Code of Virginia, the
14 Commissioner of the Department of Motor Vehicles shall issue to the applicant special license plates
15 bearing the national motto: "In God We Trust."16 § 3. Special license plates for members and supporters of the Friends of the Blue Ridge Parkway,
17 Inc.; fees.18 A. On receipt of an application and payment of the fee prescribed by this section, and following the
19 provisions of § 46.2-725 of the Code of Virginia other than those relating to the fee for the plates and
20 its disposition, the Commissioner of the Department of Motor Vehicles shall issue special license plates
21 to members and supporters of the Friends of the Blue Ridge Parkway, Inc.22 B. The annual fee for plates issued pursuant to this section shall be \$25 in addition to the prescribed
23 fee for state license plates. For each such \$25 fee collected in excess of 1,000 registrations pursuant to
24 this section, \$15 shall be paid into the state treasury and credited to a special nonreverting fund known
25 as the Friends of the Blue Ridge Parkway, Inc., Fund established within the Department of Accounts.
26 These funds shall be paid annually to the Friends of the Blue Ridge Parkway, Inc., and used to support
27 its program to clear the scenic overlooks along the Blue Ridge Parkway in order to promote tourism
28 along the Parkway in Virginia. All other fees imposed under the provisions of this section shall be paid
29 to, and received by, the Commissioner of the Department of Motor Vehicles and paid by him into the
30 state treasury and set aside as a special fund to be used to meet the necessary expenses incurred by the
31 Department of Motor Vehicles.

32 § 1. Special license plates for supporters of the James River Park System; fees.

33 A. On receipt of an application and payment of the fee prescribed by this section, and following the
34 provisions of § 46.2-725 of the Code of Virginia other than those relating to the fee for the plates and
35 its disposition, the Commissioner of the Department of Motor Vehicles shall issue to the applicant
36 special license plates for supporters of the James River Park System.37 B. The annual fee for plates issued pursuant to this section shall be \$25 in addition to the prescribed
38 fee for state license plates. For each such \$25 fee collected in excess of 1,000 registrations pursuant to
39 this section, \$15 shall be paid into the state treasury and credited to a special nonreverting fund known
40 as the James River Park System Fund established within the Department of Accounts. These funds shall
41 be paid annually to the Friends of the James River Park and used to support its operation and
42 programs in Virginia. All other fees imposed under the provisions of this section shall be paid to, and
43 received by, the Commissioner of the Department of Motor Vehicles, and paid by him into the state
44 treasury and set aside as a special fund to be used to meet the necessary expenses incurred by the
45 Department of Motor Vehicles.
