5	adding a section numbered 63.2-601.1, relating to the Temporary Assistance for Needy Families

11	Be it enacted by the General Assembly of Virginia:
12	1. That § 63.2-600 of the Code of Virginia is amended and reenacted and that the Code of
13	Virginia is amended by adding a section numbered 63.2-601.1, as follows:
14	§ 63.2-600. Temporary Assistance for Needy Families (TANF); purpose; administration.
15	A. There is hereby created the Temporary Assistance for Needy Families Program, hereinafter
16	referred to as TANF or the "Program." The Program shall be administered by the Department in
17	compliance with Titles IV-A and IV-F of the Social Security Act and related federal regulations
18	(excluding 45 C.F.R. Parts 255 and 256), as such laws and regulations were in effect at the time of the
19	enactment of the Personal Responsibility and Work Opportunity Reconciliation Act of 1996, P.L.
20 21	104-193 on August 22, 1996, to the extent that such laws and regulations do not conflict with (i) those sections of P.L. 104-193 which are mandatory; (ii) waivers granted by the Department of Health and
22	Human Services to Virginia in effect as of January 1, 1997; (iii) state laws and regulations; (iv) the
23	State Plan For Title IV-A of the Social Security Act: Financial Assistance Aid to Families with
24	Dependent Children in effect as of September 30, 1996; or (v) the Title IV-F of the Social Security Act
25	Job Opportunities and Basic Skills Training Program State Plan in effect as of September 30, 1996.
26	Further, in any instance where a state law or regulation enacted pursuant to a waiver conflicts with the
27	terms of P.L. 104-193 or the Title IV-A or IV-F State Plans, such state law or regulation shall control.
28	B. The General Assembly declares that it is the policy of the Commonwealth to support the efforts of
29 30	public agencies and charitable and community groups seeking to assist low-income Virginians in their efforts to become self-sufficient. To this end, the Department is designated as the state agency
30 31	responsible for coordinating state efforts in this regard.
32	§ 63.2-601.1. Temporary Assistance for Needy Families Fund established.
33	A. There is hereby created in the state treasury a special nonreverting fund to be known as the
34	Temporary Assistance for Needy Families Fund, hereafter referred to as "the Fund." The Fund shall be
35	established on the books of the Comptroller. All donations and contributions to the Fund and such
36	moneys as shall be appropriated by the General Assembly shall be paid into the state treasury and
37	credited to the Fund. Interest earned on moneys in the Fund shall remain in the Fund and be credited
38	to it. Any moneys remaining in the Fund, including interest thereon, at the end of each fiscal year shall
39 40	not revert to the general fund but shall remain in the Fund. Moneys in the Fund shall be used solely for the purposes set forth in this section. Moneys in the Fund shall be used to:
41	<i>I. Supplement the assistance provided through the Department's administration of the Temporary</i>
42	Assistance for Needy Families block grant; and
43	2. Assist the Commonwealth in maximizing the amount of funds available to serve the stated
44	purposes of the TANF program by leveraging individual, corporate, and charitable donations.
45	B. Expenditures and disbursements from the Fund shall be made by the State Treasurer on warrants
46	issued by the Comptroller upon written request signed by the Commissioner. Up to 12 percent of the
47 10	Fund may be used to pay the Department's expenses in administering the Temporary Assistance for
48 49	Needy Families Program. C. The Department shall administer the Fund in accordance with the provisions of this section.
49 50	C. The Deputiment shall dominister the Fund in accordance with the provisions of this section.
