VIRGINIA ACTS OF ASSEMBLY - CHAPTER

An Act to amend and reenact § 2.2-2101 of the Code of Virginia, as it is currently effective and as it shall become effective, and to amend the Code of Virginia by adding in Chapter 27 of Title 2.2 an article numbered 10, consisting of sections numbered 2.2-2734 through 2.2-2737, relating to the creation of the Southwest Virginia Cultural Heritage Foundation.

8 Be it enacted by the General Assembly of Virginia:

9 1. That § 2.2-2101 of the Code of Virginia, as it is currently effective and as it may become 10 effective, is amended and reenacted and that the Code of Virginia is amended by adding in 11 Chapter 27 of Title 2.2 an article numbered 10, consisting of sections numbered 2.2-2734 through 12 2.2-2737, as follows:

\$ 2.2-2101. (Effective until July 1, 2013) Prohibition against service by legislators on boards,
 commissions, and councils within the executive branch; exceptions.

15 Members of the General Assembly shall be ineligible to serve on boards, commissions, and councils within the executive branch of state government who are responsible for administering programs 16 established by the General Assembly. Such prohibition shall not extend to boards, commissions, and 17 18 councils engaged solely in policy studies or commemorative activities. If any law directs the 19 appointment of any member of the General Assembly to a board, commission, or council in the executive branch of state government that is responsible for administering programs established by the 20 21 General Assembly, such portion of such law shall be void, and the Governor shall appoint another 22 person from the Commonwealth at large to fill such a position.

Southwest Virginia Cultural Heritage Foundation.

§ 2.2-2734. Southwest Virginia Cultural Heritage Foundation established; purpose.

85 The Southwest Virginia Cultural Heritage Foundation (the Foundation) is hereby established as a body politic and corporate. The purpose of the Foundation is to encourage the economic development of 86 Southwest Virginia through the expansion of cultural and natural heritage ventures and initiatives 87 88 related to tourism and other asset-based enterprises, including the Heartwood: Southwest Virginia's 89 Artisan Center, The Crooked Road, 'Round the Mountain, and other related cultural and natural 90 heritage organizations and venues that promote entrepreneurial and employment opportunities. 91

§ 2.2-2735. Membership; qualifications; terms; vacancies; officers; compensation.

A. The Foundation shall be administered by a board of trustees, consisting of 22 members as 92 93 follows: two members of the Senate to be appointed by the Senate Committee on Rules; three members of the House of Delegates to be appointed by the Speaker of the House of Delegates in accordance with 94 95 the principles of proportional representation contained in the Rules of the House of Delegates; two 96 nonlegislative citizen members who shall be residents of Southwest Virginia and two nonlegislative 97 citizen members who shall be executive directors of either Planning District Commission 1, 2, 3, 4, or 98 12 or their designees, to be appointed by the Governor; one nonlegislative citizen member who shall be 99 an elected or appointed official of the Town of Abingdon to be appointed by the Governor upon the 100 recommendation, if any, of the Abingdon Town Council; one nonlegislative citizen member who shall be an elected or appointed official of Washington County to be appointed by the Governor upon the 101 102 recommendation, if any, of the Washington County Board of Supervisors; four nonlegislative citizen members who shall be artisans and members of 'Round the Mountain, who shall be appointed by the 103 104 Governor upon the recommendation of the executive committee of 'Round the Mountain; and one nonlegislative citizen member who shall represent the Ninth Congressional District and serve as a 105 member of the Virginia Commission for the Arts, to be appointed by the Governor upon the 106 107 recommendation, if any, of the Executive Director of the Virginia Commission for the Arts. The 108 President of Virginia Highlands Community College or his designee shall serve ex officio with nonvoting 109 privileges. The Chairman of The Crooked Road, the Chairman of 'Round the Mountain, the Director of 110 the Virginia Department of Housing and Community Development, the Director of the Virginia Tourism Corporation, and the Executive Director of the Southwest Virginia Higher Education Center or their 111 112 designees shall serve ex officio with voting privileges.

113 B. Legislative members and ex officio members of the Foundation board of trustees shall serve terms 114 coincident with their terms of office. Appointments to fill vacancies, other than by expiration of a term, 115 shall be for the unexpired term. Vacancies shall be filled in the same manner as the original appointments. All members may be reappointed. 116

C. No House member shall serve more than four consecutive two-year terms, no Senate member 117

shall serve more than two consecutive four-year terms, and no nonlegislative citizen member shall serve
more than two consecutive four-year terms. The remainder of any term to which a member is appointed
to fill a vacancy shall not constitute a term in determining the member's eligibility for reappointment.

D. Legislative members shall receive such compensation as provided in § 30-19.12. All members of the Foundation shall be reimbursed for all reasonable and necessary expenses incurred in the performance of their duties as provided in §§ 2.2-2813 and 2.2-2825. Funding for the costs of compensation and expenses of the members shall be provided by the Department of Housing and Community Development.

E. The Foundation shall elect a chairman and a vice-chairman from among its members and may
appoint such other officers as it deems necessary. The Foundation shall appoint an executive committee
and such other committees as it deems necessary to oversee personnel and other areas related to
operations and the achievement of the goals of the Foundation.

130 § 2.2-2736. Powers and duties of the Foundation.

131 A. The Foundation shall have the power and duty to:

132 1. Accept, execute, and administer any trust in which it may have an interest under the terms of the133 instrument creating the trust;

134 2. Establish and administer agreements with public or private agencies in order to achieve its goals;
135 3. Rent, lease, including the execution of leases with option to purchase, buy, own, acquire, and
136 dispose of such property, real and personal, as the Foundation deems proper to carry out any of the
137 purposes and provisions of this article;

4. Finance, fund, plan, establish, construct, enlarge, extend, equip, update, and maintain buildings,
 structures, and facilities that are necessary or desirable to achieve its goals;

140 5. Establish a corporation eligible for exemption from income taxation under § 501(c) of the Internal
141 Revenue Code to assist in carrying out the purposes of the Foundation;

6. Operate, manage, and oversee the retail sales, demonstration, performance, and interpretation of
artisan, musical, or other cultural activities, food and visitor services, and other functions as may be
necessary or desirable to achieve its goals;

145 7. Employ and compensate such employees and agents as the Foundation deems necessary. The
146 Foundation may appoint an executive director who shall be authorized to employ such staff as necessary
147 to enable the Foundation to achieve its goals. The Foundation shall determine the duties of such staff
148 and fix salaries and compensation from such funds as may be received;

149 8. Borrow and seek, accept, and expend gifts, grants, or donations from public or private sources;

150 9. Manage the operations of any existing or new facility in accordance with the provisions of this article;

152 10. Facilitate the sustainability of economic development initiatives relating to the cultural and
 153 natural heritage of Southwest Virginia by providing financial resources and technical assistance to
 154 organizations and venues that contribute to achieving the goals of the Foundation;

155 11. Serve as a resource and referral center by maintaining and disseminating information about 156 Southwest Virginia cultural and natural heritage efforts and venues;

157 12. Develop specific goals and initiatives intended to improve the quality of life and entrepreneurial
158 opportunities in Southwest Virginia in coordination with the Virginia Tourism Corporation, the Virginia
159 Department of Housing and Community Development, Southwest Virginia tourism and economic
160 development organizations, local governments, and other entities; and

161 13. Submit to the Governor and the General Assembly no later than the first day of each regular
162 session of the General Assembly an annual report for publication as a report document in accordance
163 with the procedures established by the Division of Legislative Automated Systems for legislative
164 documents and reports.

165 B. The Foundation may establish nonprofit, nonstock corporations under Chapter 10 (§ 13.1-801 et 166 seq.) of Title 13.1 as public instrumentalities exercising public and essential governmental functions to assist the Foundation in (i) encouraging the economic development of Southwest Virginia through the 167 168 expansion of cultural and natural heritage ventures and initiatives related to tourism and other 169 asset-based enterprises, including the Southwest Virginia Artisan Center, The Crooked Road, 'Round the 170 Mountain, and related cultural and natural heritage organizations and venues that promote 171 entrepreneurial and employment opportunities and (ii) conducting other activities useful in carrying out 172 the provisions of this article.

173 The board of directors of any such corporation shall be composed of the chairman of the Foundation
174 and eight persons appointed by the Foundation. The terms of the members of any corporation
175 established shall be four years.

176 The Foundation shall require any such corporation to report to it at least annually on its activities.

177 § 2.2-2737. Staffing.

178 The Department of Housing and Community Development shall provide additional staff support to

179 the Foundation. All agencies of the Commonwealth shall provide assistance to the Foundation, upon 180 request.

2. That as of July 1, 2011, the Southwest Virginia Cultural Heritage Foundation shall be deemed 181 182 successor in interest to the Southwest Virginia Cultural Heritage Commission to the extent that 183 this act transfers powers and duties. All right, title, and interest in and to any real or tangible personal property vested in the Southwest Virginia Cultural Heritage Commission to the extent 184 that this act transfers powers and duties as of July 1, 2011, shall be transferred to and taken as 185 standing in the name of the Southwest Virginia Cultural Heritage Foundation. 186

187 3. That the Governor may transfer an appropriation or any portion thereof within a state agency established, abolished or otherwise affected by the provisions of this act or from one such agency 188 189 to another to support the changes in organization or responsibility resulting from or required by 190 this act.

191 4. That, with the exception of the Chancellor of the Virginia Community College System, any 192

- individual serving a term as a commissioner of the Southwest Virginia Cultural Heritage Commission in accordance with the provisions of former § 2.2-2533 of the Code of Virginia shall 193
- continue his term of office as a member of the board of trustees of the Southwest Virginia 194
- 195 Cultural Heritage Foundation on July 1, 2011.
