AMENDMENT IN THE NATURE OF A SUBSTITUTE

- 5 6 A BILL to amend and reenact §§ 46.2-339, 46.2-341.9, and 46.2-341.10 of the Code of Virginia and to 7 amend the Code of Virginia by adding a section numbered 46.2-341.18.3, relating to certain drivers 8 of certain commercial vehicles. Q
 - Be it enacted by the General Assembly of Virginia:

That §§ 46.2-339, 46.2-341.9, and 46.2-341.10 of the Code of Virginia are amended and 10 1. 11 reenacted and that the Code of Virginia is amended by adding a section numbered 46.2-341.18:3 12 as follows:

§ 46.2-339. Qualifications of school bus driver; examination.

14 No person shall drive any school bus on a highway in the Commonwealth unless he has had a 15 reasonable amount of experience in driving motor vehicles, and has passed a special examination pertaining to his ability to drive a school bus with safety to its passengers and to other persons using the 16 17 highways. Such person shall obtain a commercial driver's license with the applicable classifications and endorsements, issued pursuant to the Virginia Commercial Driver's License Act (§ 46.2-341.1 et seq.), if 18 the school bus he drives is a commercial motor vehicle as defined in the Virginia Commercial Driver's 19 20 License Act. For the purpose of preparing for the examination required by this section, any person 21 holding a valid driver's license issued under Article 4 of this chapter, may drive, under the direct 22 supervision of a person holding a valid school bus license endorsement, a school bus which contains no 23 other passengers, provided that, on and after April 1, 1992, only persons holding a valid commercial 24 driver's license or instruction permit issued under the provisions of the Virginia Commercial Driver's 25 License Act, may operate, under the direct supervision of a person holding a valid commercial driver's 26 license with a school bus endorsement, a school bus which is a commercial motor vehicle as defined in 27 the Virginia Commercial Driver's License Act and which contains no pupil passengers. The Department 28 may adopt regulations necessary to provide for the examination of persons desiring to qualify to drive 29 school buses in the Commonwealth and for the granting of permits to qualified applicants. 30 Notwithstanding the provisions of this section otherwise, no person shall drive any school bus on a 31 highway in the Commonwealth during any period in which he is a person for whom registration with 32 the Sex Offender and Crimes Against Minors Registry is required pursuant to Chapter 9 (§ 9.1-900 et 33 seq.) of Title 9.1. 34

§ 46.2-341.9. Eligibility for commercial driver's license.

35 A Virginia commercial driver's license shall be issued only to a person who drives or intends to drive a commercial motor vehicle and who is domiciled in the Commonwealth, provided that any person 36 37 who is domiciled in a jurisdiction outside the United States, but has resided in the Commonwealth for a period of six weeks, shall be eligible for a commercial driver's license under such terms and conditions 38 39 as the Department may require.

40 No person shall be eligible for a Virginia commercial driver's license until he has applied for such 41 license and has passed the applicable vision, knowledge and skills tests required by this article, and has satisfied all other applicable licensing requirements imposed by the laws of the Commonwealth. 42

No person shall be eligible for a Virginia commercial driver's license during any period in which he 43 44 is disqualified from driving a commercial motor vehicle, or his driver's license or privilege to drive is 45 suspended, revoked or cancelled in any state, or during any period wherein the restoration of his license or privilege is contingent upon the furnishing of proof of financial responsibility. 46

47 No person shall be eligible for a Virginia commercial driver's license until he surrenders all other **48** driver's licenses issued to him by any state.

49 No person under the age of twenty-one years shall be eligible for a commercial driver's license, except that a person who is at least eighteen years of age may be issued a commercial driver's license, 50 provided that such person is exempt from or is not subject to the age requirements of the federal Motor 51

Carrier Safety Regulations contained in 49 C.F.R. Part 391, and is not prohibited from operating a 52 53 commercial motor vehicle by the Virginia Motor Carrier Safety Regulations, and has so certified. No 54 person under the age of twenty-one years shall be issued a hazardous materials endorsement.

55 No person shall be eligible for a Virginia commercial driver's license to drive a Type S vehicle, as defined in subsection B of § 46.2-341.16, during any period in which he is a person for whom registration with the Sex Offender and Crimes Against Minors Registry is required pursuant to Chapter 56 57 9 (§ 9.1-900 et seq.) of Title 9.1. 58

The Department, upon receiving an application on forms prescribed by the Commissioner and upon 60 the applicant's satisfactory completion of the vision and knowledge tests required for the class and type 61 62 of commercial motor vehicle to be driven by the applicant may, in its discretion, issue to such applicant 63 a commercial driver's instruction permit. Such permit shall expire one year after issuance and shall 64 entitle the applicant to drive a commercial motor vehicle of the class and type designated on the permit, 65 but only when accompanied by a person licensed to drive the class and type of commercial motor vehicle driven by the applicant. The person accompanying the permit holder shall occupy the seat 66 closest to the driver's seat for the purpose of giving instruction to the permit holder in driving the 67 68 commercial motor vehicle.

69 No person shall be issued a commercial driver's instruction permit unless he possesses a valid70 Virginia driver's license or has satisfied all the requirements necessary to obtain such a license.

No person shall be issued a commercial driver's instruction permit to drive school buses during any
period in which he is a person for whom registration with the Sex Offender and Crimes Against Minors
Registry is required pursuant to Chapter 9 (§ 9.1-900 et seq.) of Title 9.1.

74 It shall be unlawful for any instruction permit holder to operate a commercial motor vehicle without
75 being accompanied by a licensed driver as provided in this section. Persons who violate this section
76 shall be guilty of a Class 2 misdemeanor.

77 The Department shall charge a fee of three dollars for each instruction permit issued under the provisions of this section.

79 § 46.2-341.18:3. Cancellation of commercial driver's license endorsement for certain offenders.

80 The Commissioner shall cancel the Type S school bus endorsement for any person holding a

81 commercial driver's license or commercial driver's instruction permit who is convicted of an offense for

82 which registration is required in the Sex Offender and Crimes Against Minors Registry pursuant to

83 Chapter 9 (§ 9.1-900 et seq.) of Title 9.1.
