## VIRGINIA ACTS OF ASSEMBLY - CHAPTER

2 An Act to amend and reenact §§ 2.2-2715 and 2.2-2716 of the Code of Virginia, relating to the Veterans 3 Services Foundation.

## Approved

- Be it enacted by the General Assembly of Virginia: 6
- 7 1. That §§ 2.2-2715 and 2.2-2716 of the Code of Virginia are amended and reenacted as follows: 8 § 2.2-2715. Veterans Services Foundation; purpose; membership; terms; compensation; staff.

9 A. The Veterans Services Foundation (the Foundation) is established as a *an independent* body 10 politic and corporate agency supporting the Department of Veterans Services in the executive branch of state government. The Foundation shall be governed and administered by a board of trustees. The Foundation shall (i) administer the Veterans Services Fund (the Fund), (ii) provide funding for veterans 11 12 services and programs in the Commonwealth through the Fund, and (iii) raise revenue from all sources 13 including private source fundraising to support the Fund. The Foundation shall submit a quarterly report 14 to the Commissioner of Veterans Services on the Foundation's funding levels and services and an 15 16 annual report to the Secretary of Veterans Affairs and Homeland Security on or before November 30 of each year. The quarterly report and the annual report shall be submitted electronically. 17

B. The board of trustees of the Foundation shall consist of the Commissioner of Veterans Services 18 19 and the Chairmen of the Board of Veterans Services and the Joint Leadership Council of Veterans Service Organizations or their designees, who shall serve as ex officio voting members, and 16 members 20 21 to be appointed as follows: (i) eight nonlegislative citizens appointed by the Governor; five nonlegislative citizens appointed by the Speaker of the House of Delegates; and three nonlegislative 22 23 citizens appointed by the Senate Committee on Rules. A majority of the trustees shall be active or 24 retired chairmen, chief executive officers, or chief financial officers for large private corporations or 25 nonprofit organizations or individuals who have extensive fundraising experience in the private sector. 26 Trustees appointed shall, insofar as possible, be veterans. Each appointing authority shall endeavor to 27 ensure a balanced geographical representation on the Board to facilitate fundraising efforts across the 28 state.

29 After initial appointments, members shall be appointed for a term of four years. Appointments to fill 30 vacancies, other than by expiration of a term, shall be for the unexpired terms. All members may be 31 reappointed. However, no member shall serve more than two consecutive four-year terms. The remainder 32 of any term to which a member is appointed to fill a vacancy shall not constitute a term in determining 33 the member's eligibility for reappointment. Vacancies shall be filled in the same manner as the original 34 appointments. Any member of the Board of Trustees may be removed at the pleasure of the appointing 35 authority.

36 C. Trustees shall be reimbursed for their actual expenses incurred while attending meetings of the 37 trustees or performing other duties. However, such reimbursement shall not exceed the per diem rate 38 established for members of the General Assembly pursuant to § 30-19.12.

39 D. The Secretary of Public Safety shall designate a state agency to provide the Foundation with 40 administrative and other services.

41 E. The trustees shall adopt bylaws governing their organization and procedures and may amend the 42 same. The trustees shall elect from their number a chairman and such other officers as their bylaws may 43 provide. Ex officio members shall not be eligible to serve as chairman. The trustees shall meet four 44 times a year at such times as they deem appropriate or on call of the chairman. A majority of the voting members of the board of trustees shall constitute a quorum. 45

F. Any person designated by the board of trustees to handle the funds of the Foundation or the Fund 46 shall give bond, with corporate surety, in a penalty fixed by the Governor, conditioned upon the faithful 47 **48** discharge of his duties. Any premium on the bond shall be paid from funds available to the Foundation.

- 49 § 2.2-2716. Authority of Foundation.
- 50 The Foundation has the authority to:

1. Administer the Veterans Services Fund and make expenditures allocations of revenue from the 51 Fund to the Department of Veterans Services to provide supplemental funding for the Department's 52 53 services and programs;

54 2. Accept, hold, and administer gifts and bequests of money, securities, or other property, absolutely 55 or in trust, for the purposes for which the Foundation is created;

56 3. Enter into contracts and execute all instruments necessary and appropriate to carry out the

- Foundation's purposes; 4. Take such actions as may be reasonably necessary to seek, promote, and stimulate contributions for the Fund;
- 5. Develop other possible dedicated revenue sources for the Fund; and6. Perform any lawful acts necessary or appropriate to carry out the purposes of the Foundation.
