10 11	Be it enacted by the General Assembly of Virginia:
11 12	1. That § 22.1-253.13:9 of the Code of Virginia is amended and reenacted as follows: § 22.1-253.13:9. Virginia Index of Performance incentive program.
13	A. Schools and local school divisions shall be recognized by the Board of Education in accordance
14	with guidelines it shall establish for the Virginia Index of Performance (VIP) incentive program. The
15	VIP incentive program shall be designed to recognize and reward fully accredited schools and school
16	divisions that make significant progress toward achieving advanced proficiency levels in reading,
17	mathematics, science, and history and social science, and on other indicators of school and student
18	performance that are aligned with the Commonwealth's goals for public education. Such recognition may
19	include:
20 21	 Public announcements recognizing individual schools and divisions; Tangible rewards;
21	3. Waivers of certain board regulations;
$\overline{23}$	4. Exemptions from certain reporting requirements; or
24	5. Other commendations deemed appropriate to recognize high achievement.
25	In addition to Board recognition, local school boards shall adopt policies to recognize individual
26	schools through public announcements or media releases as well as other appropriate recognition.
27	B. A school that maintains a passing rate on Virginia assessment program tests or additional tests
28	approved by the Board of 95 percent or above in each of the four core academic areas for two
29 30	consecutive years may, upon application to the Department of Education, receive a waiver from annual accreditation. A school receiving such a waiver shall be fully accredited for a three-year period.
30 31	However, such school shall continue to annually submit documentation in compliance with the
32	pre-accreditation eligibility requirements.
33	C. Schools may be eligible to receive the Governor's Award for Outstanding Achievement. This
34	award will be given to schools rated fully accredited that significantly increase the achievement of
35	students within student subgroups in accordance with guidelines prescribed by the Board of Education.
36	D. In order to encourage school divisions to promote student achievement in science, technology,
37	engineering, and mathematics, the Board of Education shall take into account in its guidelines a school

D. In order to encourage school divisions to promote student achievement in science, technology, engineering, and mathematics, the Board of Education shall take into account in its guidelines a school division's increase in enrollments and elective course offerings in these areas.
