WHEREAS, an admired jurist, Judge Clarke served two terms as Chief Judge and has heard a variety
 of cases, presiding with great decorum, honor, and commitment to equal justice for all during her
 tenure; and

WHEREAS, respected by her colleagues for her insight and knowledge of the law, Judge Clarke has
contributed to her profession as a member of the American Bar Association Judicial Division; Virginia,
National, and International Association of Women Judges; American Judicature Society; and Virginia
Bar Association Commission on the Needs of Children; and

WHEREAS, Judge Clarke has been an active community supporter, serving as a life member of the
Virginia Parent Teacher Association, member of the Arlington Committee of 100, and former local
president and member of the state board of directors for the American Association of University Women
in addition to numerous other organizations; and

WHEREAS, Judge Clarke has received numerous awards and honors throughout her distinguished
 career for her professional accomplishments and public service; and

WHEREAS, in her retirement, Judge Clarke looks forward to spending time with her husband,
Frederic B. Clarke III, and children, Peter E. Stambaugh, Dr. Elisabeth M. Stambaugh, Frederic B.
