"Soil science" means the science dealing with the physical, chemical, mineralogical, and biological properties of soils as aural bodies. "Soil scientist" means a person having special knowledge of soil science and the methods and principles of soil evaluation as acquired by education and experience in the formation, description and mapping of soils. "Virginia certified <i>licensed</i> professional soil scientist" means a person who possesses the qualifications required for e <del>ertification licensure</del> by the Board. 59 2. The work of an employee or a subordinate of a certified licensed soil scientist or of an individual 60 who is practicing soil evaluation without being certified;

3. The work of an employee or a subordinate of a certified professional wetland delineator or of an 61 62 individual who is practicing wetland delineation without being certified;

63 4. The work of any professional engineer, landscape architect, or land surveyor as defined by 64 § 54.1-400 in rendering any of the services that constitute the practice of wetland delineation or the 65 practice of soil evaluation; or

5. The practice of any profession or occupation which is regulated by another regulatory board 66 within the Department of Professional and Occupational Regulation. 67

B. Nothing in this chapter shall authorize an individual to engage in the practice of engineering, the 68 practice of land surveying or the practice of landscape architecture, unless such individual is licensed or 69 certified pursuant to Chapter 4 (§ 54.1-400 et seq.) of this title. 70 71

§ 54.1-2202. Board; membership; quorum.

Notwithstanding the provisions of § 54.1-200, the Board for Professional Soil Scientists and Wetland 72 Professionals shall be composed of seven members as follows: three certified licensed professional soil 73 74 scientists, three certified professional wetland delineators and one citizen member. The professional soil 75 scientist members shall have experience in at least one of the following areas (i) soil mapping and 76 classification, (ii) soil suitability and land use, (iii) teaching and research in soil science, and (iv) 77 environmental protection regulations. Of the wetland professional members, one shall have experience in 78 wetland delineation and description, one shall have experience in teaching and research in wetland 79 science and one shall have experience with natural resource regulations. For the initial appointments of the wetland professionals the terms shall be as follows: one member shall serve a term of two years, one 80 member shall serve a term of three years, and one member shall serve a term of four years. Initial appointments of wetland professional members to the Board shall not be certified professional wetland 81 82 83 delineators but shall have a record of at least ten years of experience in wetland delineation. Subsequent 84 terms of the members shall be for four years.

85 The Board shall annually elect a chairman from its membership. Four board members, consisting of two soil scientists and two professional wetland delineators, shall constitute a quorum. 86

The Governor may select the professional soil scientist members from a list of at least three names 87 88 for each vacancy submitted by the Virginia Association of Professional Soil Scientists. The Governor 89 may notify the Virginia Association of Professional Soil Scientists of any professional vacancy other 90 than by expiration among the professional soil scientist members of the Board and nominations may be 91 made for the filling of the vacancy.

92 The Governor may select the wetland professionals from a list of at least three names for each 93 vacancy submitted by the Virginia Association of Wetland Professionals. The Governor may notify and request nominations from the Virginia Association of Wetland Professionals of any professional vacancy 94 95 other than by expiration among the wetland professional members. 96

§ 54.1-2203. Eligibility for certification as wetland delineator.

97 A. Any person practicing or offering to practice as a soil scientist in the Commonwealth may submit 98 to the Board evidence of qualification to be certified as provided in this chapter. The Board may certify 99 any applicant who has satisfactorily met the requirements of this chapter and its regulations and shall 100 specify on the certificate the appropriate endorsement.

B. Any person practicing or offering to practice as a wetland professional in the Commonwealth may 101 submit to the Board evidence of qualification to be a certified professional wetland delineator as 102 provided in this chapter. The Board may certify any applicant who has satisfactorily met the 103 requirements of this chapter and its regulations and shall specify on the certificate the appropriate 104 105 endorsement.

 $\subseteq B$ . Any individual who allows his certification to lapse by failing to renew the certificate or failing 106 107 to meet professional activity requirements stipulated in the regulations may be reinstated by the Board 108 upon submission of satisfactory evidence that he is practicing in a competent manner and upon payment 109 of the prescribed fee. 110

§ 54.1-2205. License required; application; requirements for licensure; continuing education.

111 A. No person shall engage in, or offer to engage in, the practice of soil evaluation in the Commonwealth unless he has been licensed under the provisions of this chapter. 112

113 B. In order to be certified licensed as a professional soil scientist, an applicant shall achieve:

114 1. Submit satisfactory evidence verified by affidavits that the applicant:

115 a. Is 18 years of age or more;

b. Is of good moral character; and 116

c. Has successfully completed such educational and experiential requirements as are required by this 117 chapter and the regulations of the Board. 118

119 2. Achieve a score acceptable to the Board on an examination in the principles and practice of soil evaluation and satisfy one of the following criteria: 120

121 4-a. Hold a bachelor's degree from an accredited institution of higher education in a soils curriculum 122 which has been approved by the Board and have at least four years of experience in soil evaluation, the 123 quality of which demonstrates to the Board that the applicant is competent to practice as a professional 124 soil scientist; or

125 2.b. Hold a bachelor's degree in one of the natural sciences and have at least five years of experience 126 in soil evaluation, the quality of which demonstrates to the Board that the applicant is competent to 127 practice as a professional soil scientist; or

128 3-c. Have a record of at least eight years of experience in soil evaluation, the quality of which 129 demonstrates to the Board that the applicant is competent to practice as a professional soil scientist; or

130 4-d. Have at least four years of experience in soil science research or as a teacher of soils curriculum 131 in an accredited institution of higher education which offers an approved four-year program in soils and 132 at least two years of soil evaluation experience, the quality of which demonstrates to the Board that the 133 applicant is competent to practice as a professional soil scientist.

134 B. Notwithstanding the requirements in subsection A, any person appointed to serve on the Board as 135 a professional soil scientist member prior to July 1, 1991, shall be deemed certified for the purposes of 136 this chapter.

137 C. The Board shall establish by regulation requirements for continuing education as a prerequisite to 138 renewal of a license issued under this chapter, not to exceed eight contact hours per year.

139 D. Individuals applying for a license as a professional soil scientist between January 1, 2010, and 140 January 1, 2013, who (i) have been certified as professional soil scientists by the Board or (ii) have 141 achieved a score acceptable to the Board on the examination required by this section, shall be licensed 142 by the Board if all other requirements of this chapter or Board regulations have been met, unless an 143 applicant is found by the Board to have engaged in any act that would constitute grounds for 144 disciplinary action.

145 § 54.1-2206. Waiver of examination.

146 A. The Board may waive the requirement for examination pursuant to § 54.1-2205 upon written 147 application from an individual who holds an unexpired certificate or license, or its equivalent, issued by 148 a regulatory body of another state, territory or possession of the United States and is not the subject of 149 any disciplinary proceeding before such regulatory body which could result in the suspension or 150 revocation of his certificate or license, if such other state, territory or possession recognizes the 151 certificates *license* issued by the Board.

152 B. The Board shall waive the requirement for examination pursuant to § 54.1-2206.2 upon the written 153 application from an individual who holds an unexpired certificate or its equivalent issued by a regulatory 154 body of another state, territory or possession of the United States or has been provisionally certified 155 under the U.S. Army Corps of Engineers Wetland Delineator Certification Program of 1993 and is not 156 the subject of any disciplinary proceeding before such regulatory body, which could result in the 157 suspension or revocation of his certificate.

158 § 54.1-2207. Unprofessional conduct.

159 Any professional soil scientist who is licensed or any wetland delineator who is certified, as provided 160 in this chapter, shall be considered guilty of unprofessional conduct and subject to disciplinary action by 161 the Board, if he: 162

1. Obtains his certification or license through fraud or deceit;

163 2. Violates or cooperates with others in violating any provision of this chapter, the Code of 164 Professional Ethics and Conduct or any regulation of the Board;

165 3. Performs any act likely to deceive, defraud or harm the public;

166 4. Demonstrates gross negligence, incompetence or misconduct in the practice of soil evaluation or 167 wetland delineation; or 168

5. Is convicted of a felony.

169 § 54.1-2208. Unlawful representation as a licensed professional soil scientist or certified wetland 170 delineator.

171 A. No person shall represent himself as a *certified licensed* professional soil scientist unless he has 172 been so certified licensed by the Board. Any person practicing or offering to practice soil evaluation within the meaning of this chapter who, through verbal claim, sign, advertisement, or letterhead, 173 174 represents himself as a certified licensed professional soil scientist without holding such a certificate a 175 *license* from the Board shall be guilty of a Class 1 misdemeanor.

176 B. No person shall represent himself as a certified professional wetland delineator unless he has been 177 so certified by the Board. Any person practicing or offering to practice wetland delineation within the 178 meaning of this chapter who, through verbal claim, sign, advertisement, or letterhead, represents himself 179 as a certified professional wetland delineator without holding such a certificate from the Board shall be 180 guilty of a Class 1 misdemeanor.

181 2. That this act shall not be construed to affect existing professional soil scientists appointments to

- 182 the Board for Professional Soil Scientists and Wetland Professionals for which the terms have not
- expired. However, any new appointments made after the effective date of this act shall be made inaccordance with the provisions of this act.
