19 20	§ 2.2-306. Secure Commonwealth Panel; membership; duties; compensation; staff.
20 21	A. The Secure Commonwealth Panel (the Panel), is established as an advisory board, within the meaning of § 2.2-2100, in the executive branch of state government. The Panel shall consist of 34
$\frac{21}{22}$	members as follows: three members of the House of Delegates and two nonlegislative citizens to be
$\frac{1}{23}$	appointed by the Speaker of the House of Delegates; three members of the Senate of Virginia and two
24	nonlegislative citizens to be appointed by the Senate Committee on Rules; the Lieutenant Governor; the
25	Attorney General; the Executive Secretary of the Supreme Court of Virginia; the Assistant to the
26	Governor for Commonwealth Preparedness, the Secretary of Commerce and Trade, the Secretary of
27	Health and Human Resources, the Secretary of Public Safety, the Secretary of Technology and the
28	Secretary of Transportation or their designees; two local first responders; three local government
29 30	representatives; two physicians with knowledge of public health; four members from the business or inductry sector, and four additional members from the private sector attices from the Commonwealth at
30 31	industry sector; and four additional members from the private sector citizens from the Commonwealth at large. Except for appointments made by the Speaker of the House of Delegates and the Senate
32	Committee on Rules, all other appointments shall be made by the Governor. Additional ex officio
33	members may be appointed to the Panel by the Governor at his discretion. Legislative members shall
34	serve terms coincident with their terms of office or until their successors shall qualify. Nonlegislative
35	citizen members shall serve for terms of four years. The Assistant to the Governor of the Office shall be
36	the chairman of the Panel.
37	B. The Panel shall monitor and assess the implementation of statewide prevention, preparedness,
38 39	response, and recovery initiatives and where necessary to review, evaluate, and make recommendations
39 40	relating to the emergency preparedness of government at all levels in the Commonwealth. Additionally, the Panel shall facilitate cabinet-level coordination among the various agencies of state government
41	related to emergency preparedness and shall facilitate private sector preparedness and communication.
42	The Panel shall make quarterly reports to the Governor concerning the state's emergency preparedness,
43	response, recovery, and prevention efforts.
44	C. Members of the Panel shall serve without compensation but shall be reimbursed for all reasonable
45	and necessary expenses incurred in the discharge of their duties as provided in § 2.2-2825.
46	D. Staff support for the Panel and funding for the costs of expenses of the members shall be
47	provided by the Office of Commonwealth Preparedness.
48 49	§ 2.2-1503. Filing of six-year revenue plan by Governor.
49 50	A. In every year, the Governor shall by December 15 prepare and submit to the members of the General Assembly an estimate of anticipated general fund revenue, an estimate of anticipated
51	transportation fund revenues, and estimates of anticipated revenues for each of the remaining major
52	nongeneral funds, for a prospective period of six years.
53	The Governor's estimates of anticipated general, transportation, and other nongeneral fund revenues
54	shall be based on the following:
55	1. Forecasts of economic activity in the Commonwealth.
56	2. Review by an advisory board of economists with respect to economic assumptions and technical
57 58	econometric methodology. The Joint Advisory Board of Economists (the Board) is established as an advisory board, within the meaning of $\$ 2.2,2100$ in the avacutive branch of state government for such
58 59	advisory board, within the meaning of § 2.2-2100, in the executive branch of state government for such purpose. The Board shall be chaired by the Secretary of Finance, and consist of the Staff Director of the

60 House Committee on Appropriations, the Staff Director of the Senate Committee on Finance, and 15 61 nonlegislative citizen members, 12 to be appointed by the Governor, at least eight being citizens of the Commonwealth, and three by the Joint Rules Committee, at least two being citizens of the 62 63 Commonwealth. The 15 nonlegislative citizen members of the Board shall (i) be economists from either 64 the public or private sector; (ii) serve at the pleasure of the appointing authority; (iii) be citizens of the 65 United States with at least 10 being citizens of the Commonwealth; (iv) have their vacancies filled in 66 the same manner as the original appointments; and (v) not receive compensation for their services, but 67 shall be reimbursed for all reasonable and necessary expenses for the performance of their duties as provided in §§ 2.2-2813 and 2.2-2825. Funding for the costs of expenses of the members shall be 68 provided by the Department of Taxation. The Department of Taxation shall provide staff support. A 69 majority of the members of the Board shall constitute a quorum. Meetings of the Board shall be held 70 71 upon the call of the chairman or whenever a majority of the members so request.

72 3. Review by an advisory council of revenue estimates with respect to economic assumptions and the general economic climate of the Commonwealth. The Advisory Council on Revenue Estimates (the 73 74 Council) is established as an advisory council, within the meaning of § 2.2-2100, in the executive branch 75 of state government for such purpose. The Council, of which the Governor shall be chairman, shall include the Speaker and Majority Leader of the House of Delegates; the President pro tempore and 76 77 Majority Leader of the Senate; the Chairmen of the House Committee on Appropriations, the House 78 Committee on Finance, and the Senate Committee on Finance or their designees; two members of the 79 House of Delegates to be appointed by the Speaker of the House, two members of the Senate to be 80 appointed by the Chairman of the Senate Committee on Finance; and 15 to 20 nonlegislative citizen members representing the private sector appointed by the Governor. Legislative members appointed shall 81 serve terms coincident with their terms of office and nonlegislative citizen members shall serve at the 82 83 pleasure of the Governor. All members shall be citizens of the Commonwealth. Vacancies shall be filled 84 in the same manner as the original appointments. Members shall not receive compensation for their services, but shall be reimbursed for all reasonable and necessary expenses for the performance of their 85 duties as provided in §§ 2.2-2813 and 2.2-2825. Funding for the costs of expenses of the members shall 86 87 be provided by the Department of Taxation. The Department of Taxation shall provide staff support. A 88 majority of the members of the Council shall constitute a quorum. Meetings of the Council shall be held 89 upon the call of the chairman or whenever a majority of the members so request. 90

4. Any such other advisory bodies as the Governor may desire.

91 B. At the time the Governor submits the estimate of general fund revenues in accordance with 92 subsection A, he shall also submit any alternative general fund revenue forecasts considered by the 93 Advisory Council on Revenue Estimates.

94 § 2.2-2261. Virginia Public Building Authority created; purpose; membership; terms; expenses; staff.

95 There is created a political subdivision of the Commonwealth to be known as the "Virginia Public Building Authority." The Authority is created for the purpose of constructing, improving, furnishing, 96 97 maintaining, acquiring, financing, refinancing, and operating public buildings for the use of the Commonwealth (heretofore or hereafter constructed), state arsenals, armories, and military reserves, state 98 99 institutions of every kind and character (heretofore and hereafter constructed), additions and 100 improvements to land grant colleges, state colleges, universities and medical colleges, and the purchase 101 of lands for rehabilitation purposes in connection with state institutions and for use of state colleges, and 102 museum facilities for a trust instrumentality of the United States, and the purchase of lands for the 103 development of public buildings that may be authorized by the General Assembly in the future, the 104 acquisition of items of personal property for the use of the Commonwealth, the constructing, improving, maintaining, acquiring, financing, and refinancing of major information technology projects as defined in 105 § 2.2-2006, the financing or refinancing of capital projects that benefit the Commonwealth and any of its 106 107 agencies, authorities, boards, departments, instrumentalities, institutions, or regional or local authorities, 108 the provision of financing on behalf of any of the Commonwealth's agencies, authorities, boards, 109 departments, instrumentalities, institutions, or regional or local authorities or governments of land, 110 buildings, infrastructure, and improvements for the benefit of an MEI project incentive package endorsed by the MEI Project Approval Commission created pursuant to § 30-309, and the financing or refinancing 111 112 of reimbursements to localities or governmental entities of all or any portion of the Commonwealth's share of the costs for capital projects made pursuant to other applicable provisions of Virginia law, and 113 114 the refinancing of (i) obligations issued by other state and local authorities or political subdivisions of 115 the Commonwealth where such obligations are secured by a lease or other payment agreement with the 116 Commonwealth or (ii) the Commonwealth's obligations under such leases or payment agreements, the purpose and intent of this article being to benefit the people of the Commonwealth by, among other 117 118 things, increasing their commerce and prosperity.

The Authority shall be comprised of the State Treasurer or his designee, the State Comptroller, and 119 120 five additional members appointed by the Governor, subject to confirmation by the General Assembly, who shall serve at the pleasure of the Governor. Unconfirmed appointments shall expire 30 days after 121

122 the convening of the General Assembly. Members of the Authority shall be entitled to no compensation 123 for their services as members, but shall be reimbursed for all reasonable and necessary expenses incurred 124 in the discharge of their duties as provided in § 2.2-2825. The term of each member appointed by the 125 Governor shall be five years.

126 Vacancies in the membership of the Authority shall be filled by appointment for the unexpired
127 portion of the term. The Governor shall designate one member of the Authority as chairman who shall
128 serve a two-year term. No member shall be eligible to serve more than two consecutive terms as
129 chairman. The Department of the Treasury shall serve as staff to the Authority.

\$ 2.2-2282. Board of directors; membership; terms, compensation and expenses; chairman,
 vice-chairman, secretary and treasurer; quorum; staff.

132 A. The Board shall consist of the State Treasurer or his designee, the Director of the Department of 133 Business Assistance, and nine members who are not employees of the Commonwealth or of any political 134 subdivision thereof who shall be appointed by the Governor and who shall have such small business 135 experience as he deems necessary or desirable. The appointment of members of the Board by the 136 Governor shall be subject to confirmation by the General Assembly. All members of the Board shall be 137 residents of the Commonwealth and shall have full voting privileges. Appointments shall be for terms of 138 four years, except that appointments to fill vacancies shall be made for the unexpired terms. No member 139 appointed by the Governor shall serve more than two complete terms in succession. The members of the 140 Board shall receive no salaries but shall be paid travel and other expenses incurred to attend meetings or 141 while otherwise engaged in the discharge of their duties, all as may be deemed appropriate by the 142 Board.

143 B. The Governor shall appoint one member as chairman for a two-year term. No member shall be 144 eligible to serve more than two consecutive terms as chairman. Five members of the Board shall 145 constitute a quorum for the transaction of all business of the Authority. The Board shall elect one 146 member from the group of nine members appointed by the Governor as vice-chairman who shall 147 exercise the powers of the chairman in the absence of the chairman. The Board shall elect a secretary 148 and a treasurer, or a secretary-treasurer, who need not be members of the Board and who shall continue 149 to hold such office until their respective successors are elected. The Department of Business Assistance 150 of the Commonwealth shall serve as staff to the Authority.

\$ 2.2-2400. Art and Architectural Review Board; members and officers; travel expenses; quorum;
 compensation; staff; report.

153 A. The Art and Architectural Review Board (the Board) is established as an advisory board, within 154 the meaning of § 2.2-2100, in the executive branch of state government. The Board shall consist of six 155 members as follows: the Director of the Department of Historic Resources, or his designee, serving as 156 an ex officio member and five citizen members, appointed by the Governor. Of the citizen members, 157 one shall be an architect who may be appointed from a list of two or more architects nominated by the 158 governing board of the Virginia Society of the American Institute of Architects; one shall may be 159 appointed from a list of two or more persons nominated by the governing board of the University of 160 Virginia; one shall be appointed from a list of persons nominated by a member of the board of trustees of the Virginia Museum of Fine Arts; and two shall be appointed from the Commonwealth at large, one 161 162 of whom shall be a painter or sculptor. Lists of nominees shall be submitted at least 60 days before the 163 expiration of the member's term for which the nominations are being made in order to be considered by 164 the Governor in making appointments pursuant to this section.

165 B. The Beginning July 1, 2011, the Governor's appointments of the five citizen members shall be 166 staggered as follows: two members for a term of one year, two members for a term of two years, and one member for a term of three years. Thereafter, members of the Board shall be appointed for terms of 167 168 four years each, except appointments to fill vacancies, which shall be for the unexpired terms. No 169 member shall serve for more than two consecutive four-year terms, except that any member appointed to 170 the unexpired term of another shall be eligible to serve two consecutive four-year terms. Vacancies shall 171 be filled in the manner of the original appointments. The Director of the Department of Historic 172 Resources shall serve a term coincident with his term of office.

173 C. Annually, the Board shall elect a chairman and vice-chairman and may elect such other officers as
174 the Board deems proper from among its membership. A majority of the members of the Board shall
175 constitute a quorum.

D. The members of the Board shall serve without compensation, but shall be reimbursed for allreasonable and necessary expenses incurred in the discharge of their duties as provided in § 2.2-2825.

E. The Division of Engineering and Buildings of the Department of General Services shall provide assistance to the Board in the undertaking of its responsibilities.

180 F. The Board shall submit a biennial report to the Governor and General Assembly on or before181 October 1 of each even-numbered year.

182 § 2.2-2404. Design-Build/Construction Management Review Board; membership; terms;

183 compensation; staff; seal.

184 A. The Design-Build/Construction Management Review Board (the "Review Board") is established as 185 an advisory board, within the meaning of § 2.2-2100, in the executive branch of state government.

186 B. The Board shall consist of nine members to be appointed by the Governor as follows: the 187 Director of the Division of Engineering and Buildings of the Department of General Services, or his 188 designee; two Class A general contractors who may be selected from a list of two or more persons for 189 each position recommended by the Associated General Contractors; one architect and one engineer who may be selected from a list of two or more persons for each position recommended by the Consulting 190 Engineers Council of Virginia, the Virginia Society of the American Institute of Architects, and the 191 Virginia Society of Professional Engineers; and four representatives of public bodies other than the 192 193 Commonwealth who may be selected from a list of two or more persons for each position recommended by the Virginia Municipal League and the Virginia Association of Counties. Each such list, other than 194 195 those recommended as representatives of public bodies, shall include the names of at least four persons 196 who are experienced and actively engaged in competitive sealed bidding or competitive negotiation and 197 in design-build or construction management procedures. The list for representatives of public bodies 198 shall include at least four persons who are experienced in competitive sealed bidding or competitive 199 negotiation and in design-build or construction management procedures. Lists of nominees shall be 200 submitted at least 60 days before the expiration of the member's term for which the nomination is being 201 made in order to be considered by the Governor in making appointments pursuant to this section. The 202 Director of the Division of Engineering and Buildings or his designee shall be a nonvoting member of 203 the Review Board, except in the event of a tie vote of the Review Board.

204 C. After the original appointments, all appointments shall be for terms of four years, except that appointments to fill vacancies shall be for the unexpired terms. No person shall be eligible to serve for 205 206 more than two successive full terms, except the Director of the Division of Engineering and Buildings, who shall serve until a successor qualifies. 207

D. The Review Board shall elect its chairman and vice-chairman from among its members. The 208 209 Review Board shall meet monthly to conduct its business as required by § 2.2-2405. However, monthly 210 meetings may be canceled by the chairman if there is no business before the Review Board. Five 211 members shall constitute a quorum.

212 E. Members of the Review Board shall receive no compensation for their services, but shall be 213 reimbursed for all reasonable and necessary expenses incurred in the discharge of their duties as 214 provided in § 2.2-2825.

215 F. Such staff support as is necessary for the conduct of the Review Board's business shall be 216 furnished by the Division of Engineering and Buildings of the Department of General Services pursuant 217 to § 2.2-1134. 218

G. The Review Board shall adopt a seal by which it shall authenticate its proceedings.

§ 2.2-2413. Small Business Advisory Board; membership; terms; quorum; compensation.

220 A. The Small Business Advisory Board (the "Board") is established as an advisory board, within the 221 meaning of § 2.2-2100, in the executive branch of state government. The Board shall consist of the 222 following members: fourteen 14 members appointed by the Governor and subject to confirmation by the 223 General Assembly; the Chairman of the Small Business Financing Authority and the Director of the 224 Department of Business Assistance and the District Director for Virginia of the U.S. Small Business 225 Administration or their designees as nonvoting ex officio members. The appointed members of the Board shall represent small businesses as defined by the Small Business Financing Act (§ 2.2-2279 et 226 227 seq.). There shall be at least one member appointed from each congressional district who does business 228 in that district and three members appointed at large from within the Commonwealth.

229 B. Terms of the appointed members shall be for four years except that appointments to fill vacancies 230 shall be for the unexpired terms. No member appointed by the Governor shall serve more than two 231 complete terms in succession.

232 C. The Governor shall appoint one member of the Board to be chairman for a term of two years. No 233 member shall be eligible to serve more than two consecutive terms as chairman. The Board shall 234 annually elect one of its members as vice-chairman, and shall also elect annually a secretary, who need 235 not be a member of the Board. The chairman, or in his absence, the vice-chairman, shall preside at all 236 meetings of the Board. In the absence of both the chairman and the vice-chairman at any meeting, the 237 Board shall elect a chairman pro tempore, who shall preside at such meeting.

238 D. The Board shall meet at least semiannually, at the call of the chairman, Director of the 239 Department of Business Assistance or Governor or at the request of a majority of the Board members. A 240 majority of the members of the Board shall constitute a quorum.

241 E. Members of the Board shall serve without compensation but shall be reimbursed for all reasonable 242 and necessary expenses incurred in the discharge of their duties as provided in § 2.2-2825.

243 § 2.2-2666.1. Council created; composition; compensation and expenses; meetings; chairman's 244 executive summary.

245 A. The Virginia Military Advisory Council (the Council) is hereby created as an advisory council, 246 within the meaning of § 2.2-2100, in the executive branch of state government, to maintain a 247 cooperative and constructive relationship between the Commonwealth and the leadership of the several 248 Armed Forces of the United States and the military commanders of such Armed Forces stationed in the 249 Commonwealth, and to encourage regular communication on continued military facility viability, the 250 exploration of privatization opportunities and issues affecting preparedness, public safety and security.

251 B. The Council shall be composed of 27 28 members as follows: the Lieutenant Governor, the 252 Attorney General, the Secretary of Public Safety, the Adjutant General, the Assistant to the Governor for 253 Commonwealth Preparedness, the Chairman of the House Committee on Militia, Police and Public 254 Safety and the Chairman of the Senate Committee on General Laws, or their designees; four members, 255 one of whom shall be a representative of the Virginia State Defense Force, to be appointed by and serve 256 at the pleasure of the Governor; and 17 members, including representatives of major military commands 257 and installations located in the Commonwealth or in jurisdictions adjacent thereto, who shall be 258 appointed by requested to serve by the Governor after consideration of the persons nominated by the 259 Secretaries of the Armed Forces of the United States and who shall serve at the pleasure of the Governor. However, any legislative member who is appointed by the Governor shall serve a term 260 coincident with his term of office. The provisions of § 49-1 shall not apply to federal civilian officials 261 262 and military personnel appointed to the Council.

263 C. Legislative members of the Council shall receive such compensation as provided in § 30-19.12, 264 and nonlegislative members shall receive such compensation as provided in § 2.2-2813 for the 265 performance of their duties. All members shall be reimbursed for all reasonable and necessary expenses 266 incurred in the performance of their duties as provided in §§ 2.2-2813 and 2.2-2825. Funding for the 267 costs of compensation and expenses of the members shall be provided by the Department of Military 268 Affairs.

269 D. The Council shall elect a chairman from among its membership. The vice-chairman of the 270 Council shall be the Assistant to the Governor for Commonwealth Preparedness. The meetings of the 271 Council shall be held at the call of the chairman or whenever the majority of members so request. A 272 majority of the members shall constitute a quorum.

273 E. The chairman of the Council shall submit to the Governor and the General Assembly an annual 274 executive summary of the interim activity and work of the Council no later than the first day of each 275 regular session of the General Assembly. The executive summary shall be submitted as provided in the 276 procedures of the Division of Legislative Automated Systems for the processing of legislative documents 277 and reports and shall be posted on the General Assembly's website.

278 § 2.2-2669. Virginia Workforce Council; purpose; membership; terms; compensation and expenses; 279 staff.

280 A. The Virginia Workforce Council (the Council) is established as a policy council, within the 281 meaning of § 2.2-2100, in the executive branch of state government. The purpose of the Council shall be 282 to assist the Governor in meeting workforce training needs in the Commonwealth. 283

B. The Council shall consist of 29 members as follows:

284 1. The Council shall include two members of the House of Delegates to be appointed by the Speaker 285 of the House of Delegates; and two members of the Senate to be appointed by the Senate Committee on 286 Rules. Legislative members shall serve terms coincident with their terms of office and may be 287 reappointed for successive terms.

288 2. The Governor or his designee; the Secretaries of Commerce and Trade, Education, and Health and 289 Human Resources; the Chancellor of the Virginia Community College System; the Commissioner of the 290 Virginia Employment Commission; and the president of the Virginia AFL-CIO shall serve as members.

291 3. The Governor shall appoint members as follows: one mayor and one chairperson of a county 292 board of supervisors; one representative of labor in addition to the president of the Virginia AFL-CIO; 293 and 15 nonlegislative citizen members representing the business community, to include the presidents of 294 the Virginia Chamber of Commerce and the Virginia Manufacturer's Association, one representative of 295 proprietary employment training schools, one representative of health care employers, and the remaining 296 members who are business owners, chief executive officers, chief operating officers, chief financial 297 officers, senior managers or other business executives or employers with optimum policy-making or 298 hiring authority and who shall represent diverse regions of the state, to include urban, suburban, and 299 rural areas, at least two of whom shall be members of local workforce investment boards. Nonlegislative 300 citizen members may be nonresidents of the Commonwealth.

301 Members appointed in accordance with this subdivision shall serve four-year terms, subject to the 302 pleasure of the Governor, and may be reappointed.

303 C. If one person appointed to fill one of the enumerated positions in subsection B also qualifies to 304 fill any other of the enumerated positions, such person may, at the discretion of the Governor, be 305 deemed to fill any or all of the enumerated positions for which such person qualifies.

306 D. The Governor shall select a chairman and vice-chairman, who shall serve two-year terms, from 307 among the 15 members representing the business community appointed in accordance with subdivision B308 3 of subsection B. No member shall be eligible to serve more than two consecutive terms as chairman. 309 The Council shall meet upon the call of the chair or the Governor.

310 E. Compensation and reimbursement of expenses of the members shall be as follows:

311 1. Legislative members appointed in accordance with subdivision B 1 shall receive such 312 compensation and reimbursement of expenses incurred in the performance of their duties as provided in 313 §§ 2.2-2813, 2.2-2825, and 30-19.12.

314 2. Members of the Council appointed in accordance with subdivision B 2 shall not receive compensation but shall be reimbursed for all reasonable and necessary expenses incurred in the 315 performance of their duties as provided in §§ 2.2-2813 and 2.2-2825. 316

3. Members of the Council appointed in accordance with subdivision B 3 shall not receive 317 compensation but shall be reimbursed for all reasonable and necessary expenses incurred in the 318 319 performance of their duties as provided in §§ 2.2-2813 and 2.2-2825.

320 Funding for the costs of compensation and expenses of the members shall be provided from federal 321 funds received under the Workforce Investment Act of 1998 (P.L. 105-220, as amended).

322 F. The Office of the Chancellor of the Virginia Community College System shall provide strategic 323 guidance and staff support to the Council. 324

§ 2.2-2696. Substance Abuse Services Council.

325 A. The Substance Abuse Services Council (the Council) is established as an advisory council, within 326 the meaning of § 2.2-2100, in the executive branch of state government. The purpose of the Council is 327 to advise and make recommendations to the Governor, the General Assembly, and the State Board of Behavioral Health and Developmental Services on broad policies and goals and on the coordination of 328 329 the Commonwealth's public and private efforts to control substance abuse, as defined in § 37.2-100.

B. The Council shall consist of 30 members. Four members of the House of Delegates shall be 330 331 appointed by the Speaker of the House of Delegates, in accordance with the principles of proportional 332 representation contained in the Rules of the House of Delegates, and two members of the Senate shall 333 be appointed by the Senate Committee on Rules. The Governor shall appoint one member representing 334 the Virginia Sheriffs' Association, one member representing the Virginia Drug Courts Association, one 335 member representing the Substance Abuse Certification Alliance of Virginia, two members representing 336 the Virginia Association of Community Services Boards, and two members representing statewide consumer and advocacy organizations. The Council shall also include the Commissioner of Behavioral 337 338 Health and Developmental Services; the Commissioner of Health; the Commissioner of the Department 339 of Motor Vehicles; the Superintendent of Public Instruction; the Directors of the Departments of Juvenile Justice, Corrections, Criminal Justice Services, Medical Assistance Services, and Social Services; the Chief Operating Officer of the Department of Alcoholic Beverage Control; the Executive 340 341 342 Director of the Governor's Office for Substance Abuse Prevention or his designee; the Executive Director of the Virginia Foundation for Healthy Youth or his designee; the Executive Director of the 343 344 Commission on the Virginia Alcohol Safety Action Program or his designee; and the chairs or their designees of the Virginia Association of Drug and Alcohol Programs, the Virginia Association of 345 346 Alcoholism and Drug Abuse Counselors, and the Substance Abuse Council and the Prevention Task Force of the Virginia Association of Community Services Boards. 347

348 C. Appointments of legislative members and heads of agencies or representatives of organizations 349 shall be for terms consistent with their terms of office. All other Beginning July 1, 2011, the Governor's 350 appointments of the seven nonlegislative citizen members shall be staggered as follows: two members for 351 a term of one year, three members for a term of two years, and two members for a term of three years. Thereafter, appointments of nonlegislative members shall be for terms of three years, except an 352 353 appointment to fill a vacancy, which shall be for the unexpired term. The Governor shall appoint a 354 chairman from among the members for a two-year term. No member shall be eligible to serve more 355 than two consecutive terms as chairman.

356 No person shall be eligible to serve more than two successive terms, provided that a person 357 appointed to fill a vacancy may serve two full successive terms.

358 D. The Council shall meet at least four times annually and more often if deemed necessary or 359 advisable by the chairman.

360 E. Members of the Council shall receive no compensation for their services but shall be reimbursed 361 for all reasonable and necessary expenses incurred in the performance of their duties as provided in §§ 2.2-2813 and 2.2-2825. Funding for the cost of expenses shall be provided by the Department of 362 363 Behavioral Health and Developmental Services.

F. The duties of the Council shall be:

364

1. To recommend policies and goals to the Governor, the General Assembly, and the State Board of 365 Behavioral Health and Developmental Services; 366

367 2. To coordinate agency programs and activities, to prevent duplication of functions, and to combine

368 all agency plans into a comprehensive interagency state plan for substance abuse services;

369 3. To review and comment on annual state agency budget requests regarding substance abuse and on 370 all applications for state or federal funds or services to be used in substance abuse programs;

371 4. To define responsibilities among state agencies for various programs for persons with substance 372 abuse and to encourage cooperation among agencies; and

373 5. To make investigations, issue annual reports to the Governor and the General Assembly, and make 374 recommendations relevant to substance abuse upon the request of the Governor.

375 G. Staff assistance shall be provided to the Council by the Office of Substance Abuse Services of the 376 Department of Behavioral Health and Developmental Services. 377

§ 2.2-2699.1. Aerospace Advisory Council; purpose; membership; compensation; chairman.

378 A. The Aerospace Advisory Council (the Council) is established as an advisory council, within the 379 meaning of § 2.2-2100, in the executive branch of state government. The purpose of the Council shall be 380 to advise the Governor, the Joint Commission on Technology and Science, and the Secretaries of 381 Commerce and Trade, Technology, and Education on policy and funding priorities with respect to 382 aerospace economic development, workforce training, educational programs, and educational curriculum. 383 The Council shall suggest strategies to attract and promote the development of existing aerospace 384 companies, new aerospace companies, federal aerospace agencies, aerospace research, venture and 385 human capital, and applied research and technology that contribute to the growth and development of 386 the aerospace sector in the Commonwealth.

387 B. The Council shall have a total membership of 19 members that shall consist of four legislative 388 members and 15 nonlegislative citizen members. Members shall be appointed as follows: three members 389 of the House of Delegates to be appointed by the Speaker of the House of Delegates in accordance with 390 the principles of proportional representation contained in the Rules of the House of Delegates; one 391 member of the Senate, to be appointed by the Senate Committee on Rules and 15 nonlegislative citizen 392 members, of whom one shall represent the Mid-Atlantic Regional Spaceport, one shall represent Old 393 Dominion University, one shall represent the University of Virginia, one shall represent Virginia Tech, 394 and five shall represent aerospace companies or suppliers within the Commonwealth, to be appointed by 395 the Governor, and serve with voting privileges. The Directors of the Department of Aviation, the 396 National Institute of Aerospace, the Virginia Tourism Authority and the Virginia Space Grant 397 Consortium shall serve as ex officio members with voting privileges. A representative of NASA Wallops 398 Flight Facility and a representative of NASA's Langley Research Center, each to be appointed -shall be 399 *requested to serve* by the Governor, shall serve as ex officio members with nonvoting privileges. 400 Legislative members shall serve terms coincident with their terms of office. Other members shall be 401 appointed for terms of two years. Appointments to fill vacancies, other than by expiration of a term, 402 shall be for the unexpired terms. Vacancies shall be filled in the same manner as the original 403 appointments. All members may be reappointed.

404 C. Legislative members of the Council shall receive such compensation as provided in § 30-19.12. 405 Nonlegislative citizen members shall serve without compensation or reimbursement for reasonable and 406 necessary expenses. Funding for compensation and expenses of legislative members shall be provided by 407 the operating budgets of the Clerk of the House of Delegates and the Clerk of the Senate upon approval 408 of the Joint Rules Committee. All other expenses of the Council shall be provided by the Department of 409 Aviation.

410 D. The Council shall elect a chairman and a vice-chairman annually from among its legislative 411 membership. A majority of the members shall constitute a quorum. The Council shall meet at such times 412 as may be called by the chairman or a majority of the Council.

413 E. Staff to the Council shall be provided by the Department of Aviation. The Division of Legislative 414 Services shall provide additional staff support to legislative members serving on the Council.

415 § 2.2-2699.5. Information Technology Advisory Council; membership; terms; quorum; compensation; 416 staff.

417 A. The Information Technology Advisory Council (ITAC) is established as an advisory council, 418 within the meaning of § 2.2-2100, in the executive branch of state government. The ITAC shall be 419 responsible for advising the CIO and the Secretary of Technology on the planning, budgeting, acquiring, 420 using, disposing, managing, and administering of information technology in the Commonwealth.

421 B. The ITAC shall consist of not more than 14 16 members as follows: (i) one representative from 422 an agency under each of the Governor's Secretaries, as set out in Chapter 2 (§ 2.2-200 et seq.), to be 423 appointed by the Governor and serve with voting privileges; (ii) the Secretary of Technology and the 424 CIO who shall serve ex officio with voting privileges; and (iii) the Secretary of the Commonwealth or 425 his designee; (iv) the Assistant to the Governor for Commonwealth Preparedness or his designee; and 426 (v) at the Governor's discretion, not more than two nonlegislative citizen members to be appointed by 427 the Governor and serve with voting privileges.

428 Nonlegislative citizen members shall be appointed for terms of four years. Appointments to fill

429 vacancies, other than by expiration of a term, shall be for the unexpired terms. All members may be 430 reappointed. However, no nonlegislative citizen member shall serve more than two consecutive four-year 431 terms. The remainder of any term to which a member is appointed to fill a vacancy shall not constitute 432 a term in determining the member's eligibility for reappointment. Vacancies shall be filled in the same 433 manner as the original appointments.

434 C. The Secretary of Technology shall serve as chairman of the ITAC. The CIO shall serve as 435 vice-chairman. A majority of the members shall constitute a quorum. The ITAC shall meet at least 436 quarterly each year. The meetings of the ITAC shall be held at the call of the chairman or whenever the 437 majority of the members so request.

438 D. Nonlegislative citizen members shall receive compensation and shall be reimbursed for all reasonable and necessary expenses incurred in the performance of their duties, as provided in §§ 2.2-2813 and 2.2-2825. Funding for the costs of compensation and expenses of the members shall be 439 440 441 provided by the Virginia Information Technologies Agency.

442 E. The disclosure requirements of subsection B of § 2.2-3114 of the State and Local Government Conflict of Interests Act shall apply to citizen members of the ITAC. 443 444

F. The Virginia Information Technologies Agency shall serve as staff to the ITAC.

445 § 3.2-1301. Cattle Industry Board; composition and appointment of members.

446 A. The Cattle Industry Board, established by the passage of a referendum held pursuant to Chapter 447 375 of the 1983 Acts of Assembly, is continued within the Department.

448 The Cattle Industry Board shall be composed of 15 members, each of whom shall be a citizen of the 449 United States and a resident of the Commonwealth. Each member shall have been actively engaged in 450 the type of production or business that he will represent on the Cattle Industry Board for at least five 451 years, shall derive a substantial proportion of his income from such production or business, and shall 452 continue to be actively engaged in such production or business during his term.

453 B. The Governor shall appoint the members, who represent the various segments of the industry as 454 follows:

455 1. Seven commercial beef cattle producers, one from each feeder cattle production area of the 456 Commonwealth. The seven areas shall be designated by the Virginia Cattlemen's Association in general 457 accordance with feeder cattle marketing practices.

458 2. Two dairymen.

- 459 3. One commercial cattle feeder.
- 460 4. Two purebred beef cattle breeders.
- 461 5. Two livestock market operators.
- 462 6. One meat packer or processor.

C. Such appointments shall be chosen from the following recommendations made through the 463 464 Commissioner:

465 1. Each of the seven beef cattle producing areas shall recommend two producers to the Virginia 466 Cattlemen's Association. The Virginia Cattlemen's Association shall recommend these 14 commercial beef cattle producers (two from each area), and at least one representative from each feeder cattle 467 468 production area of the Commonwealth shall be appointed to the Cattle Industry Board.

2. The Virginia Cattle Feeders Association shall recommend two commercial cattle feeders.

3. The Virginia State Dairymen's Association shall recommend four dairymen.

471 4. The Beef Cattle Improvement Association shall recommend four purebred beef cattle breeders, 472 provided that not more than one be nominated from each of the four predominant breeder associations.

473 5. The Virginia Association of Livestock Market Operators shall recommend four livestock market 474 operators.

475 6. The Virginia Cattlemen's Association shall recommend two persons, each of whom shall be either a processor or a packer. 476

477 The recommendations shall be submitted at least 90 days before the expiration of the member's term 478 for which the nomination is being provided. If said associations fail to provide the recommendations at 479 least 90 days before the expiration date pursuant to this section, the Governor may appoint other 480 nominees that meet the foregoing criteria. **481**

§ 3.2-1401. Corn Board; composition and appointment of members.

The Corn Board, established by the passage of a referendum held pursuant to Chapter 395 of the 482 483 1980 Acts of Assembly, is continued within the Department. The Corn Board shall be composed of 11 484 members appointed by the Governor and confirmed in accordance with § 2.2-107 from nominations by 485 producer organizations representing corn producers. These organizations shall nominate at least two producers from each production area of corn as defined in § 3.2-1410 and such nominations shall be 486 487 submitted at least 90 days before the expiration of the member's term for which the recommendations 488 are provided. If said organizations fail to provide the nominations at least 90 days before the expiration 489 of the term, the Governor may appoint other nominees that meet the criteria provided by this section. 490 The Governor shall appoint at least one producer from each production area and the membership of the

491 Corn Board shall be composed of a majority of producers. The Governor shall appoint one member, if 492 available, from each of the following classifications: seedsman, processor, country buyer, and exporter.

493 § 3.2-1501. Cotton Board; composition and appointment of members; quorum.

494 The Cotton Board, established by the passage of a referendum held pursuant to Chapter 873 of the 495 1997 Acts of Assembly, is continued within the Department. The Cotton Board shall be composed of 496 eight members appointed by the Governor, each of whom shall be a resident of Virginia and a producer 497 in Virginia. The Governor shall be guided in his appointments from nominations made by the following **498** agricultural organizations: (i) the Virginia Cotton Growers Association, Inc.; (ii) the Virginia Farm 499 Bureau Federation; and (iii) any other organization within the Commonwealth that is recognized by the 500 U.S. Department of Agriculture as a certified cotton grower organization representing Virginia producers 501 pursuant to guidelines authorized by the Cotton Research and Promotion Act (7 U.S.C. §§ 2101-2118). 502 Each such agricultural organization may nominate producers from each production area. The Governor 503 shall appoint a producer residing in each such production area. If no producer resides in a particular 504 production area, the Governor shall appoint a qualified producer from any other production area. Each 505 agricultural organization shall submit two or more nominations for each available position at least 90 506 days before the expiration of the member's term for which the nomination is being provided. If said 507 agricultural organizations fail to provide the nominations at least 90 days before the expiration date 508 pursuant to this section, the Governor may appoint other nominees that meet the foregoing criteria. 509 Five members of the Cotton Board shall constitute a quorum.

510 § 3.2-1601. Egg Board; composition and appointment of members.

511 The Egg Board is continued within the Department. The Egg Board shall be composed of seven 512 members appointed by the Governor and confirmed in accordance with § 2.2-107 from nominations 513 submitted to him by the Virginia Egg Council.

514 The Virginia Egg Council shall provide two or more nominations for each available position at least 515 30 days before the expiration of the member's term for which the nominations are being provided. If the 516 Virginia Egg Council fails to provide at least two nominations for each available position at least 30 517 days before the expiration date pursuant to this section, the Governor may appoint to such available 518 position another person who is involved in the commercial egg industry.

519 § 3.2-1700. Horse Industry Board; composition and appointment of members; quorum.

520 The Horse Industry Board, established by the passage of a referendum held pursuant to Chapters 790 521 and 805 of the 1993 Acts of Assembly, is continued within the Department. The Horse Industry Board 522 shall consist of 12 members representing the horse industry, industry support services, education, and 523 equine health. Four members shall be the presidents of the following industry organizations: the Virginia 524 Horse Council, Inc., the Virginia Thoroughbred Association, the Virginia Horse Shows Association, and 525 the Virginia Quarter Horse Association. Four members shall serve at large, to be appointed by the 526 Governor from nominations made by the remaining statewide horse breed or use organizations. The 527 Governor shall also appoint two members from recommendations submitted by the Virginia horse 528 industry: one shall be a representative of the horse industry support services or professional community 529 (feed manufacturing or sales, pharmaceutical sales, horseshoeing, marketing, veterinary services, etc.) 530 and the other shall be an individual commercially involved in the horse industry (manager, trainer, etc.). 531 Each organization shall submit two or more nominations or recommendations for each available 532 position at least 90 days before the expiration of the member's term for which the nomination or 533 recommendation is being provided. If the organizations fail to provide the nominations at least 90 days 534 before the expiration date pursuant to this section, the Governor may appoint other nominees that meet 535 the foregoing criteria.

536 The extension horse specialist from Virginia Polytechnic Institute and State University shall serve as 537 a voting member of the Horse Industry Board. The Commissioner shall serve as a nonvoting member. 538 Seven members shall constitute a quorum for the transaction of business.

539 The presidents of the Virginia Horse Council, Inc., the Virginia Thoroughbred Association, the 540 Virginia Horse Shows Association, and the Virginia Quarter Horse Association may each designate in 541 writing a member of his organization as an alternate who may attend meetings in his place and be 542 counted as a member of the Horse Industry Board for the purposes of a quorum and for voting. 543

§ 3.2-1801. Potato Board; composition and appointment of members.

544 The Potato Board, established by the passage of a 1994 referendum held pursuant to Chapter 126 of 545 the 1982 Acts of Assembly, is continued within the Department. The Potato Board shall be composed of 546 seven members appointed by the Governor from nominations by grower organizations, the appointments 547 to be subject to confirmation by the General Assembly. All members of the Potato Board shall be producers of potatoes. Each grower organization shall submit two or more nominations for each 548 549 available position at least 90 days before the expiration of the member's term for which the nomination is being provided. If said organizations fail to provide nominations at least 90 days before such 550 551 expiration, the Governor may appoint other nominees that meet the criteria provided by this section.

552 § 3.2-1901. Peanut Board; composition and appointment of members.

553 The Peanut Board is continued within the Department. The Peanut Board shall consist of nine 554 members representing as nearly as possible each peanut-producing section of the Commonwealth. Such 555 members shall be appointed by the Governor, subject to confirmation by the General Assembly, and 556 each of whom shall be a resident of the Commonwealth and engaged in producing peanuts in the 557 Commonwealth. The Governor shall be guided in his appointments by the recommendations of the 558 Virginia Peanut Growers Association or other peanut growers' organizations existing in peanut-producing counties. The Virginia Peanut Growers Association and any other peanut growers' organization 559 submitting nominations shall submit two or more nominations for each available position at least 90 560 days before the expiration of the member's term for which the nomination is being provided. If the 561 Virginia Peanut Growers Association or other peanut growers' organizations fail to provide the 562 nominations at least 90 days before the expiration date pursuant to this section, the Governor may 563 564 appoint other nominees that meet the foregoing criteria.

§ 3.2-2101. Sheep Industry Board; composition and appointment of members; quorum.

The Sheep Industry Board, established by the passage of a referendum held pursuant to Chapter 691 566 of the 1995 Acts of Assembly, is continued within the Department. 567

568 The Sheep Industry Board shall consist of 12 members representing the sheep industry and industry 569 support services. The Governor shall appoint 12 individuals from nominations submitted by the Virginia 570 Sheep Producers Association, Virginia sheep and wool marketing organizations, or other Virginia farm 571 organizations representing sheep producers. One member shall represent the packing/processing/retailing segment of the industry, one shall represent the Virginia Livestock Markets Association, and one shall 572 represent the purebred segment of the industry. The remaining nine members shall be appointed by the Governor as follows in accordance with § 3.2-2110, with no more than one member appointed per locality: three members who reside in the Southwest District; three members who reside in the Valley 573 574 575 576 District; two members who reside in the Northern District; and one member who resides in the South 577 Central District. In addition, the extension sheep specialist from Virginia Polytechnic Institute and State 578 University and the Commissioner shall serve as nonvoting members. Seven members of the Sheep 579 Industry Board shall constitute a quorum for the transaction of business.

580 Each association or organization shall submit two or more nominations for each available position 581 at least 90 days before the expiration of the member's term for which the nomination or 582 recommendation is being provided. If the organizations fail to provide the nominations at least 90 days 583 before the expiration date pursuant to this section, the Governor may appoint other nominees that meet 584 the foregoing criteria. 585

§ 3.2-2201. Small Grains Board; composition and appointment of members.

586 The Small Grains Board, established by the passage of a referendum held pursuant to Chapter 587 of 587 the 1991 Acts of Assembly, is continued within the Department. The Small Grains Board shall be 588 composed of 11 members appointed by the Governor from nominations by the Virginia Grain Producers 589 Association or other organizations representing small grain producers, the appointments to be subject to 590 confirmation by the General Assembly. The Virginia Grain Producers Association and any other 591 organization submitting nominations shall nominate at least two producers from each production area of 592 small grains. The Governor shall appoint at least one producer from each production area and the 593 membership of the Small Grains Board shall be composed of a majority of producers. The Governor 594 shall appoint one member, if available, from each of the following classifications: seedsman, processor, 595 country buyer, and exporter.

596 Nominations shall be submitted at least 90 days before the expiration of the member's term for which the nomination is being provided. If the Virginia Grain Producers Association or any other organization submitting nominations fail to provide the nominations at least 90 days before the 597 598 599 expiration date pursuant to this section, the Governor may appoint other nominees that meet the 600 foregoing criteria.

§ 3.2-2301. Soybean Board; composition and appointment of members.

602 The Soybean Board, established by the passage of a referendum held pursuant to Chapter 431 of the 603 1970 Acts of Assembly, is continued within the Department. The Soybean Board shall be composed of 604 11 members appointed by the Governor from nominations by the several producer organizations representing soybean producers, the appointments to be subject to confirmation by the General 605 606 Assembly. The several producer organizations representing soybean producers shall nominate at least two producers from each production area of soybeans. The Governor shall appoint at least one producer 607 608 from each production area as described in § 3.2-2310, and the membership of the Soybean Board shall always be composed of a majority of producers. The Governor shall appoint one member, if available, 609 610 from each of the following classifications: seedsman, producer, processor, country buyer, and exporter. 611 Such appointments shall be made from nominations from the several producer organizations representing 612 soybean producers.

613 Each organization shall submit nominations at least 90 days before the expiration of the member's

614 term for which the nomination or recommendation is being provided. If the organizations fail to provide 615 the nominations at least 90 days before the expiration date pursuant to this section, the Governor may 616 appoint other nominees that meet the foregoing criteria.

§ 3.2-2401. Bright Flue-Cured Tobacco Board; composition and appointment of members. 617

618 The Bright Flue-Cured Tobacco Board is continued within the Department. The Bright Flue-Cured 619 Tobacco Board shall consist of seven members with one member from each production area of 620 flue-cured tobacco. The Governor shall appoint members from nominations made by the Flue-Cured 621 Tobacco Committee of the Virginia Farm Bureau Federation and other tobacco grower organizations 622 existing in tobacco-producing counties. Each member shall be a citizen of the Commonwealth and engaged in producing tobacco in the Commonwealth. Each organization shall submit two or more 623 624 nominations for each available position at least 90 days before the expiration of the member's term for 625 which the nomination is being provided. If the organizations fail to provide the nominations at least 90 626 days before the expiration date pursuant to this section, the Governor may appoint other nominees that 627 meet the foregoing criteria.

§ 3.2-2501. Dark-Fired Tobacco Board: composition and appointment of members.

629 The Dark-Fired Tobacco Board is continued within the Department. The Dark-Fired Tobacco Board 630 shall consist of five members representing as nearly as possible each important type 21 dark-fired 631 tobacco-producing section in the Commonwealth. The Governor shall be guided in his appointments to 632 the Dark-Fired Tobacco Board by the recommendations of tobacco growers' organizations existing in 633 tobacco-producing counties. Each member shall be a citizen of the Commonwealth and engaged in 634 producing tobacco in the Commonwealth. Each organization shall submit two or more recommendations for each available position at least 90 days before the expiration of the member's term for which the 635 636 recommendation is being provided. If the organizations fail to provide the nominations at least 90 days 637 before the expiration date pursuant to this section, the Governor may appoint other nominees that meet 638 the foregoing criteria. 639

§ 3.2-3001. Wine Board; purpose; composition and appointment of members; quorum; meetings.

640 A. The Wine Board is established within the Department. The purpose of the Wine Board is to foster 641 the development of the Virginia wine industry by expanding viticulture and enological research, 642 increasing education, and promoting the production of grapes and wine in the Commonwealth.

643 B. The Wine Board shall consist of 10 members, nine of whom shall be voting nonlegislative citizen 644 members, to be appointed by the Governor, and the 10th tenth shall be the Commissioner, who shall 645 serve as a nonvoting ex officio member. Nonlegislative citizen members shall be citizens of the 646 Commonwealth and shall be either grape growers or owners or operators of a winery or farm winery in 647 the Commonwealth. The Governor shall make his appointments upon consideration of the 648 recommendations made by any grape grower, an owner or operator of a winery or farm winery, or the 649 following agricultural organizations or their successor organizations: the Virginia Wineries Association, 650 Inc.; the Virginia Vineyards Association, Inc.; the Virginia Farm Bureau; and the Virginia Agribusiness 651 Council. Each entity or person shall submit two or more recommendations for each available position at 652 least 90 days before the expiration of the member's term for which the recommendation is being 653 provided. If said entities or persons fail to provide the nominations at least 90 days before the 654 expiration date pursuant to this section, the Governor may appoint other nominees that meet the 655 foregoing criteria.

656 C. A majority of the members of the Wine Board shall constitute a quorum, but a two-thirds vote of 657 the members present shall be required for passage of items taken up by the Wine Board. The Wine 658 Board shall meet at least four times each year. The meetings of the Wine Board shall be held at the call 659 of the chairman or whenever the majority of the members so request. 660

§ 3.2-4022. Membership; terms; quorum; meetings.

The Certified Seed Board shall have a total membership of seven consisting of two nonlegislative 661 citizen members and five ex officio members. Nonlegislative citizen members shall be appointed as 662 follows: one member of the Virginia Seedsmen's Association and one member of the Virginia Crop 663 Improvement Association shall be appointed by the Governor subject to confirmation by the General 664 665 Assembly. Such appointments may be made from lists of three names nominated by each such 666 Association and submitted at least 90 days before the expiration of the member's term for which the 667 nominations are being provided. If said organizations fail to provide the nominations at least 90 days 668 before the expiration date pursuant to this section, the Governor may appoint other nominees that meet 669 the criteria provided by this section. The Commissioner, the Director of the Agricultural Experiment 670 Station at Blacksburg, the Director of the Virginia Cooperative Extension, the Head of the Crop and Soil Environmental Sciences Department of the Virginia Polytechnic Institute and State University, and the 671 672 Dean for the School of Agriculture at Virginia State University or their designees shall serve ex officio with voting privileges. Nonlegislative citizen members of the Certified Seed Board shall be citizens of 673 674 the Commonwealth.

675 Nonlegislative citizen members of the Certified Seed Board shall serve for terms of three years. Ex
676 officio members of the Certified Seed Board shall serve terms coincident with their terms of office.
677 Appointments to fill vacancies, other than by expiration of a term, shall be for the unexpired terms.
678 Vacancies shall be filled in the same manner as the original appointments. All members may be
679 reappointed.

680 The Certified Seed Board shall elect a chairman and vice-chairman from among its membership. A

683 The Board shall maintain an office in Blacksburg from which place its duties shall be performed.

684 § 9.1-108. Criminal Justice Services Board membership; terms; vacancies; members not disqualified
 685 from holding other offices; designation of chairmen; meetings; compensation.

A. The Criminal Justice Services Board is established as a policy board within the meaning of 686 687 § 2.2-2100, in the executive branch of state government. The Board shall consist of 29 members as follows: the Chief Justice of the Supreme Court of Virginia, or his designee; the Attorney General or his 688 689 designee; the Superintendent of the Department of State Police; the Director of the Department of 690 Corrections; the Director of the Department of Juvenile Justice; the Superintendent of the Department of 691 Correctional Education; the Chairman of the Parole Board; the Executive Director of the Virginia Indigent Defense Commission or his designee; and the Executive Secretary of the Supreme Court of **692** 693 Virginia. In those instances in which the Executive Secretary of the Supreme Court of Virginia, the 694 Superintendent of the Department of State Police, the Director of the Department of Corrections, the 695 Director of the Department of Juvenile Justice, the Superintendent of the Department of Correctional 696 Education, or the Chairman of the Parole Board will be absent from a Board meeting, he may appoint a 697 member of his staff to represent him at the meeting.

Sixteen members shall be appointed by the Governor from among citizens of the Commonwealth. At **698** 699 least one shall be a representative of a crime victims' organization or a victim of crime as defined in 700 subsection B of § 19.2-11.01. The remainder shall be representative of the broad categories of state and 701 local governments, criminal justice systems, and law-enforcement agencies, including but not limited to, 702 police officials, sheriffs, attorneys for the Commonwealth, defense counsel, the judiciary, correctional 703 and rehabilitative activities, and other locally elected and appointed administrative and legislative 704 officials. Among these members there shall be two sheriffs representing the Virginia Sheriffs' Sheriffs' 705 Association selected from among names submitted by the Association; one member who is an active 706 duty law-enforcement officer appointed after consideration of the names, if any, submitted by police or 707 fraternal associations that have memberships of at least 1,000; two representatives of the Virginia 708 Association of Chiefs of Police Association appointed after consideration of the names submitted by the 709 Association, if any; one attorney for the Commonwealth appointed after consideration of the names submitted by the Virginia Association for of Commonwealth's Attorneys, if any; one person who is a 710 711 mayor, city or town manager, or member of a city or town council representing the Virginia Municipal 712 League appointed after consideration of the names submitted by the League, if any; one person who is a 713 county executive, manager, or member of a county board of supervisors representing the Virginia 714 Association of Counties appointed after consideration of the names submitted by the Association, if any; 715 one member representing the Virginia Crime Prevention Association appointed after consideration of the names submitted by the Association, if any; one member of the Private Security Services Advisory 716 717 Board; and one representative of the Virginia Association of Regional Jail Superintendents Jails appointed after consideration of the names submitted by the Association, if any. 718

719 Four members of the Board shall be members of the General Assembly appointed as follows: one 720 member of the House Committee on Appropriations appointed by the Speaker of House of Delegates after consideration of the recommendation by the committee's chairman; one member of the House 721 722 Committee for Courts of Justice appointed by the Speaker of the House of Delegates after consideration 723 of the recommendation by the committee's chairman; one member of the Senate Committee on Finance 724 appointed by the Senate Committee on Rules after consideration of the recommendation of the chairman 725 of the Senate Committee on Finance; and one member of the Senate Committee for Courts of Justice 726 appointed by the Senate Committee on Rules after consideration of the recommendation of the chairman 727 of the Senate Committee for Courts of Justice. The legislative members shall serve for terms coincident 728 with their terms of office and shall serve as ex officio, nonvoting members. Legislative members may be 729 reappointed for successive terms.

B. The members of the Board appointed by the Governor shall serve for terms of four years,
provided that no member shall serve beyond the time when he holds the office or employment by
reason of which he was initially eligible for appointment. Gubernatorial appointed members of the Board
shall not be eligible to serve for more than two consecutive full terms. Three or more years within a
four-year period shall be deemed a full term. Any vacancy on the Board shall be filled in the same
manner as the original appointment, but for the unexpired term.

736 C. The Governor shall appoint a chairman of the Board, and the for a two-year term. No member

737 shall be eligible to serve more than two consecutive terms as chairman. The Board shall designate one 738 or more vice-chairmen from among its members, who shall serve at the pleasure of the Board.

739 D. Notwithstanding any provision of any statute, ordinance, local law, or charter provision to the 740 contrary, membership on the Board shall not disqualify any member from holding any other public 741 office or employment, or cause the forfeiture thereof.

742 E. The Board shall hold no less than four regular meetings a year. Subject to the requirements of this 743 subsection, the chairman shall fix the times and places of meetings, either on his own motion or upon 744 written request of any five members of the Board.

745 F. The Board may adopt bylaws for its operation.

746 G. Legislative members of the Board shall receive such compensation as provided in § 30-19.12 and 747 nonlegislative citizen members shall receive such compensation as provided in § 2.2-2813 for the 748 performance of their duties. All members shall be reimbursed for all reasonable and necessary expenses 749 incurred in the performance of their duties as provided in §§ 2.2-2813 and 2.2-2825. Funding for the 750 costs of compensation and expenses of the members shall be provided by the Department of Criminal 751 Justice Services. 752

§ 9.1-202. Virginia Fire Services Board; membership; terms; compensation.

753 A. The Virginia Fire Services Board (the Board) is established as a policy board within the meaning 754 of § 2.2-2100 in the executive branch of state government. The Board shall consist of 15 members to be 755 appointed by the Governor as follows: a representative of the insurance industry; two members of the 756 general public with no connection to the fire services, one of whom shall be a representative of those 757 industries affected by SARA Title III and OSHA training requirements; and one member each from the 758 Virginia Fire Chiefs Association, the Virginia State Firefighter's Firefighters Association, the 759 Virginia Association of Professional Firefighters Fire Fighters, the Virginia Fire Service Council, the 760 Virginia Fire Prevention Association, the State Virginia Chapter of the International Association of Arson Investigators, the Virginia Municipal League, and the Virginia Association of Counties, and a 761 member of the Virginia Chapter of the International Society of Fire Service Instructors who is a faculty 762 763 member who teaches fire science at a public institution of higher education. Of these appointees, at least 764 one shall be a volunteer firefighter. The State Fire Marshal, the State Forester and a member of the 765 Board of Housing and Community Development, appointed by the chairman of that Board shall also 766 serve as members of the Board.

767 Each of the organizations represented shall submit at least three names for each position for the 768 Governor's consideration in making these appointments.

769 B. Members of the Board appointed by the Governor shall serve for terms of four years. An 770 appointment to fill a vacancy shall be for the unexpired term. No appointee shall serve more than two 771 successive four-year terms but neither shall any person serve beyond the time he holds the office or 772 organizational membership by reason of which he was initially eligible for appointment.

773 C. The Board annually shall elect its chairman and vice-chairman from among its membership and 774 shall adopt rules of procedure.

775 D. Members of the Board shall receive such compensation for the performance of their duties as 776 provided in § 2.2-2813. All members shall be reimbursed for all reasonable and necessary expenses 777 incurred in the performance of their duties as provided in § 2.2-2825. Funding for the compensation and 778 costs of expenses of the members shall be provided from the Fire Programs Fund established pursuant to 779 § 38.2-401. 780

§ 10.1-1102. Board of Forestry.

781 The Board of Forestry within the Department of Forestry, referred to in this chapter as the Board, shall be composed of one member from each congressional district appointed by the Governor for a 782 783 term of four years. Upon notification to the Commonwealth by the United States Department of Justice 784 that there is no objection to Chapter 6 of the 1991 Acts of Assembly, Special Session II, the Governor 785 shall appoint a member to represent the new congressional district. Such member shall serve a term 786 coincident with the terms of the current members. Beginning July 1, 2011, the Governor's appointments 787 shall be staggered as follows: four members for a term of one year, three members for a term of two 788 years, and four members for a term of three years. Thereafter, appointments shall be for four-year 789 terms. The State Forester shall serve as executive officer of the Board.

790 No member of the Board, except the executive officer, shall be eligible for more than two successive 791 terms; however, persons subsequently appointed to fill vacancies may serve two additional successive 792 terms after the terms of the vacancies they were appointed to fill have expired. All vacancies in the 793 membership of the Board shall be filled by the Governor for the unexpired term.

794 The Board shall meet at least three times a year for the transaction of business. Special meetings 795 may be held at any time upon the call of the executive officer of the Board, or a majority of the 796 members of the Board.

797 Members of the Board shall be reimbursed for all reasonable and necessary expenses incurred as a **798** result of their membership on the Board.

799 § 10.1-1800. Establishment and administration of Foundation; appointment, terms, chairman, quorum, etc., of board of trustees.

801 The Virginia Outdoors Foundation is established to promote the preservation of open-space lands and 802 to encourage private gifts of money, securities, land or other property to preserve the natural, scenic, 803 historic, scientific, open-space and recreational areas of the Commonwealth. The Virginia Outdoors 804 Foundation is a body politic and shall be governed and administered by a board of trustees composed of 805 seven trustees from the Commonwealth at large to be appointed by the Governor for four-year terms. 806 Appointments shall be made to achieve a broad geographical representation of members. Vacancies shall 807 be filled for the unexpired term. No trustee-at-large shall be eligible to serve more than two consecutive 808 four-year terms. All trustees-at-large shall post bond in the penalty of \$5,000 with the State Comptroller 809 prior to entering upon the functions of office.

810 The Governor shall appoint a chairman of the board from among the seven trustees-at-large to a
811 two-year term. No member shall be eligible to serve more than two consecutive terms as chairman. A
812 majority of the members of the board serving at any one time shall constitute a quorum for the
813 transaction of business.

§ 10.1-2136. Foundation for Virginia's Natural Resources Board of Trustees; membership; terms;
expenses.

816 A. The Foundation shall be governed and administered by a Board of Trustees. The Board shall 817 consist of 13 citizen members from the Commonwealth to be appointed by the Governor, and the 818 Secretaries of Natural Resources and Agriculture and Forestry, or their designees, to serve ex officio 819 with voting privileges. Appointments shall be made so that each of the 13 major river basins, pursuant 820 to § 10.1-2137, is represented insuring there is adequate representation from the agriculture and forestry industries. Citizen members shall be appointed for four-year terms, except that initial appointments shall 821 822 be made for terms of one to four years in a manner whereby no more than four members shall have 823 terms that expire in the same year. The ex officio members shall serve a term coincident with their 824 terms of office. Appointments to fill vacancies, other than by expiration of a term, shall be made for the 825 unexpired terms. Vacancies shall be filled in the same manner as the original appointments. All 826 members may be reappointed. However, no citizen member shall serve more than two consecutive 827 four-year terms. The remainder of any term to which a member is appointed to fill a vacancy shall not 828 constitute a term in determining the member's eligibility for reappointment.

B. The Governor shall appoint a chairman of the Board of Trustees who shall serve a two-year term.
No member shall be eligible to serve more than two consecutive terms as chairman. The members shall elect a vice-chairman annually from among the members of the Board. A majority of the members of the Board serving at any one time shall constitute a quorum for the transaction of business. The Board shall meet at least four times a year and at the call of the chairman or whenever a majority of the members so request.

C. The Board shall seek assistance in developing grant criteria and advice on grant priorities and any
other appropriate issues from a task force consisting of the following agency heads or their designees:
the Director of the Department of Conservation and Recreation, the Commissioner of Agriculture and
Consumer Services, the State Forester, the Director of the Department of Historic Resources, the
Director of the Department of Game and Inland Fisheries, and the Director of the Department of
Environmental Quality, and the Director of the Virginia Museum of Natural History. The Board may
request any other agency head, agency employee, or environmental steward to serve on the task force.

D. The chairman of the Board shall submit to the Governor and the General Assembly a biennial
executive summary of the interim activity and work of the Board no later than the first day of each
even-numbered year regular session of the General Assembly. The executive summary shall be
submitted as provided in the procedures of the Division of Legislative Automated Systems for the
processing of legislative documents and reports and shall be posted on the General Assembly's website.

847 E. Members shall receive no compensation for their services, but shall be reimbursed out of the Fund
848 for all reasonable and necessary expenses incurred in the performance of their duties as provided in
849 §§ 2.2-2813 and 2.2-2825.

850 § 22.1-164. Board of Commissioners; membership; terms; compensation and expenses; chairman and vice-chairman; quorum; employees, agents, etc.

852 All powers, rights and duties conferred by this chapter or other provisions of law upon the Authority 853 shall be exercised by the Board of Commissioners of the Virginia Public School Authority. The Board 854 of Commissioners shall consist of the State Treasurer, the State Comptroller, the Superintendent of 855 Public Instruction or his designee, and five additional members to be appointed by the Governor, subject 856 to confirmation by the General Assembly, who shall serve at the pleasure of the Governor for terms of six years each. Appointments to fill vacancies other than by expiration of term shall be made for the 857 unexpired terms. The chairman and members of the Board of Commissioners shall receive such 858 859 compensation as provided for by law.

860 The Governor shall designate one member of the Board of Commissioners as chairman who shall serve a two-year term. No member shall be eligible to serve more than two consecutive terms as 861 862 chairman. The chairman shall be the chief executive officer of the Authority and shall receive such compensation as the Governor shall fix. The State Treasurer, the State Comptroller, the Superintendent 863 864 of Public Instruction and his designee shall be ineligible to serve as chairman. The chairman shall sign 865 and execute all vouchers for the disbursement of funds belonging to the Authority upon authorization by 866 the Board. Five members of the Board of Commissioners shall constitute a quorum for the transaction of 867 all business of the Authority. The Board of Commissioners shall elect one of its members as 868 vice-chairman, who shall exercise the powers of the chairman when so directed by the chairman.

869 The Board of Commissioners may employ or retain such employees, agents, financial advisers and 870 attorneys as it may deem necessary and fix their compensation.

871 § 22.1-337. Virginia representatives on Education Commission of the States; membership; terms; 872 compensation and expenses; chairman's executive summary.

In accordance with the Compact for Education of 1968, which established the Education Commission 873 874 of the States, there shall be seven commissioners representing Virginia on the Education Commission of 875 the States. The Virginia commissioners shall consist of one member of the House of Delegates, to be 876 appointed by the Speaker of the House of Delegates; one member of the Senate, to be appointed by the 877 Senate Committee on Rules; four nonlegislative citizen members, of whom one shall be the 878 Superintendent of Public Instruction, to be appointed by the Governor; and the Governor. The 879 commissioners representing Virginia shall by virtue of their training, experience, knowledge, or 880 affiliations, collectively reflect the broad interests of state government, the state's system of education, 881 public and higher education, nonprofessional and professional public and nonpublic educational 882 leadership.

883 Legislative members shall serve terms coincident with their terms of office. Nonlegislative citizen **884** members shall serve at the pleasure of the Governor. All members may be reappointed. Appointments to 885 fill vacancies, other than by expiration of a term, shall be made for the unexpired terms. Vacancies shall 886 be filled in the same manner as the original appointments.

887 The Governor shall designate one commissioner to serve as chairman of the Virginia commissioners 888 for a two-year term. The commissioners shall meet on the call of the chairman or at the request of a 889 majority of the members. A majority of the commissioners shall constitute a quorum. The commissioners may consider any and all matters related to recommendations of the Education 890 891 Commission of the States or the general activities and business of the organization and shall have the 892 authority to represent the Commonwealth in all actions of the Commission.

893 The commissioners shall serve without compensation. All members shall be reimbursed for all 894 reasonable and necessary expenses incurred in the performance of their duties as provided in §§ 2.2-2813 and 2.2-2825. The costs of expenses of the legislative commissioners incurred in the 895 896 performance of their duties shall be paid from appropriations to the Virginia Commission on 897 Intergovernmental Cooperation for the attendance of conferences. The costs of expenses of nonlegislative 898 citizen commissioners incurred in the performance of their duties shall be paid from such funds as may 899 be provided for this purpose in the appropriations act.

900 The chairman of the Commissioners shall submit to the Governor and the General Assembly an 901 annual executive summary of the interim activity and work of the Commissioners no later than the first 902 day of each regular session of the General Assembly. The executive summary shall be submitted as 903 provided in the procedures of the Division of Legislative Automated Systems for the processing of 904 legislative documents and reports and shall be posted on the General Assembly's website. 905

§ 22.1-346.2. Board of Visitors of the Virginia School for the Deaf and the Blind established.

906 A. There is hereby established the Board of Visitors of the Virginia School for the Deaf and the 907 Blind (Board), as a policy agency in the executive branch of state government under the name of the 908 "Virginia School for the Deaf and the Blind," for the purpose of governing the educational programs and 909 services to deaf, blind, and multi-disabled students enrolled at the Virginia School for the Deaf and the 910 Blind.

911 B. The Board shall have a total membership of 11 members that shall consist of four legislative 912 members, and seven nonlegislative citizen members. Members shall be appointed as follows: two 913 members of the House of Delegates, to be appointed by the Speaker of the House of Delegates in 914 accordance with the principles of proportional representation contained in the Rules of the House of Delegates; two members of the Senate, to be appointed by the Senate Committee on Rules; and seven 915 916 nonlegislative citizen members, of whom one shall be a parent representative from of a child who is 917 deaf or blind representing the Eastern region of the Commonwealth, one shall be a parent representative 918 from of a child who is deaf or blind representing the Western region of the Commonwealth, and one 919 shall be a representative of the Virginia School for the Deaf and the Blind Alumni Association, to be 920 appointed by the Governor, subject to confirmation by the General Assembly. 921 members of the Board shall be citizens of the Commonwealth. Legislative members of the Board shall 922 serve terms coincident with their terms of office. After the initial staggering of terms, nonlegislative 923 members appointed shall serve for four-year terms. All members may be reappointed. The meetings of the Board shall be held at the call of the chairman or whenever 935 the majority of the members so request.

936 C. Legislative members of the Board shall receive such compensation as provided in § 30-19.12, and 937 nonlegislative citizen members shall receive such compensation for the performance of their duties as 938 provided in § 2.2-2813. All members shall be reimbursed for all reasonable and necessary expenses 939 incurred in the performance of their duties as provided in §§ 2.2-2813 and 2.2-2825. Funding for the 940 costs of expenses of the members shall be provided from such funds as may be appropriated to the 941 Board of Visitors of the Virginia School for the Deaf and the Blind, in accordance with the 942 appropriations act.

943 D. The Superintendent of Public Instruction shall designate a member of the staff of the Department 944 of Education to serve as a consultant to the Board of Visitors of the Virginia School for the Deaf and 945 the Blind on matters pertaining to instruction, federal and state special education requirements, and 946 school accreditation, and to provide technical assistance to assist the Board in meeting specific 947 instructional and school accreditation needs. 948

E. The Board shall have the following powers and duties:

949 1. Establish such rules, policies, and regulations for the governance of the Virginia School for the 950 Deaf and the Blind.

951 2. Prescribe the criteria and procedures governing admissions to the school, and the review of student 952 placement, to ensure the appropriateness of the placement and instructional program of each student 953 admitted to the school, pursuant to § 22.1-348 and in accordance with federal and state special education 954 laws and regulations.

955 3. Establish a policy governing the transportation of students at the school to permit frequent home 956 visits by students, and to provide to each student transportation to and from the school and the place of 957 residence of such student's parent or guardian whenever the school is officially closed.

958 4. Prescribe and approve the education programs of the Virginia School for the Deaf and the Blind, in consultation with the Department of Education, the Virginia Department for the Deaf and 959 960 Hard-of-Hearing, and the Virginia Department for the Blind and Visually Impaired.

5. Appoint the superintendent, other officers, and the faculty of the school. The superintendent shall 961 be appointed every two years and the other officers and faculty annually. However, the superintendent, 962 963 with the approval of the chairman of the Board, shall be authorized to fill vacancies in positions 964 appointed by the Board occurring between meetings of the Board. The Board may remove at any time 965 the superintendent, other officers, faculty and employees for cause, subject to the provisions of Chapter 966 29 (§ 2.2-2900 et seq.) of Title 2.2.

967 6. Establish the qualifications, duties, and compensation of the superintendent, other officers, faculty, 968 and employees of the school.

969 7. Prepare and submit to the Governor and General Assembly, beginning July 1, 2010, an annual 970 report detailing the curricula and other educational programs and services of the school, including 971 receipts and disbursements pertaining to the operation of the school for each fiscal year ending on June 972 30. 973

§ 23-30.25. Creation and organization of Authority; surety bonds.

974 The Virginia College Building Authority is hereby created as a public body corporate and as a 975 political subdivision and an agency and instrumentality of the Commonwealth of Virginia, and as such, 976 shall have and is hereby vested with the powers, rights and duties hereinafter conferred in this chapter.

977 The Virginia College Building Authority shall consist of the State Treasurer, the State Comptroller, 978 the Director of Planning and Budget, the Director of the State Council of Higher Education for Virginia, 979 and seven additional members appointed by the Governor, subject to confirmation by the General 980 Assembly, if in session when such appointments are made, and if not in session, at its first session 981 subsequent to such appointment, who shall serve at the pleasure of the Governor. The initial members 982 shall be the members of the Authority heretofore appointed under the Virginia College Building

984 appointed and qualified. The successors of each of the appointed members shall be appointed for a term
985 of four years, except that appointments to fill vacancies shall be made for the unexpired terms. Such
986 members shall serve no more than two consecutive terms. The secretary and the assistant secretary may
987 receive such compensation as the Authority may provide.

988 The Governor shall appoint one member as chairman, who shall serve a two-year term. No member 989 shall be eligible to serve more than two consecutive terms as chairman. The chairman shall be the chief 990 executive officer of the Authority and who shall receive such compensation as the Governor shall fix. 991 Neither the State Treasurer, the State Comptroller, the Director of the State Council of Higher Education for Virginia nor the Director of Planning and Budget shall be eligible to serve as chairman. Six 992 993 members of the Authority shall constitute a quorum for the transaction of all business of the Authority. 994 The Authority shall elect one member from the group of seven members appointed by the Governor as 995 vice-chairman, who shall exercise the powers of the chairman in the absence of the chairman. The 996 Authority shall elect a treasurer, a secretary, and an assistant secretary, each of whom may perform the 997 duties and functions commonly performed by such officers. All such officers, except the secretary and **998** the assistant secretary, shall be selected from members of the Authority. Each member of the Authority 999 hereafter appointed and the secretary and the assistant secretary of the Authority shall execute a surety 1000 bond in such penal sum as shall be determined by the Attorney General, each such surety bond to be 1001 conditioned upon the faithful performance of the duties of his office, to be executed by a surety 1002 company authorized to transact business in the Commonwealth of Virginia as surety and to be approved 1003 by the Attorney General and filed in the office of the Secretary of the Commonwealth.

1004 § 23-253.1. Membership of board of trustees; quorum.

1005 The management and control of the Virginia Museum of Fine Arts, hereinafter in this chapter called 1006 the "Museum," together with the building, contents, furnishings, grounds and other properties thereof 1007 shall be vested in a board of trustees composed of the following persons: (i) ex officio members: the 1008 Governor, the Speaker of the House of Delegates and the mayor of the City of Richmond; and (ii) 1009 regular members: the trustees who are in office on June 27, 1958, and their successors from time to 1010 time, consisting of not less than 25 persons and not more than 35 persons. The term of office of all 1011 regular members who are in office on June 27, 1958, shall continue until June 30, 1963, and shall 1012 expire at that time. All successors from time to time, whether for a full term or for the remainder of an 1013 unexpired term, shall be appointed and commissioned by the Governor, upon the nomination of the 1014 trustees from the after consideration of a list of members of nominated trustees from the Museum 1015 submitted at least 60 days before the expiration of the member's term for which the nominations are 1016 *being made.* The trustees appointed to hold office beginning on July 1, 1963, shall be divided as nearly 1017 as may be, into five equal groups, their terms of office to expire, respectively, one, two, three, four and 1018 five years thereafter. All trustees subsequently appointed shall hold office for a term of five years unless 1019 appointed for the remainder of an unexpired term. No person shall be eligible to serve consecutively for 1020 more than two successive complete terms. Nine trustees shall constitute a quorum at any meeting and a 1021 majority vote of those present shall control in all matters.

1022 § 54.1-2950.1. Advisory Board on Physician Assistants; membership; qualifications.

1023 The Advisory Board on Physician Assistants shall consist of five members to be appointed by the 1024 Governor for four year terms, as follows: three members shall be licensed physician assistants who have 1025 practiced their professions in Virginia for not less than three years prior to their appointments; one shall 1026 be a physician who supervises at least one physician assistant; and one shall be a citizen member 1027 appointed from the Commonwealth at-large. Beginning July 1, 2011, the Governor's appointments shall 1028 be staggered as follows: two members for a term of one year, one member for a term of two years, and 1029 two members for a term of three years. Thereafter, appointments shall be for four-year terms. Vacancies 1030 occurring other than by expiration of term shall be filled for the unexpired term. No person shall be 1031 eligible to serve on the Advisory Board for more than two successive terms.

1032 § 54.1-2956. Advisory Board on Respiratory Care; appointment; terms; duties; etc.

A. The Advisory Board on Respiratory Care shall assist the Board in carrying out the provisions of
 this chapter regarding the qualifications, examination, and regulation of licensed respiratory care
 practitioners.

1036 The Advisory Board shall consist of five members appointed by the Governor for four-year terms. **1037** Three as follows: three members shall be at the time of appointment respiratory care practitioners who have practiced for not less than three years, one member shall be a physician licensed to practice medicine in the Commonwealth, and one member shall be appointed by the Governor from the Commonwealth at large. Beginning July 1, 2011, the Governor's appointments shall be staggered as follows: two members for a term of one year, one member for a term of two years, and two members **1042** for a term of three years. Thereafter, appointments shall be for four-year terms.

1043 Vacancies occurring other than by expiration of term shall be filled for the unexpired term. No

person shall be eligible to serve on the Advisory Board for more than two consecutive terms. 1044

1045 B. The Advisory Board shall, under the authority of the Board, recommend to the Board for its 1046 enactment into regulation the criteria for licensure as a respiratory care practitioner and the standards of 1047 professional conduct for holders of licenses.

1048 The Advisory Board shall also assist in such other matters dealing with respiratory care as the Board 1049 may in its discretion direct.

§ 54.1-2956.8. Advisory Board on Radiological Technology; appointments; terms; etc.

1051 The Advisory Board on Radiological Technology shall assist the Board in carrying out the provisions 1052 of this chapter regarding the qualifications, examination, registration and regulation of certified 1053 radiological technology practitioners.

The Advisory Board shall consist of five members to be appointed by the Governor for four-year 1054 1055 terms. Three as follows: three members shall be licensed radiological technology practitioners who have 1056 been practicing in the Commonwealth for not less than three years prior to their appointments- One, one 1057 member shall be a board-certified radiologist licensed in the Commonwealth, and one member shall be a 1058 citizen member appointed from the Commonwealth at large. Beginning July 1, 2011, the Governor's 1059 appointments shall be staggered as follows: two members for a term of one year, one member for a 1060 term of two years, and two members for a term of three years. Thereafter, appointments shall be for 1061 four-vear terms.

1062 Vacancies occurring other than by expiration of term shall be filled for the unexpired term. No 1063 person shall be eligible to serve on the Advisory Board for more than two consecutive terms.

1064 § 54.1-2956.11. Advisory Board on Acupuncture; composition; appointment.

1065 The Advisory Board on Acupuncture, hereinafter referred to as the "Advisory Board," shall assist the 1066 Board of Medicine in carrying out the provisions of this chapter regarding the qualifications, examination, licensure, and regulation of acupuncturists. Nothing in this chapter shall be construed to 1067 authorize the Advisory Board to advise the Board of Medicine in matters pertaining to the regulations of 1068 1069 doctors of medicine, osteopathy, chiropractic, or podiatry who are qualified by such regulations to 1070 practice acupuncture.

1071 The Advisory Board shall consist of five members to be appointed by the Governor for four-year 1072 terms. Three as follows: three members shall be licensed acupuncturists who have been practicing in 1073 Virginia for not less than three years- One; one member shall be a doctor of medicine, osteopathy, 1074 chiropractic or podiatry who is qualified to practice acupuncture in Virginia, and one member shall be a 1075 citizen member appointed from the Commonwealth at large. Beginning July 1, 2011, the Governor's 1076 appointments shall be staggered as follows: two members for a term of one year, two members for a 1077 term of two years, and one member for a term of three years. Thereafter, appointments shall be for 1078 *four-vear terms*. Any vacancy occurring during a member's term shall be filled for the unexpired balance 1079 of that term. No person shall be eligible to serve on the Advisory Board for more than two successive 1080 terms.

1081 § 54.1-2957.5. Advisory Board on Athletic Training established; duties; composition; appointment; 1082 terms.

1083 A. The Advisory Board on Athletic Training shall assist the Board in formulating its requirements 1084 for the licensure of athletic trainers. In the exercise of this responsibility, the Advisory Board shall 1085 recommend to the Board the criteria for licensure of athletic trainers and the standards of professional 1086 conduct for licensees. The Advisory Board shall also assist in such other matters relating to the practice 1087 of athletic training as the Board may require.

B. The Advisory Board shall consist of five members appointed by the Governor for four-year terms. 1088 1089 The first appointments shall provide for staggered terms with two members being appointed for a 1090 two-year term, two members being appointed for a three-year term and one member being appointed for a four-year term. Three members shall be at the time of appointment athletic trainers who are currently 1091 1092 licensed by the Board and who have practiced in Virginia for not less than three years, including one 1093 athletic trainer practicing employed at a secondary school, one practicing employed at an institution of 1094 higher education, and one practicing in a nonacademic environment. One employed in the private sector; 1095 one member shall be a physician licensed to practice medicine in the Commonwealth; and one member 1096 shall be a citizen appointed by the Governor from the Commonwealth at large.

1097 Vacancies occurring other than by expiration of term shall be filled for the unexpired term. No 1098 person shall be eligible to serve on the Advisory Board for more than two full consecutive terms. 1099

§ 63.2-1735. Child Day-Care Council created; members; terms; duties.

1100 The Child Day-Care Council is hereby continued. Its members shall be appointed by the Governor and serve without compensation. Notwithstanding the provisions of § 2.2-2813, reimbursement for travel 1101 expenses of members shall be limited to in-state travel. The members of the Council shall consist of one 1102 1103 nonprofit child day center operator; three private for-profit child day center operators; one representative from each of the Departments of Social Services, Health, Education, Fire Programs, and Housing and 1104 1105 Community Development; one pediatric health professional; one child development specialist; one parent 1106 consumer; one legal professional; one representative of the National Association for the Education of 1107 Young Children; one representative of the YMCA; one representative of the National Academy of Early 1108 Childhood Programs; one representative of the Association of Christian Schools International; one 1109 representative of the American Association of Christian Schools; one representative of the National Early Childhood Program Accreditation; one representative of the National Accreditation Council for Early 1110 1111 Childhood Professional Personnel and Programs; one representative of the International Academy for 1112 Private Education; one representative of the American Montessori Society; one representative of the 1113 International Accreditation and Certification of Childhood Educators, Programs, and Trainers; one 1114 representative of the National Accreditation Commission; one representative of the Virginia Council for 1115 Private Education; and one representative each of a child day center offering a seasonal program 1116 emphasizing outdoor activities, a private child day center offering a half-day nursery school program, 1117 and a local governing body all of which operate programs required to be licensed under this chapter. The membership of the Council shall also include such representatives of state agencies as advisory 1118 1119 members as the Governor deems necessary. The Governor shall designate a member of the Council to 1120 serve as chairman for a two-year term. No member shall be eligible to serve more than two consecutive 1121 terms as chairman.

1122 The members of the Council shall be appointed for four-year terms, except appointments to fill vacancies shall be for the unexpired term.

1124 The Council shall adopt regulations for licensure and operation of child day centers in the 1125 Commonwealth in accordance with the regulations referred to in § 63.2-1734.

1126 The Council shall adopt regulations in collaboration with the Virginia Recreation and Park Society1127 and the Department of Behavioral Health and Developmental Services for therapeutic recreation1128 programs.

1129 All staff and other support services required by the Council shall be provided by the Department.

1130 2. That the provisions of this act providing for (i) staggered terms for board, council, or 1131 commission members and (ii) two-year terms for chairmen appointed by the Governor shall not 1132 affect current members or chairmen whose terms have not expired as of July 1, 2011.
