## AMENDMENT IN THE NATURE OF A SUBSTITUTE

(Proposed by the Senate Committee on Transportation  
on February 3, 2011)

(Patron Prior to Substitute—Senator McWaters)

A *BILL to amend and reenact §§ 33.1-46.2, as it is currently effective and as it may become effective, 46.2-341.12, 46.2-341.20, 46.2-668, 46.2-711, 46.2-755, 46.2-2000, 46.2-2000.1, 46.2-2001.3, 46.2-2005, 46.2-2011.4, 46.2-2011.8, 46.2-2011.27, 46.2-2075, 46.2-2096, 46.2-2099.4, 46.2-2099.5, 46.2-2100, 46.2-2108.2, 46.2-2108.4, 46.2-2108.5, 46.2-2108.6, 46.2-2109, 46.2-2115, 46.2-2116, 46.2-2118, 46.2-2119, 46.2-2120, 46.2-2122, 46.2-2123, 46.2-2124, 46.2-2132, 46.2-2133, 46.2-2135, 46.2-2136, 46.2-2137, 46.2-2143, 46.2-2144, 46.2-2146, 46.2-2147, 46.2-2150, 46.2-2151, 46.2-2155, 46.2-2156, 58.1-2259, 58.1-2402, 58.1-2426, and 58.1-2701, as it is currently effective and as it may become effective, of the Code of Virginia; to amend the Code of Virginia by adding a section numbered 46.2-208.2 and by adding in Chapter 20 of Title 46.2 an article numbered 14, consisting of a section numbered 46.2-2099.44; and to repeal §§ 46.2-696, 46.2-2084, 46.2-2097, 46.2-2097.1, and 46.2-2099.6 of the Code of Virginia, relating to regulation of passenger carriers by the Department of Motor Vehicles.*

**Be it enacted by the General Assembly of Virginia:**

That §§ 33.1-46.2, as it is currently effective and as it may become effective, 46.2-341.12, 46.2-341.20, 46.2-668, 46.2-711, 46.2-755, 46.2-2000, 46.2-2000.1, 46.2-2001.3, 46.2-2005, 46.2-2011.4, 46.2-2011.8, 46.2-2011.27, 46.2-2075, 46.2-2096, 46.2-2099.4, 46.2-2099.5, 46.2-2100, 46.2-2108.2, 46.2-2108.4, 46.2-2108.5, 46.2-2108.6, 46.2-2109, 46.2-2115, 46.2-2116, 46.2-2118, 46.2-2119, 46.2-2120, 46.2-2122, 46.2-2123, 46.2-2124, 46.2-2132, 46.2-2133, 46.2-2135, 46.2-2136, 46.2-2137, 46.2-2143, 46.2-2144, 46.2-2146, 46.2-2147, 46.2-2150, 46.2-2151, 46.2-2155, 46.2-2156, 58.1-2259, 58.1-2402, 58.1-2426, and 58.1-2701, as it is currently effective and as it may become effective, of the Code of Virginia are amended and reenacted and that the Code of Virginia is amended by adding a section numbered 46.2-208.2 and by adding in Chapter 20 of Title 46.2 an article numbered 14, consisting of a section numbered 46.2-2099.44, as follows:

§ 33.1-46.2. (For expiration date - see Editor's note) Designation of high-occupancy vehicle lanes; use of such lanes; penalties.

A. In order to facilitate the rapid and orderly movement of traffic to and from urban areas during peak traffic periods, the Commonwealth Transportation Board may designate one or more lanes of any highway in the interstate, primary, or secondary highway systems as high-occupancy vehicle lanes, hereinafter referred to in this section as HOV lanes. When lanes have been so designated and have been appropriately marked with such signs or other markers as the Board may prescribe, they shall be reserved during periods designated by the Board for the exclusive use of buses and high-occupancy vehicles. Any local governing body may also, with respect to highways under its exclusive jurisdiction, designate HOV lanes and impose and enforce restrictions on the use of such HOV lanes. Any highway for which the local jurisdiction receives highway maintenance funds pursuant to § 33.1-41.1 shall be deemed to be within the exclusive jurisdiction of the local governing body for the purposes of this section. HOV lanes shall be reserved for high-occupancy vehicles of a specified number of occupants as determined by the Board or, for HOV lanes designated by a local governing body, by that local governing body. Notwithstanding the foregoing provisions of this section, no designation of any lane or lanes of any highway as HOV lanes shall apply to the use of any such lanes by:

1. Emergency vehicles such as fire-fighting vehicles, ambulances, and rescue squad vehicles,
2. Law-enforcement vehicles,
3. Motorcycles,
4. a. Transit and commuter buses designed to transport 16 or more passengers, including the driver,  
b. ~~Commuter buses and motor coaches operating under irregular route passenger certificates issued under § 46.2-2010 and any~~ Any vehicle operating under a certificate of Public Convenience and Necessity or as a common carrier of passengers issued under § 46.2-2075 or, 46.2-2080, 46.2-2096, 46.2-2099.4, or 46.2-2099.44,
5. Vehicles of public utility companies operating in response to an emergency call,
6. Until July 1, 2011, vehicles bearing clean special fuel vehicle license plates issued pursuant to § 46.2-749.3,
7. Taxicabs having two or more occupants, including the driver, or
8. (For contingent effective date, see Editor's note.) Any active duty military member in uniform who is utilizing Interstate Route 264 and Interstate Route 64 for the purposes of traveling to or from a military facility in the Hampton Roads Planning District.

60 In the Hampton Roads Planning District, HOV restrictions may be temporarily lifted and HOV lanes  
61 opened to use by all vehicles when restricting use of HOV lanes becomes impossible or undesirable and  
62 the temporary lifting of HOV limitations is indicated by signs along or above the affected portion of  
63 highway.

64 The Commissioner of VDOT shall implement a program of the HOV facilities in the Hampton Roads  
65 Planning District beginning not later than May 1, 2000. This program shall include the temporary lifting  
66 of HOV restrictions and the opening of HOV lanes to all traffic when an incident resulting from  
67 nonrecurring causes within the general lanes occurs such that a lane of traffic is blocked or is expected  
68 to be blocked for 10 minutes or longer. The HOV restrictions for the facility will be reinstated when the  
69 general lane is no longer blocked and is available for use.

70 The Commissioner shall maintain necessary records to evaluate the effects of such openings on the  
71 operation of the general lanes and the HOV lanes. He shall report on the effects of this program. This  
72 program will terminate if the Federal Highway Administration requires repayment of any federal  
73 highway construction funds because of the program's impact on the HOV facilities in Hampton Roads.

74 B. In designating any lane or lanes of any highway as HOV lanes, the Board, or local governing  
75 body as the case may be, shall specify the hour or hours of each day of the week during which the

77 lanes the Board or local governing body deems appropriate. Any person driving a motor vehicle in a  
78 designated HOV lane in violation of this section shall be guilty of a traffic infraction which shall not be  
79 a moving violation and on conviction shall be fined \$100. However, violations committed within the  
80 boundaries of Planning District Eight shall be punishable as follows:

81 For a first offense, by a fine of \$125;

82 For a second offense within a period of five years from a first offense, by a fine of \$250;

83 For a third offense within a period of five years from a first offense, by a fine of \$500; and

84 For a fourth or subsequent offense within a period of five years from a first offense, by a fine of  
85 \$1,000.

86 Upon a conviction under this section, the court shall furnish to the Commissioner of the Department  
87 of Motor Vehicles in accordance with § 46.2-383 an abstract of the record of such conviction which  
88 shall become a part of the person's driving record. Notwithstanding the provisions of § 46.2-492, no  
89 driver demerit points shall be assessed for any violation of this section; except that persons convicted of  
90 second, third, fourth, or subsequent violations within five years of a first offense committed in Planning  
91 District Eight shall be assessed three demerit points for each such violation.

92 C. In the prosecution of an offense, committed in the presence of a law-enforcement officer, of  
93 failure to obey a road sign restricting a highway, or portion thereof, to the use of high-occupancy  
94 vehicles, proof that the vehicle described in the HOV violation summons was operated in violation of  
95 this section, together with proof that the defendant was at the time of such violation the registered  
96 owner of the vehicle, shall constitute in evidence a rebuttable presumption that such registered owner of  
97 the vehicle was the person who committed the violation. Such presumption shall be rebutted if the  
98 registered owner of the vehicle testifies in open court under oath that he was not the operator of the  
99 vehicle at the time of the violation. A summons for a violation of this section may be executed in  
100 accordance with § 19.2-76.2. Such rebuttable presumption shall not arise when the registered owner of  
101 the vehicle is a rental or leasing company.

102 D. Notwithstanding the provisions of § 19.2-76, whenever a summons for a violation of this section  
103 is served in any county, city, or town, it may be executed by mailing by first-class mail a copy thereof  
104 to the address of the owner of the vehicle as shown on the records of the Department of Motor  
105 Vehicles. If the summoned person fails to appear on the date of return set out in the summons mailed  
106 pursuant to this section, the summons shall be executed in the manner set out in § 19.2-76.3.

107 No proceedings for contempt or arrest of a person summoned by mailing shall be instituted for his  
108 failure to appear on the return date of the summons.

109 E. Notwithstanding § 33.1-252, high-occupancy vehicles having three or more occupants (HOV-3)  
110 may be permitted to use the Omer L. Hirst-Adelard L. Brault Expressway (Dulles Toll Road) without  
111 paying a toll.

112 F. Notwithstanding the contrary provisions of this section, the following conditions shall be met  
113 before the HOV-2 designation of Interstate Route 66 outside the Capital Beltway can be changed to  
114 HOV-3 or any more restrictive designation:

115 1. The Department shall publish a notice of its intent to change the existing designation and also  
116 immediately provide similar notice of its intent to all members of the General Assembly representing  
117 districts that touch or are directly impacted by traffic on Interstate Route 66.

118 2. The Department shall hold public hearings in the corridor to receive comments from the public.

119 3. The Department shall make a finding of the need for a change in such designation, based on  
120 public hearings and its internal data and present this finding to the Commonwealth Transportation Board  
121 for approval.

122 4. The Commonwealth Transportation Board shall make written findings and a decision based upon  
123 the following criteria:

124 a. Is changing the HOV-2 designation to HOV-3 in the public interest?

125 b. Is there quantitative and qualitative evidence that supports the argument that HOV-3 will facilitate

231 § 46.2-208.2. *Delinquent accounts; publication thereof.*

232 *Upon the failure of any owner, operator, or other person to timely deliver to the Department either*  
233 *payment in full of uncontested civil penalties, liquidated damages, weighing fees, processing fees,*  
234 *delinquent taxes, debts, and levies such as the Department may be authorized to collect, the Department*  
235 *at the direction of the Commissioner shall be permitted to publish on a website available to the public*  
236 *the name of such owner, operator, or the person, along with the county or city of his residence or*  
237 *incorporation, and the amount owed and the type of assessment.*

238 *The Department shall remove such name, county or city of residence or incorporation, amount owed,*  
239 *and type of assessment from such website immediately upon receipt of payment in full of the amount*  
240 *owed.*

241 § 46.2-341.12. Application for commercial driver's license.

242 A. Every application to the Department for a commercial driver's license shall be made upon a form  
243 approved and furnished by the Department, and the applicant shall write his usual signature in ink in the  
244 space provided. The applicant shall provide the following information:

- 245 1. Full legal name;
- 246 2. Current mailing and residential addresses;
- 247 3. Physical description including sex, height, weight and eye and hair color;
- 248 4. Year, month and date of birth;
- 249 5. Social Security number; and
- 250 6. Any other information required on the application form.
- 251 B. Every applicant for a commercial driver's license shall also submit to the Department the
- 252 following:
- 253 1. A consent to release driving record information;
- 254 2. Certifications that:
- 255 a. He either meets the federal qualification requirements of 49 C.F.R. Part 391, or he is exempt from
- 256 or is not subject to such federal requirements;
- 257 b. He either meets the state qualification requirements established pursuant to § 52-8.4, or he is
- 258 exempt from or is not subject to such requirements;
- 259 c. The motor vehicle in which the applicant takes the skills test is representative of the class and, if
- 260 applicable, the type of motor vehicle for which the applicant seeks to be licensed;
- 261 d. He is not subject to any disqualification, suspension, revocation or cancellation of his driving
- 262 privileges;
- 263 e. He does not have more than one driver's license;
- 264 3. Other certifications required by the Department;
- 265 4. Any evidence required by the Department to establish proof of identity, legal presence, residency,
- 266 and social security number; and
- 267 5. A statement indicating whether (i) the applicant has previously been licensed to drive any type of
- 268 motor vehicle during the previous 10 years and, if so, all states that licensed the applicant and the dates
- 269 he was licensed, and (ii) whether or not he has ever been disqualified, or his license suspended, revoked
- 270 or cancelled and, if so, the date of and reason therefor.
- 271 C. Every application for a commercial driver's license shall include a photograph of the applicant
- 272 supplied under arrangements made therefor by the Department in accordance with § 46.2-323.
- 273 D. The Department shall disqualify any commercial driver for a period of one year when the records
- 274 of the Department clearly show to the satisfaction of the Commissioner that such person has made a
- 275 material false statement on any application or certification made for a commercial driver's license. The
- 276 Department shall take such action within 30 days after discovering such falsification.
- 277 E. The Department shall review the driving record of any person who applies for a Virginia
- 278 commercial driver's license, for the renewal or reinstatement of such license or for an additional
- 279 commercial classification or endorsement, including the driving record from all jurisdictions where,
- 280 during the previous 10 years, the applicant was licensed to drive any type of motor vehicle. If
- 281 appropriate, the Department shall incorporate information from such other jurisdictions' records into the
- 282 applicant's Virginia driving record, and shall make a notation on the applicant's driving record
- 283 confirming that such review has been completed and the date it was completed. The Department's
- 284 review shall include research through the Commercial Driver License Information System established
- 285 pursuant to the Commercial Motor Vehicle Safety Act and the National Driver Register in addition to
- 286 the driver record maintained by the applicant's previous jurisdictions of licensure. This research shall be
- 287 completed prior to the issuance, renewal, or reinstatement of a commercial driver's license or additional
- 288 commercial classification or endorsement.
- 289 *F. On and after January 30, 2012, every new applicant for a commercial driver's license, including*
- 290 *any person applying for a commercial driver's license after revocation of his driving privileges, who*
- 291 *certifies that he will operate a commercial motor vehicle in non-excepted interstate or intrastate*
- 292 *commerce shall provide the Department with an original or certified copy of a medical examiner's*
- 293 *certificate prepared by a medical examiner as defined in 49 C.F.R. Part 390.5. Any new applicant for a*
- 294 *commercial driver's license who fails to comply with the requirements of this subsection shall be denied*
- 295 *the issuance of a commercial driver's license by the Department.*
- 296 *G. On and after January 30, 2012, but no later than January 30, 2014, every existing holder of a*
- 297 *commercial driver's license who certifies that he will operate a commercial motor vehicle in*
- 298 *non-excepted interstate or intrastate commerce shall provide the Department with an original or*
- 299 *certified copy of a medical examiner's certificate prepared by a medical examiner as defined in 49*
- 300 *C.F.R. Part 390.5. If an existing holder of a commercial driver's license fails to provide the Department*
- 301 *with a medical certificate as required by this subsection, the Department shall post a certification status*
- 302 *of "noncertified" on the record of the driver on the Commercial Driver's License Information System*
- 303 *and initiate a downgrade of his commercial driver's license as defined in 49 C.F.R. Part 383.5.*
- 304 *H. Any person who provides a medical certificate to the Department pursuant to the requirements of*
- 305 *subsections F and G shall keep the medical certificate information current and shall notify the*

306 Department of any change in the status of the medical certificate. If the Department determines that the  
307 medical certificate is no longer valid, the Department shall initiate a downgrade of the driver's  
308 commercial driver's license as defined in 49 C.F.R. Part 383.5.

309 I. If the Department receives notice that the holder of a commercial driver's license has been issued  
310 a medical variance as defined in 49 C.F.R. Part 390.5, the Department shall indicate the existence of  
311 such medical variance on the commercial driver's license document of the driver and on the record of  
312 the driver on the Commercial Driver's License Information System using the restriction code "V."

313 J. Any holder of a commercial driver's license who has been issued a medical variance shall keep  
314 the medical variance information current and shall notify the Department of any change in the status of  
315 the medical variance. If the Department determines that the medical variance is no longer valid, the  
316 Department shall initiate a downgrade of the driver's commercial driver's license as defined in 49  
317 C.F.R. Part 383.5.

318 § 46.2-341.20. Disqualification for multiple serious traffic violations.

319 A. For the purposes of this section, the following offenses, if committed in a commercial motor  
320 vehicle, are serious traffic violations:

321 1. Driving at a speed 15 or more miles per hour in excess of the posted speed limits;

322 2. Reckless driving;

323 3. A violation of a state law or local ordinance relating to motor vehicle traffic control arising in  
324 connection with a fatal traffic accident;

325 4. Improper or erratic traffic lane change;

326 5. Following the vehicle ahead too closely;

327 6. Driving a commercial motor vehicle without obtaining a commercial driver's license;

328 7. Driving a commercial motor vehicle without a commercial driver's license in the driver's  
329 immediate possession; and

330 8. Driving a commercial motor vehicle without the proper class of commercial driver's license and/or  
331 endorsements for the specific vehicle group being operated or for the passengers or type of cargo being  
332 transported; and

333 9. A violation of § 46.2-1078.1 or a substantially similar law of any other jurisdiction.

334 For the purposes of this section, parking, vehicle weight, and vehicle defect violations shall not be  
335 considered traffic violations.

336 B. Beginning September 30, 2005, the following offenses shall be treated as serious traffic violations  
337 if committed while operating a noncommercial motor vehicle, but only if (i) the person convicted of the  
338 offense was, at the time of the offense, the holder of a commercial driver's license; (ii) the offense was  
339 committed on or after September 30, 2005; and (iii) the conviction, by itself or in conjunction with  
340 other convictions that satisfy the requirements of this section, resulted in the revocation, cancellation, or  
341 suspension of such person's driver's license or privilege to drive.

342 1. Driving at a speed 15 or more miles per hour in excess of the posted speed limits;

343 2. Reckless driving;

344 3. A violation of a state law or local ordinance relating to motor vehicle traffic control arising in  
345 connection with a fatal traffic accident;

346 4. Improper or erratic traffic lane change; or

347 5. Following the vehicle ahead too closely.

348 C. The Department shall disqualify for the following periods of time, any person whose record as  
349 maintained by the Department shows that he has committed, within any three-year period, the requisite  
350 number of serious traffic violations:

351 1. A 60-day disqualification period for any person convicted of two serious traffic violations; or

352 2. A 120-day disqualification period for any person convicted of three serious traffic violations.

353 D. Any disqualification period imposed pursuant to this section shall run consecutively, and not  
354 concurrently, with any other disqualification period imposed hereunder.

355 § 46.2-668. Vehicles validly registered in other states and used in conjunction with harvesting  
356 operations.

357 A. No person shall be required to obtain the registration certificate, license plates and decals, or pay  
358 a registration fee for any motor vehicle, trailer, or semitrailer which is validly registered in another state  
359 and bears valid license plates issued by that state when the use of the vehicle has been contracted for by  
360 the owner or lessee of a farm as an incidental part of the harvesting of a crop from his farm. This  
361 exemption shall only be valid while the vehicle is engaged *principally* in transporting farm produce from  
362 the farm:

363 1. As an incidental part of harvesting operations;

364 2. Along a public highway for a distance of not more than 20 miles to a storage house, packing  
365 plant, market, or transportation terminal;

366 3. When the use is a seasonal operation; and

367 4. When the owner of the vehicle has secured from the Commissioner an exemption permit for each

368 vehicle.

369 B. The Commissioner, upon receipt of certification by the Superintendent of State Police an  
370 application certifying that a vehicle is entitled to the exemption set forth in this subsection and, if the  
371 vehicle is a qualified highway vehicle under § 58.1-2700, payment of \$100 \$150, shall issue an  
372 exemption permit on a form prescribed by him. The exemption permit shall be carried at all times by  
373 the operator of the vehicle for which it is issued or displayed in a conspicuous place on the vehicle. The  
374 exemption permit shall be valid for a period of 90 days from date of issue and shall be renewable by  
375 the procedure set forth in the foregoing provisions of this section.

376 § 46.2-711. Furnishing number and design of plates; displaying on vehicles required.

377 A. The Department shall furnish one license plate for every registered motorcycle, tractor truck,  
378 semitrailer, or trailer, and two license plates for every other registered motor vehicle, except to licensed  
379 motor vehicle dealers and persons delivering unladen vehicles who shall be furnished one license plate.  
380 The license plates for trailers, semitrailers, commercial vehicles, and trucks, other than license plates for  
381 dealers, may be of such design as to prevent removal without mutilating some part of the indicia  
382 forming a part of the license plate, when secured to the bracket.

383 B. The Department shall issue appropriately designated license plates for:

- 384 1. Passenger-carrying vehicles for rent or hire for the transportation of passengers for private trips;
- 385 2. Taxicabs;
- 386 3. Passenger-carrying vehicles operated by common carriers or restricted common carriers;
- 387 4. Property-carrying motor vehicles to applicants who operate as private carriers only;
- 388 5. Applicants who operate motor vehicles as carriers for rent or hire; and
- 389 6. Vehicles operated by nonemergency medical transportation carriers as defined in § 46.2-2000; and
- 390 7. Trailers and semitrailers.

391 C. The Department shall issue appropriately designated license plates for motor vehicles held for  
392 rental as defined in § 58.1-2401.

393 D. No vehicles shall be operated on the highways in the Commonwealth without displaying the  
394 license plates required by this chapter. The provisions of this subsection shall not apply to vehicles used  
395 to collect and deliver the United States mail to the extent that their rear license plates may be covered  
396 by the "CAUTION, FREQUENT STOPS, U.S. MAIL" sign when the vehicle is engaged in the  
397 collection and delivery of the United States mail.

398 E. Pickup or panel trucks are exempt from the provisions of subsection B with reference to  
399 displaying for-hire license plates when operated as a carrier for rent or hire. However, this exemption  
400 shall not apply to pickup or panel trucks subject to regulation under Chapter 21 (§ 46.2-2100 et seq.) of  
401 this title.

402 § 46.2-755. Limitations on imposition of motor vehicle license taxes and fees.

403 A. No county, city, or town shall impose any motor vehicle license tax or fee on any motor vehicle,  
404 trailer, or semitrailer when:

- 405 1. A similar tax or fee is imposed by the county, city, or town wherein the vehicle is normally  
406 garaged, stored or parked;
- 407 2. The vehicle is owned by a nonresident of such locality and is used exclusively for pleasure or  
408 personal transportation and not for hire or for the conduct of any business or occupation other than that  
409 set forth in subdivision 3 of this subsection;
- 410 3. The vehicle is (i) owned by a nonresident and (ii) used for transporting into and within the  
411 locality, for sale in person or by his employees, wood, meats, poultry, fruits, flowers, vegetables, milk,  
412 butter, cream, or eggs produced or grown by him, and not purchased by him for sale;

413 4. The motor vehicle, trailer, or semitrailer is owned by an officer or employee of the  
414 Commonwealth who is a nonresident of such county, city, or town and who uses the vehicle in the  
415 performance of his duties for the Commonwealth under an agreement for such use;

416 5. The motor vehicle, trailer, or semitrailer is kept by a dealer or manufacturer for sale or for sales  
417 demonstration;

418 6. The motor vehicle, trailer, or semitrailer is operated by a common carrier of persons or property  
419 operating between cities and towns in the Commonwealth and not in intracity transportation or between  
420 cities and towns on the one hand and points and places outside cities and towns on the other and not in  
421 intracity transportation; or

422 7. The motor vehicle, trailer, or semitrailer is inoperable and unlicensed pursuant to § 46.2-734.

423 B. No county, city, or town shall impose a license fee for any one motor vehicle owned and used  
424 personally by any veteran who holds a current state motor vehicle registration card establishing that he  
425 has received a disabled veteran's exemption from the Department and has been issued a disabled  
426 veteran's motor vehicle license plate as prescribed in § 46.2-739.

427 C. No county, city, or town shall impose any license tax or license fee or the requirement of a  
428 license tag, sticker or decal upon any daily rental vehicle, as defined in § 58.1-2401, the rental of which

429 is subject to the tax imposed by § 58.1-2402 A 4.

430 D. In the rental agreement between a motor vehicle renting company and a renter, the motor vehicle  
431 renting company may separately itemize and charge daily fees or transaction fees to the renter, provided  
432 that the amounts of such fees are disclosed at the time of reservation and rental as part of any estimated  
433 pricing provided to the renter. Such fees include a vehicle license fee to recover the company's incurred  
434 costs in licensing, titling, and registering its rental fleet, concession recovery fees actually charged the  
435 company by an airport, or other governmentally owned or operated facility, and consolidated facility  
436 charges actually charged by an airport, or other governmentally owned or operated facility for  
437 improvements to or construction of facilities at such facility where the motor vehicle rental company  
438 operates. The vehicle license fee shall represent the company's good faith estimate of the average per  
439 day per vehicle portion of the company's total annual vehicle licensing, titling, and registration costs.

440 No motor vehicle renting company charging a vehicle license fee, concession recovery fee, or  
441 consolidated facility charge may make an advertisement in the Commonwealth that includes a statement  
442 of the rental rate for a vehicle available for rent in the Commonwealth unless such advertisement  
443 includes a statement that the customer will be required to pay a vehicle license fee, concession recovery  
444 fee, or consolidated facility charge. The vehicle license fee, concession recovery fee, or consolidated  
445 facility charge shall be shown as a separately itemized charge on the rental agreement. The vehicle  
446 license fee shall be described in either the terms and conditions of the rental agreement as the "estimated  
447 average per day per vehicle portion of the company's total annual vehicle licensing, titling, and  
448 registration costs" or, for renters participating in an extended rental program pursuant to a master rental  
449 agreement, by posting such statement on the rental company website

450 Any amounts collected by the motor vehicle renting company in excess of the actual amount of its  
451 costs incurred relating to its vehicle license fees shall be retained by the motor vehicle renting company  
452 and applied toward the recovery of its next calendar year's costs relating to such fees. In such event, the  
453 good faith estimate of any vehicle license fee to be charged by the company for the next calendar year  
454 shall be reduced to take into account the excess amount collected from the prior year.

455 E. As used in this section, common carrier of persons or property includes any person who  
456 undertakes, whether directly or by lease or any other arrangement, to transport passengers or household  
457 goods for the general public by motor vehicle for compensation over the highways of the  
458 Commonwealth, whether over regular or irregular routes, that has obtained the required certificate of  
459 public convenience and necessity from the Department of Motor Vehicles pursuant to § 46.2-2075 or  
460 46.2-2150.

461 § 46.2-2000. Definitions.

462 Whenever used in this chapter unless expressly stated otherwise:

463 "Authorized insurer" means, in the case of an interstate motor carrier whose operations may or may  
464 not include intrastate activity, an insurer authorized to transact business in any one state, or, in the case  
465 of a solely intrastate motor carrier, an insurer authorized to transact business in the Commonwealth.

466 "Broker" means any person not included in the term "motor carrier" and not a bona fide employee or  
467 agent of any such carrier, who, as principal or agent, sells or offers for sale any transportation subject to  
468 this chapter, or negotiates for, or holds himself out by solicitation, advertisement, or otherwise as one  
469 who sells, provides, furnishes, contracts, or arranges for such transportation.

470 "Carrier by motor launch" means a common carrier or contract carrier, which carrier uses one or  
471 more motor launches operating on the waters within the Commonwealth to transport passengers.

472 "Certificate" means a certificate of public convenience and necessity or a certificate of fitness.

473 "Certificate of fitness" means a certificate issued by the Department to a contract bus carrier, a  
474 contract passenger carrier, a sight-seeing carrier, or a nonemergency medical transportation carrier.

475 "Certificate of public convenience and necessity" means a certificate issued by the Department of  
476 Motor Vehicles to certain common carriers, ~~certain restricted common carriers, contract passenger~~  
477 ~~carriers and sight-seeing carriers under this chapter authorizing the transportation of passengers over the~~  
478 ~~public highways or waterways of the Commonwealth;~~ but nothing contained in this chapter shall be  
479 construed to mean that the Department can issue any such certificate authorizing intracity transportation.

480 "Charter bus" means a motor vehicle manufactured with a minimum seating capacity of 32  
481 passengers or more, excluding the driver.

482 "Common carrier" means any person who undertakes, whether directly or by a lease or any other  
483 arrangement, to transport passengers for the general public by motor vehicle for compensation over the  
484 highways of the Commonwealth, whether over regular or irregular routes, including such motor vehicle  
485 operations of carriers by rail or water under this chapter. "Common carrier" does not include  
486 nonemergency medical transportation carriers as defined in this section.

487 "Contract bus carrier" means a motor carrier that operates solely charter buses, as defined in this  
488 section, to transport groups of passengers under a single contract made with one person for an agreed  
489 charge for such transportation regardless of the number of passengers transported, and for which  
490 transportation no individual or separate fares are solicited, charged, collected, or received by the carrier.

491 "Contract carrier" means any person who, under special and individual contracts or agreements, and  
492 whether directly or by a lease or any other arrangement, transports passengers for compensation.

493 "Contract passenger carrier" means a motor carrier that transports groups of passengers under a single  
494 contract made with one person for an agreed charge for such transportation, regardless of the number of  
495 passengers transported, and for which transportation no individual or separate fares are solicited,  
496 charged, collected, or received by the carrier.

497 "Department" means the Department of Motor Vehicles.

498 "Employee hauler" means a motor carrier operating for compensation and exclusively transporting  
499 only bona fide employees directly to and from the factories, plants, office or other places of like nature  
500 where the employees are employed and accustomed to work.

501 "Excursion train" means any steam-powered train that carries passengers for which the primary  
502 purpose of the operation of such train is the passengers' experience and enjoyment of this means of  
503 transportation, and does not, in the course of operation, carry (i) freight other than the personal luggage  
504 of the passengers or crew or supplies and equipment necessary to serve the needs of the passengers and  
505 crew, (ii) passengers who are commuting to work, or (iii) passengers who are traveling to their final  
506 destination solely for business or commercial purposes.

507 "Financial responsibility" means the ability to respond in damages for liability thereafter incurred  
508 arising out of the ownership, maintenance, use, or operation of a motor vehicle, in the amounts provided  
509 for in this chapter.

510 "Highway" means every public highway or place of whatever nature open to the use of the public for  
511 purposes of vehicular travel in the Commonwealth, including the streets and alleys in towns and cities.

512 "Identification marker" means a decal or other visible identification issued by the Department to  
513 show (i) that the operator of the vehicle has registered with the Department for the payment of the road  
514 tax imposed under Chapter 27 (§ 58.1-2700 et seq.) of Title 58.1, (ii) proof of the possession of a  
515 certificate or permit issued pursuant to Chapter 20 (§ 46.2-2000 et seq.) of this title, and/or (iii) proof of  
516 compliance with the insurance requirements of this chapter.

517 "Interstate" means transportation of passengers between states.

518 "Intrastate" means transportation of passengers solely within a state.

519 "License" means a license issued by the Department to a broker.

520 "Minibus" means any motor vehicle having a seating capacity of not less than seven nor more than  
521 31 passengers, including the driver, and used in the transportation of passengers.

522 "Motor carrier" means any person who undertakes, whether directly or by lease, to transport  
523 passengers for compensation over the highways of the Commonwealth.

524 "Motor launch" means a motor vessel that meets the requirements of the U.S. Coast Guard for the  
525 carriage of passengers for compensation, with a capacity of six or more passengers, but not in excess of  
526 fifty passengers. Motor launch, as defined herein, shall not include sight-seeing vessels, special or  
527 charter party vessels within the provisions of this chapter. A carrier by motor launch shall not be  
528 regarded as a steamship company.

529 *"Nonemergency medical transportation carrier" means a motor carrier that exclusively provides*  
530 *nonemergency medical transportation and provides such transportation only through the Department of*  
531 *Medical Assistance Services or through a broker operating under a contract with that Department to*  
532 *provide such transportation.*

533 "Nonprofit/tax-exempt passenger carrier" means a bona fide nonprofit corporation organized or  
534 existing under Chapter 10 (§ 13.1-801 et seq.) of Title 13.1, or a tax-exempt organization as defined in  
535 §§ 501 (c) (3) and 501 (c) (4) of the United States Internal Revenue Code, as from time to time  
536 amended, who undertakes, whether directly or by lease, to control and operate minibuses exclusively in  
537 the transportation, for compensation, of members of such organization if it is a membership corporation,  
538 or of elderly, disabled, or economically disadvantaged members of the community if it is not a  
539 membership corporation.

540 "Operation" or "operations" includes the operation of all motor vehicles, whether loaded or empty,  
541 whether for compensation or not, and whether owned by or leased to the motor carrier who operates  
542 them or causes them to be operated.

543 "Operator" means the employer or person actually driving a motor vehicle or combination of  
544 vehicles.

545 "Permit" means a permit issued by the Department to carriers operating as employee haulers or  
546 nonprofit/tax-exempt passenger carriers or to operators of taxicabs or other vehicles performing taxicab  
547 service under this chapter.

548 "Person" means any individual, firm, copartnership, corporation, company, association or joint-stock  
549 association, and includes any trustee, receiver, assignee, or personal representative thereof.

550 "Restricted common carrier" means any person who undertakes, whether directly or by a lease or  
551 other arrangement, to transport passengers for compensation, whereby such transportation service has

552 been restricted.

553 "Route," when used in connection with or with respect to a certificate of public convenience and  
 554 necessity, means the road or highway, or segment thereof, operated over by the holder of a certificate of  
 555 public convenience and necessity or proposed to be operated over by an applicant therefor, whether such  
 556 road or highway is designated by one or more highway numbers.

557 "Services" and "transportation" include the service of, and all transportation by, all vehicles operated  
 558 by, for, or in the interest of any motor carrier irrespective of ownership or contract, expressed or  
 559 implied, together with all facilities and property operated or controlled by any such carrier or carriers  
 560 and used in the transportation of passengers or the performance of any service in connection therewith.

561 "Sight-seeing carrier" means a restricted common carrier authorized to transport passengers under the  
 562 provisions of this chapter, whereby the primary purpose of the operation is the passengers' experience  
 563 and enjoyment and/or the promotion of tourism.

564 "Sight-seeing carrier by boat" means a restricted common carrier, which restricted common carrier  
 565 uses a boat or boats operating on waters within the Commonwealth to transport passengers, and whereby  
 566 the primary purpose of the operation is the passengers' experience and enjoyment and/or the promotion  
 567 of tourism. Sight-seeing carriers by boat shall not be regarded as steamship companies.

568 "Single state insurance receipt" means any receipt issued pursuant to 49 C.F.R. Part 367 evidencing  
 569 that the carrier has the required insurance and paid the requisite fees to the Commonwealth and other  
 570 qualified jurisdictions.

571 "Special or charter party carrier by boat" for purposes of this chapter shall mean a restricted common  
 572 carrier which transports groups of persons under a single contract made with one person for an agreed  
 573 charge for such movement regardless of the number of persons transported. Special or charter party  
 574 carriers by boat shall not be regarded as steamship companies.

575 "Taxicab or other motor vehicle performing a taxicab service" means any motor vehicle having a  
 576 seating capacity of not more than six passengers, excluding the driver, not operating on a regular route  
 577 or between fixed terminals used in the transportation of passengers for hire or for compensation, and not  
 578 a common carrier, ~~or~~ restricted common carrier, *or nonemergency medical transportation carrier* as  
 579 defined in this chapter.

580 § 46.2-2000.1. Vehicles excluded from operation of chapter.

581 This chapter shall not be construed to include:

582 1. Motor vehicles employed solely in transporting school children and teachers;

583 2. Taxicabs, or other motor vehicles performing bona fide taxicab service, having a seating capacity  
 584 of not more than six passengers, excluding the driver, while operating in a county, city, or town which  
 585 has or adopts an ordinance regulating and controlling taxicabs and other vehicles performing a bona fide  
 586 taxicab service, and not operating on a regular route or between fixed termini;

587 3. Motor vehicles owned or operated by or on behalf of hotels while used exclusively for the  
 588 transportation of hotel patronage between hotels and local railroad or other common carrier stations;

589 4. Motor vehicles owned and operated by the United States, the District of Columbia, or any state, or  
 590 any municipality or any other political subdivision of this Commonwealth, including passenger-carrying  
 591 motor vehicles while being operated under an exclusive contract with the United States;

592 5. Any motor vehicle designed with a seating capacity for and used to transport not more than fifteen  
 593 passengers, including the driver, if the driver and the passengers are engaged in a share-the-ride  
 594 undertaking and if they share not more than the expenses of operation of the vehicle. Regular payments  
 595 toward a capital recovery fund not exceeding the cost of the vehicle or used to pay for leasing the  
 596 vehicle are to be considered eligible expenses of operation;

597 6. Unless otherwise provided, motor vehicles while used exclusively in the transportation of  
 598 passengers within the corporate limits of incorporated cities or towns, and motor vehicles used  
 599 exclusively in the regular transportation of passengers within the boundaries of such cities or towns and  
 600 adjacent counties where such vehicles are being operated by such county or pursuant to a contract with  
 601 the board of supervisors of such county;

602 7. Motor vehicles while operated under the exclusive regulatory control of a transportation district  
 603 commission acting pursuant to Chapter 45 (§ 15.2-4500 et seq.) of Title 15.2;

604 8. Motor vehicles used for the transportation of passengers by nonprofit, nonstock corporations  
 605 funded solely by federal, state or local subsidies, the use of which motor vehicles are restricted as to  
 606 regular and irregular routes to contracts with four or more counties and, at the commencement of the  
 607 operation, no certificated carrier provides the same or similar services within such counties; *and*

608 9. *Ambulances as defined in § 32.1-111.1.*

609 § 46.2-2001.3. Application; notice requirements.

610 A. Applications for a license, permit, certificate, or identification marker under this chapter shall be  
 611 made to the Department and contain such information and exhibits as the Department shall require. Such  
 612 information shall include, in the application or otherwise, the matters set forth in § 46.2-2011.24 as  
 613 grounds for denying licenses, permits, and certificates, and other pertinent matters requisite for the

614 safeguarding of the public interest.

615 B. An applicant for any original certificate of public convenience and necessity issued under this  
616 chapter, or any request for a transfer of such certificate, unless otherwise provided, shall cause a notice  
617 of such application, on the form and in the manner prescribed by the Department, on every motor  
618 carrier holding the same type of certificate issued by the Department and operating or providing service  
619 within the area proposed to be served by the applicant.

620 C. ~~An applicant for~~ For any application for original certificate or license issued under this chapter,  
621 or any request for a transfer of such certificate or license, ~~the Department shall cause~~ publish a notice of  
622 such application ~~on the Department's public website; or~~ in the form and in the manner prescribed by the  
623 Department; ~~on every affected person who has requested notification.~~

624 D. An applicant for any original certificate of public convenience and necessity or license issued  
625 under this chapter, or any request for a transfer of such certificate of public convenience and necessity  
626 or license, shall cause a publication of a summary of the application to be made in a newspaper having  
627 a general circulation in the proposed area to be served or area where the primary business office is  
628 located within such time as the Department may prescribe.

629 § 46.2-2005. Action on applications; hearings on denials and protests.

630 A. The Department may act upon any application required under this chapter for a certificate of  
631 public convenience and necessity without a hearing, unless such application is protested by any  
632 aggrieved party, except that no protest shall be heard in such cases whereby the applicant has received a  
633 notice of intent to award a contract under the Virginia Public Procurement Act (§ 2.2-4300 et seq.) for  
634 irregular route common carrier service to or from a public-use airport located in the City of Norfolk.  
635 Aggrieved parties may protest an application by submitting written grounds to the Department setting  
636 forth (i) a precise statement of the party's interest and how the party could be aggrieved if the  
637 application were granted; (ii) a full and clear statement of the facts that the person is prepared to  
638 provide by competent evidence; (iii) a statement of the specific relief sought; (iv) the case number  
639 assigned to the application; and (v) a certification that a copy of the protest was sent to the applicant.

640 B. ~~The Department may act upon any application required under this chapter for a license or~~  
641 ~~certificate of fitness without a hearing, unless such application is protested by any party based upon~~  
642 ~~fitness allegations. Parties may protest an application by submitting written grounds to the Department~~  
643 ~~setting forth (i) a precise statement of the party's objections to the application being granted; (ii) a full~~  
644 ~~and clear statement of the facts that the person is prepared to provide by competent evidence; (iii) the~~  
645 ~~case number assigned to the application; and (iv) a certification that a copy of the protest was sent to~~  
646 ~~the applicant. The Department shall have full discretion as to whether a hearing is warranted based on~~  
647 ~~the merits of any protest filed.~~

648 C. Any applicant denied without a hearing an original license or certificate under subsection A or B,  
649 or any request for a transfer of such a license or certificate, shall be given a hearing at a time and place  
650 determined by the Commissioner or his designee upon the applicant's written request for such hearing  
651 made within thirty days of denial.

652 § 46.2-2011.4. Conversion of old permits and certificates.

653 A. All holders of nonemergency medical transportation carriers as defined in this chapter that hold  
654 a license, permit, or certificate issued prior to July 1, 2002 2011, shall be issued a replacement license,  
655 permit, or nonemergency medical transportation certificate that shall reflect the same or new  
656 classification for and contain the same requirements and restrictions as the original license, permit, or  
657 certificate of fitness. All contract passenger carriers and sight-seeing carriers that hold a certificate of  
658 public convenience and necessity issued prior to July 1, 2011, shall be issued a replacement certificate  
659 of fitness. The holder of such license, permit, or certificate shall apply for a replacement license, permit,  
660 or certificate prior to October 1, 2002 2011. If such application is not received by the Department or  
661 received in an envelope bearing a postmark showing it was mailed prior to midnight, September 30,  
662 2002 2011, then the license, permit, or certificate shall expire.

663 B. If a broker, motor carrier, or rail passenger carrier does not request a replacement license, permit,  
664 or certificate prior to October 1, 2002 2011, and allows the original to expire, any application received  
665 thereafter shall be treated as an original application.

666 C. Replacement certificates issued for limousine, executive sedan, and special or charter party  
667 certificates shall be reclassified as contract passenger certificates.

668 § 46.2-2011.8. Transfers of licenses or certificates.

669 Any license or certificate issued under this chapter may be transferred or leased, subject to the  
670 approval of the Department, and under such reasonable rules and regulations as may be prescribed by  
671 the Department. An application for such approval shall be made jointly by the transferor and transferee,  
672 or lessor or lessee. The transfer or lease of a license or certificate can only be made upon a satisfactory  
673 showing that such purchaser, or transferee, or lessee can and will comply with the applicable motor  
674 carrier or broker laws, rules and regulations of the Department, is fit, willing and able to properly

675 perform the services, and all taxes due the Commonwealth have been paid, or payment guaranteed.

676 § 46.2-2011.27. Basis for reinstatement of suspended licenses, permits, or certificates; reinstatement  
677 fees.

678 A. The Department shall reinstate any license, permit, or certificate suspended pursuant to this  
679 chapter provided the grounds upon which the suspension action was taken have been satisfied and the  
680 appropriate reinstatement fee and other applicable fees have been paid to the Department.

681 B. The reinstatement fee for suspensions issued pursuant to this chapter shall be fifty dollars. In the  
682 event multiple credentials have been suspended under this chapter for the same violation, only one  
683 reinstatement fee shall be applicable.

684 C. In addition to a reinstatement fee, a fee of \$500 shall be paid for failure of a motor carrier to  
685 keep in force at all times insurance, a bond or bonds, in an amount required by this chapter. *Any motor  
686 carrier who applies for a new license, permit, or certificate because his prior license, permit, or  
687 certificate was revoked for failure to keep in force at all times insurance, a bond or bonds, in an  
688 amount required by this chapter, shall also be subject to a fee of \$500.*

689 § 46.2-2075. Required certificates of public convenience and necessity.

690 No common carrier not otherwise exempted, *other than a sight-seeing carrier*, shall engage in  
691 intrastate operation on any highway within the Commonwealth without first having obtained from the  
692 Department a certificate of public convenience and necessity authorizing such operation.

693 § 46.2-2096. Certificates required unless exempted.

694 Unless otherwise exempted, no person shall engage in the business of a contract passenger carrier by  
695 motor vehicle on any highway within the Commonwealth on an intrastate basis unless such person has  
696 secured from the Department a certificate of ~~public convenience and necessity~~ *fitness* authorizing such  
697 business.

698 § 46.2-2099.4. Required certificate of fitness.

699 No sight-seeing carrier, unless otherwise exempted, shall transport passengers on any highway within  
700 the Commonwealth on an intrastate basis without first having obtained from the Department a certificate  
701 of ~~public convenience and necessity~~ *fitness* authorizing such operation.

702 § 46.2-2099.5. Specific service and route requirements.

703 ~~A certificate issued under this article shall authorize the holder named in the certificate to A  
704 sight-seeing carrier shall transport passengers from the a specific point or points of origin named in the  
705 certificate over regular routes to the specific points of interest named in the certificate and back to the  
706 point or points of origin. Each passenger shall be issued a ticket on which shall be printed the points of  
707 interest and the fare charged for the round trip. Passengers shall be transported only on round trips  
708 without stopover privileges, and no part of a fare shall be refunded because of a passenger's refusal to  
709 complete the round trip.~~

##### 711 Nonemergency Medical Transportation Carriers.

712 § 46.2-2099.44. Certificate of fitness required.

713 *No nonemergency medical transportation carrier, unless otherwise exempted, shall transport  
714 passengers on any highway within the Commonwealth on an intrastate basis without first having  
715 obtained from the Department a certificate of fitness authorizing such operation.*

716 § 46.2-2100. Definitions.

717 Whenever used in this chapter, unless expressly stated otherwise:

718 "Authorized insurer" means, in the case of an interstate motor carrier whose operations may or may  
719 not include intrastate activity, an insurer authorized to transact business in any one state, or, in the case  
720 of a solely intrastate motor carrier, an insurer authorized to transact business in the Commonwealth.

721 "Broker" means any person not included in the term "motor carrier" and not a bona fide employee or  
722 agent of any such carrier, who, as principal or agent, sells or offers for sale any transportation subject to  
723 this chapter, or negotiates for, or holds himself out by solicitation, advertisement, or otherwise as one  
724 who sells, provides, furnishes, contracts, or arranges for such transportation.

725 "Bulk commodity" means any non-liquid, non-gaseous commodity shipped loose or in mass/aggregate  
726 and which in the loading and unloading thereof is ordinarily shoveled, scooped, forked, or mechanically  
727 conveyed or which is not in containers or in units of such size to permit piece by piece loading and  
728 unloading.

729 "Bulk property carrier" means any person, not herein exempted, who undertakes either directly or by  
730 lease, to transport exclusively bulk commodities, as defined, for compensation including for purposes of  
731 this section for-hire tow truck operations.

732 "Certificate of ~~public convenience and necessity~~ *fitness*" means a certificate issued by the Department  
733 to certain "household goods carriers" under this chapter.

734 "Constructive weight" means a measurement of seven pounds per cubic foot of properly loaded van  
735 space.

736 "Courier service" means a motor carrier that engages, directly or by lease, exclusively in the

737 transportation of letters, envelopes, negotiable or nonnegotiable instruments, or other documents or  
738 papers for compensation.

739 "Department" means the Department of Motor Vehicles.

740 "Financial responsibility" means the ability to respond in damages for liability thereafter incurred  
741 arising out of the ownership, maintenance, use, or operation of a motor vehicle, in the amounts provided  
742 for in this chapter.

743 "Gross weight" means the weight of a truck after a shipment has been loaded.

744 "Highway" means every public highway or place of whatever nature open to the use of the public for  
745 purposes of vehicle travel in this Commonwealth, excluding the streets and alleys in towns and cities.

746 "Household goods" means personal effects and property used or to be used in a dwelling, when a  
747 part of the equipment or supplies of such dwelling, and similar property if the transportation of such  
748 effects or property is (i) arranged and paid for by the householder, including transportation of the  
749 property from a factory or store when the property is purchased by the householder with intent to use it  
750 in his dwelling or (ii) arranged and paid for by another party.

751 "Household goods carrier" means a restricted common carrier who undertakes, whether directly or by  
752 a lease or other arrangement, to transport "household goods," as herein defined, by motor vehicle for  
753 compensation, on any highway in this Commonwealth, between two or more points in this  
754 Commonwealth, whether over regular or irregular routes.

755 "Identification marker" means a decal or other visible identification issued by the Department to  
756 show (i) that the operator of the vehicle has registered with the Department for the payment of the road  
757 tax imposed under Chapter 27 (§ 58.1-2700 et seq.) of Title 58.1, (ii) proof of the possession of a  
758 certificate or permit issued pursuant to Chapter 21 (§ 46.2-2100 et seq.) of this title, and/or (iii) proof of  
759 compliance with the insurance requirements of this chapter.

760 "Interstate" means the transportation of property between states.

761 "Intrastate" means the transportation of property solely within a state.

762 "License" means a license issued by the Department to a broker.

763 "Motor carrier" means any person who undertakes whether directly or by a lease, to transport  
764 property, including household goods, as defined by this chapter, for compensation over the highways of  
765 the Commonwealth.

766 "Motor vehicle" means any vehicle, machine, tractor, trailer, or semitrailer propelled or drawn by  
767 mechanical power and used upon the highways in the transportation of property, but does not include  
768 any vehicle, locomotive or car operated exclusively on a rail or rails.

769 "Net weight" means the tare weight subtracted from the gross weight.

770 "Permit" means a permit issued by the Department authorizing the transportation of property,  
771 excluding household goods transported for a distance greater than 30 road miles.

772 "Person" means any individual, firm, copartnership, corporation, company, association or joint-stock  
773 association, and includes any trustee, receiver, assignee, or personal representative thereof.

774 "Property carrier" means any person, not herein exempted, who undertakes either directly or by a  
775 lease, to transport property for compensation.

776 "Restricted common carrier" means any person who undertakes, whether directly or by a lease or  
777 other arrangement, to transport household goods by motor vehicle for compensation whether over regular  
778 or irregular routes.

779 "Services" and "transportation" includes the services of, and all transportation by, all vehicles  
780 operated by, for, or in the interest of any motor carrier, irrespective of ownership or contract, express or  
781 implied, together with all facilities and property operated or controlled by any such carrier or carriers  
782 and used in the transportation of property or in the performance of any service in connection therewith.

783 "Single state insurance receipt" means any receipt issued pursuant to 49 C.F.R. Part 367 evidencing  
784 that the carrier has the required insurance and paid the requisite fees to the Commonwealth and other  
785 qualified jurisdictions.

786 "Tare weight" means the weight of a truck before being loaded at a shipper's residence or place of  
787 business, including the pads, dollies, hand-trucks, ramps and other equipment normally used in the  
788 transportation of household goods shipments.

789 § 46.2-2108.2. Necessity of a license, permit, or certificate.

790 It shall be unlawful for any person to operate, offer, advertise, provide, procure, furnish, or arrange  
791 by contract, agreement or arrangement to transport property for compensation on an intrastate basis as a  
792 motor carrier or broker without first obtaining from the Department a license, permit, or certificate of  
793 ~~public convenience and necessity~~ *fitness* as required by this chapter.

794 § 46.2-2108.4. Application; notice requirements.

795 A. Applications for a license, permit, or certificate of ~~public convenience and necessity~~ *fitness* under  
796 this chapter shall be made to the Department and contain such information as the Department shall  
797 require. Such information shall include, in the application or otherwise, the matters set forth in

798 §§ 46.2-2133 and 46.2-2134 as grounds for denying licenses, permits, and certificates.

799 B. The applicant for a certificate of ~~public convenience and necessity~~ *fitness* issued under this chapter  
800 shall cause a notice of such application, on the form and in the manner prescribed by the Department, to  
801 be served on the mayor or principal officer of any city or county and on the chairman of the board of  
802 supervisors of any county in which the applicant maintains offices and/or warehouses; and on every  
803 affected person who has requested notification. Publication of a summary of the application shall be  
804 made in a newspaper having a general circulation in the area where the primary business office is  
805 located within such time as the Department may prescribe.

806 § 46.2-2108.5. Registered for fuels tax; business, professional, and occupational license taxes.

807 License, permit, and certificate of ~~public convenience and necessity~~ *fitness* holders shall be licensed  
808 and registered in accordance with the road tax requirements of Chapter 27 (§ 58.1-2700 et seq.) of Title  
809 58.1 and licensed for payment of local business, professional, and occupational license taxes of Chapter  
810 37 (§ 58.1-3700 et seq.) of Title 58.1 as required.

811 § 46.2-2108.6. Considerations for determination of issuance of license, permit, or certificate.

812 In determining whether a license, permit, or certificate of ~~public convenience and necessity~~ *fitness*  
813 required by this chapter shall be issued, the Department may, among other things, consider compliance  
814 with financial responsibility, bonding and other requirements of this chapter.

815 § 46.2-2109. Action on applications; hearings on denials and protests.

816 A. The Department may act upon any application required under this chapter without a hearing,  
817 unless such application is protested by any ~~aggrieved party based upon fitness allegations.~~ ~~Aggrieved~~  
818 ~~parties~~ *Parties* may protest an application by submitting written grounds to the Department setting forth  
819 (i) a precise statement of the party's interest and how the party could be aggrieved if *objections to the*  
820 application ~~were being~~ granted; (ii) a full and clear statement of the facts that the person is prepared to  
821 provide by competent evidence; (iii) a statement of the specific relief sought; ~~(iv)~~ *(iv)* the case number  
822 assigned to the application; and ~~(v)~~ *(iv)* a certification that a copy of the protest was sent to the  
823 applicant. *The Department shall have full discretion as to whether a hearing is warranted based on the*  
824 *merits of any protest filed.*

825 B. Any applicant denied without a hearing an original license or certificate of ~~public convenience and~~  
826 ~~necessity~~ *fitness* under subsection A, or any request for a transfer for such license or certificate, shall be  
827 given a hearing at a time and place determined by the Commissioner or his designee upon the  
828 applicant's written request for such hearing made within thirty days of denial.

829 § 46.2-2115. Determination for issuance of license, permit, or certificate.

830 If the Department finds the applicant has met all requirements of this chapter, it shall issue a license,  
831 permit, or certificate of ~~public convenience and necessity~~ *fitness* to the applicant, subject to such terms,  
832 limitations and restrictions as the Department may deem proper.

833 § 46.2-2116. Issuance of temporary authority.

834 To enable the provision of service for which there is an immediate and urgent need to a point or  
835 between points in Virginia where certificated carriers are unable to perform the service, or within a  
836 territory having no certificated carrier, the Department may, in its discretion and without hearings or  
837 other proceedings, grant temporary authority for such service by a carrier that would otherwise be  
838 required to obtain a certificate of ~~public convenience and necessity~~ *fitness* under this chapter. Such  
839 temporary authority, unless suspended or revoked in accordance with § 46.2-2133, shall be valid for  
840 such time as the Department shall specify, but for not more than an aggregate of 180 days, and shall  
841 create no presumption that corresponding permanent authority will be granted thereafter.

842 § 46.2-2118. Issuance, expiration, and renewal of license, permit, and certificate.

843 All licenses, permits, and certificates of ~~public convenience and necessity~~ *fitness* issued under this  
844 chapter shall be issued for a period of twelve consecutive months except, at the discretion of the  
845 Department, the periods may be adjusted as necessary. Such licenses, permits, and certificates shall  
846 expire if not renewed annually. Such expiration shall be effective thirty days after the Department has

858 B. If a ~~broker or~~ motor carrier does not request a replacement ~~license, permit, or~~ certificate prior to  
859 October 1, 2002 ~~2011~~, and allows the original to expire, any application received thereafter shall be

860 treated as an original application.

861 § 46.2-2120. Filing and application fees.

862 Every applicant for an original license or certificate of ~~public convenience and necessity~~ *fitness*  
863 issued under this chapter and transfer of a license or certificate of ~~public convenience and necessity~~  
864 *fitness* under this chapter shall, upon the filing of an application, deposit with the Department, as a filing  
865 fee, a sum in the amount of fifty dollars. The Department shall collect a fee of three dollars for the  
866 issuance of a duplicate license or certificate of ~~public convenience and necessity~~ *fitness*.

867 § 46.2-2122. Bond and letter of credit requirements of applicants for license and certificate.

868 A. Every applicant for an original, second-year renewal, third-year renewal, fourth-year renewal, and  
869 fifth-year renewal of a certificate of ~~public convenience and necessity~~ *fitness* under this chapter shall  
870 obtain and file with the Department a surety bond or an irrevocable letter of credit, in addition to any  
871 other bond or letter of credit required by law, in the amount of \$50,000. The bond or letter of credit  
872 shall be in a form and content acceptable to the Department. The bond or letter of credit shall be  
873 conditioned on a statement by the applicant that the applicant will not practice fraud, make any  
874 fraudulent representation, or violate any provision of this chapter in the conduct of the applicant's

876 ~~and necessity~~ *fitness* during the period that the certificate holder does not have a sufficient bond or letter  
877 of credit on file.

878 B. Every applicant for an original and subsequent renewal license pursuant to Article 5 of this  
879 chapter shall obtain and file with the Department a surety bond or an irrevocable letter of credit, in  
880 addition to any other bond or letter of credit required by law, in the amount of \$25,000. The bond or  
881 letter of credit shall be in a form and content acceptable to the Department. The bond or letter of credit  
882 shall be conditioned on a statement by the applicant that the applicant will not practice fraud, make any  
883 fraudulent representation, or violate any provision of this chapter in the conduct of the applicant's  
884 business. The Department may, without holding a hearing, suspend the license during the period that the  
885 licensee does not have a sufficient bond or letter of credit on file.

886 C. If a person suffers any of the following: (i) loss or damage in connection with the transportation  
887 service by reason of fraud practiced on him or fraudulent representation made to him by a licensee or  
888 certificate holder or his agent or employee acting within the scope of employment; (ii) loss or damage  
889 by reason of a violation by a licensee or certificate holder or his agent or employee of any provision of  
890 this chapter in connection with the transportation service; or (iii) loss or damage resulting from a breach  
891 of a contract entered into on or after the effective date of this act, that person shall have a claim against  
892 the licensee or certificate holder's bond or letter of credit, and may recover from such bond or letter of  
893 credit the amount awarded to such person by final judgment of a court of competent jurisdiction against  
894 the licensee or certificate holder as a result of such loss or damage up to, but not exceeding, the amount  
895 of the bond or letter of credit.

896 D. The licensee or certificate holder's surety shall notify the Department when a claim is made  
897 against a licensee or certificate holder's bond, when a claim is paid and/or when the bond is canceled.  
898 Such notification shall include the amount of a claim and the circumstances surrounding the claim.  
899 Notification of cancellation shall include the effective date and reason for cancellation.

900 E. The surety on any bond filed by a licensee or certificate holder shall be released and discharged  
901 from all liability accruing on such bond after the expiration of sixty days from the date on which the  
902 surety files with the Department a written request to be released and discharged. Such request shall not  
903 operate to relieve, release, or discharge the surety from any liability already accrued or that shall accrue  
904 before the expiration of the sixty-day period.

905 § 46.2-2123. Transfer of license or certificate.

906 Any certificate of ~~public convenience and necessity~~ *fitness* issued under this chapter may be  
907 transferred ~~or leased~~, subject to the approval of the Department, and under such reasonable rules and  
908 regulations as may be prescribed by the Department. An application for such approval shall be made

915 § 46.2-2124. Notice of discontinuance of service.

916 Every motor carrier or broker who ceases operation or abandons his rights under a license, permit, or  
917 certificate of ~~public convenience and necessity~~ *fitness* issued shall notify the Department within thirty  
918 days of such cessation or abandonment.

919 § 46.2-2132. Violations; civil penalties.

920 The Department may impose a civil penalty not exceeding \$1,000 if any person has:

921 1. Made any misrepresentation of a material fact to obtain proper operating credentials as required by  
 922 this chapter or other requirements in this title regulating the operation of motor vehicles;

923 2. Failed to make any report required in this chapter;

924 3. Failed to pay any fee or tax properly assessed against him; or

925 4. Failed to comply with any provision of this chapter or lawful order, rule or regulation of the  
 926 Department or any term or condition of any certificate, permit, or license.

927 Any such penalty shall be imposed by order; however, no order issued pursuant to this section shall  
 928 become effective until the Department has offered the person an opportunity for an administrative  
 929 hearing to show cause why the order should not be enforced. Instead of or in addition to imposing such  
 930 penalty, the Department may suspend, revoke, or cancel any license, permit, certificate of ~~public~~  
 931 ~~convenience and necessity fitness~~, registration card or identification marker issued pursuant to this title.  
 932 If, in any such case, it appears that the defendant owes any fee or tax to the Commonwealth, the  
 933 Department shall enter order therefor.

934 § 46.2-2133. Grounds for denying, suspending, or revoking licenses or certificates.

935 A license or certificate of ~~public convenience and necessity fitness~~ issued under this chapter may be  
 936 denied, suspended, or revoked on any one or more of the following grounds, where applicable:

937 1. Material misstatement or omission in application for license or certificate of public convenience  
 938 and necessity, identification marker, or vehicle registration;

939 2. Failure to comply subsequent to receipt of a written warning from the Department or any willful  
 940 failure to comply with a lawful order, any provision of this chapter or any regulation promulgated by  
 941 the Department under this chapter, or any term or condition of any license or certificate of ~~public~~  
 942 ~~convenience and necessity fitness~~;

943 3. Use of deceptive business acts or practices;

944 4. Knowingly advertising by any means any assertion, representation, or statement of fact that is  
 945 untrue, misleading, or deceptive relating to the conduct of the business for which a license, certificate of  
 946 ~~public convenience and necessity fitness~~, identification marker, or vehicle registration is held or sought;

947 5. Having been found, through a judicial or administrative hearing, to have committed fraudulent or  
 948 deceptive acts in connection with the business for which a license or certificate of ~~public convenience~~  
 949 ~~and necessity fitness~~ is held or sought or any consumer-related fraud;

950 6. Having been convicted of any criminal act involving the business for which a license or certificate  
 951 of ~~public convenience and necessity fitness~~ is held or sought;

952 7. Improper leasing, renting, lending, or otherwise allowing the improper use of a license, certificate  
 953 of ~~public convenience and necessity fitness~~, identification marker, or vehicle registration;

954 8. Having been convicted of a felony;

955 9. Having been convicted of any misdemeanor involving lying, cheating, stealing, or moral turpitude;

956 10. Failure to submit to the Department any tax, fees, dues, fines, or penalties owed to the  
 957 Department;

958 11. Failure to furnish the Department information, documentation, or records required or requested  
 959 pursuant to statute or regulation;

960 12. Knowingly and willfully filing any false report, account, record, or memorandum;

961 13. Failure to meet application certifications or requirements of ~~public convenience and necessity~~,  
 962 character, fitness, and financial responsibility pursuant to this chapter;

963 14. Willfully altering or changing the appearance or wording of any license, certificate, identification  
 964 marker, license plate, or vehicle registration;

965 15. Failure to provide services in accordance with license or certificate of ~~public convenience and~~  
 966 ~~necessity fitness~~ terms, limitations, conditions, or requirements;

967 16. Failure to maintain and keep on file with the Department motor carrier liability insurance or  
 968 cargo insurance, issued by a company licensed to do business in the Commonwealth, or a bond,  
 969 certificate of insurance, certificate of self-insurance, or unconditional letter of credit in accordance with  
 970 this chapter, with respect to each motor vehicle operated in the Commonwealth;

971 17. Failure to comply with the Workers' Compensation Act of Title 65.2;

972 18. Failure to properly register a motor vehicle under this title;

973 19. Failure to comply with any federal motor carrier statute, rule, or regulation; or

974 20. Inactivity of a motor carrier as may be evidenced by the absence of a motor vehicle registered to  
 975 operate under such certificate or permit for a period of greater than three months.

976 § 46.2-2135. Altering or amending licenses, permits, or certificates.

977 The Department may alter or amend a license, permit, or certificate of ~~public convenience and~~  
 978 ~~necessity fitness~~ at the request of a licensee, permittee, or certificate holder, or upon a finding by the  
 979 Department that a licensee, permittee, or certificate holder failed to observe any of the provisions within  
 980 this chapter, or any of the rules or regulations of the Department, or any term, condition, or limitation of  
 981 such license or certificate.

982 § 46.2-2136. Suspension, revocation, and refusal to renew license, permit, or certificate; notice and

983 hearing.

984 A. Except as provided in subsection D of this section, unless otherwise provided in this chapter, no  
985 license, permit, or certificate of ~~public convenience and necessity~~ *fitness* issued under this chapter shall  
986 be suspended or revoked, or renewal thereof refused, unless the licensee, permittee, or certificate holder  
987 has been furnished a written copy of the complaint against him and the grounds upon which the action  
988 is taken and has been offered an opportunity for an administrative hearing to show cause why such  
989 action should not be taken.

990 B. The order suspending, revoking, or denying renewal of a license, permit, or certificate of ~~public~~  
991 ~~convenience and necessity~~ *fitness* shall not become effective until the licensee, permittee, or certificate  
992 holder has, after notice of the opportunity for a hearing, had thirty days to make a written request for  
993 such a hearing. If no hearing has been requested within such thirty-day period, the order shall become  
994 effective and no hearing shall thereafter be held. A timely request for a hearing shall automatically stay  
995 operation of the order until after the hearing.

996 C. Notice of an order suspending, revoking, or denying renewal of a license, permit, or certificate of  
997 ~~public convenience and necessity~~ *fitness* and an opportunity for a hearing shall be mailed to the licensee,  
998 permittee, or certificate holder by registered or certified mail at the address as shown on the license,  
999 permit, or certificate or other record of information in possession of the Department and shall be  
1000 considered served when mailed.

1001 D. If the Department makes a finding, after conducting a preliminary investigation, that the conduct  
1002 of a licensee, permittee, or certificate holder (i) is in violation of this chapter or regulations adopted  
1003 pursuant to this chapter and (ii) such violation constitutes a danger to public safety, the Department may  
1004 issue an order suspending the license, permit, or certificate. Notice of the suspension shall be in writing  
1005 and mailed in accordance with subsection C of this section. Upon receipt of a request for a hearing  
1006 appealing the suspension, the licensee, permittee, or certificate holder shall be afforded the opportunity  
1007 for a hearing within thirty days. The suspension shall remain in effect pending the outcome of the  
1008 hearing.

1009 § 46.2-2137. Basis for reinstatement of suspended licenses, permits, or certificates; reinstatement fees.

1010 A. The Department shall reinstate any license, permit, or certificate suspended pursuant to this  
1011 chapter provided the grounds upon which the suspension action was taken have been satisfied and the  
1012 appropriate reinstatement fee and other applicable fees have been paid to the Department.

1013 B. The reinstatement fee for suspensions issued pursuant to this chapter shall be fifty dollars. In the  
1014 event multiple credentials have been suspended under this chapter for the same violation only one  
1015 reinstatement fee shall be applicable.

1016 C. In addition to a reinstatement fee, a fee of \$500 shall be paid for failure of a motor carrier to  
1017 keep in force at all times insurance, a bond or bonds, in an amount required by this chapter. *Any motor*  
1018 *carrier who applies for a new license, permit, or certificate because his prior license, permit, or*  
1019 *certificate was revoked for failure to keep in force at all times insurance, a bond or bonds, in an*  
1020 *amount required by this chapter, shall also be subject to a fee of \$500.*

1021 § 46.2-2143. Surety bonds, insurance, letter of credit or securities required prior to issuance of  
1022 registration; amounts.

1023 A. No certificate of ~~public convenience and necessity~~ *fitness*, permit, identification marker,  
1024 registration card, or license plate shall be issued by the Department to any vehicle operated by a motor  
1025 carrier until the motor carrier certifies to the Department that the vehicle is covered by:

1026 1. An insurance policy or bond;

1027 2. A certificate of insurance in lieu of the insurance policy or bond, certifying that such policy or  
1028 bond covers the liability of such motor carrier in accordance with the provisions of this article, is issued  
1029 by an authorized insurer, or in the case of bonds, is in an amount approved by the Department. The  
1030 bonds may be issued by the Commonwealth of Virginia, the United States of America, or any  
1031 municipality in the Commonwealth. Such bonds shall be deposited with the State Treasurer and the  
1032 surety shall not be reduced except in accordance with an order of the Department;

1033 3. An unconditional letter of credit, issued by a bank doing business in Virginia, for an amount  
1034 approved by the Department. The letter of credit shall be in effect so long as the motor carrier operates  
1035 motor vehicles in the Commonwealth; or

1036 4. In the case of a lessor who acts as a registrant for purposes of consolidating lessees' vehicle  
1037 registration applications, a statement that the registrant has, before leasing a vehicle, obtained from the  
1038 lessee an insurance policy, bond, or certificate of insurance in lieu of the insurance policy or bond and  
1039 can make available said proof of insurance coverage upon demand.

1040 Vehicles belonging to carriers who have filed proof of financial responsibility in accordance with the  
1041 single state registration system authorized by 49 U.S.C. § 14504 or the unified carrier registration system  
1042 authorized by 49 U.S.C. § 14504a are deemed to have fulfilled the requirements of this article for  
1043 insurance purposes, provided there is on board the vehicle a copy of an insurance receipt issued pursuant

1044 to the federal regulations promulgated pursuant to 49 U.S.C. § 14504 or 14504a. The Department is  
 1045 further authorized to issue single state registration system or unified carrier registration system receipts  
 1046 to any qualified carrier as well as to collect and disperse the fees for and to qualified jurisdictions.

1047 B. All motor carriers shall keep in force at all times insurance, a bond or bonds, in an amount  
 1048 required by this section.

1049 C. The minimum public liability financial responsibility requirements for motor carriers operating in  
 1050 intrastate commerce shall be \$750,000. The minimum insurance for motor carriers operating in interstate  
 1051 commerce shall equal the minimum required by federal law, rule, or regulation. The minimum cargo  
 1052 insurance required for motor carriers operating in intrastate commerce shall be \$50,000. Motor carriers  
 1053 engaged exclusively in the transportation of bulk commodities shall not be required to file any cargo  
 1054 insurance, bond or bonds for cargo liability. Any motor carrier that meets the minimum federal financial  
 1055 responsibility requirements and also operates in intrastate commerce may submit, in lieu of a separate  
 1056 filing for its intrastate operation, proof of the minimum federal limits, provided that (i) both interstate  
 1057 and intrastate operations are insured, (ii) the public liability filed is at least \$750,000, and (iii) any cargo  
 1058 insurance requirements of this section have been met.

1059 § 46.2-2144. Policies or surety bonds to be filed with the Department and securities with State  
 1060 Treasurer.

1061 A. Each motor carrier shall keep on file with the Department proof of an insurance policy or bond in  
 1062 accordance with this article. Record of the policy or bond shall remain in the files of the Department six  
 1063 months after the certificate of ~~public convenience and necessity~~ *fitness*, registration card, license plate,  
 1064 identification marker or permit is canceled for any cause. If federal, state, or municipal bonds are  
 1065 deposited with the State Treasurer in lieu of an insurance policy, the bonds shall remain deposited until  
 1066 six months after the registration card, license plate, certificate, permit or identification marker is  
 1067 canceled for any cause unless otherwise ordered by the Department.

1068 B. The Department may, without holding a hearing, suspend a permit or certificate of ~~public~~  
 1069 ~~convenience and necessity~~ *fitness* if the permittee or certificate holder fails to comply with the  
 1070 requirements of this section.

1071 § 46.2-2146. Effect of unfair claims settlement practices on self-insured motor carriers.

1072 The provisions of subdivisions 4, 6, 11 and 12 of subsection A of § 38.2-510 shall apply to each  
 1073 holder of a certificate of ~~public convenience and necessity~~ *fitness* or permit issued by and under the  
 1074 authority of the Department who, in lieu of filing an insurance policy, has deposited with the State  
 1075 Treasurer state, federal or municipal bonds or has filed an unconditional letter of credit issued by a  
 1076 bank. The failure of any such holder of a certificate or permit to comply with the provisions of  
 1077 § 38.2-510 shall be the cause for revocation or suspension of the certificate or permit.

1078 § 46.2-2147. Certain household goods carriers exempted from article.

1079 Household goods carriers transporting solely household goods under a certificate of ~~public~~  
 1080 ~~convenience and necessity~~ *fitness* issued pursuant to this chapter are exempt from the provisions of this  
 1081 article.

1082 § 46.2-2150. Required certificates of fitness.

1083 No household goods carrier, unless otherwise exempted, shall engage in intrastate operations on any  
 1084 highway within the Commonwealth without first having obtained from the Department a certificate of  
 1085 ~~public convenience and necessity~~ *fitness* authorizing such operation.

1086 § 46.2-2151. Considerations for determination of issuance of certificate.

1087 In determining whether the certificate of ~~public convenience and necessity~~ *fitness* required by this  
 1088 article shall be granted, the Department may, among other things, consider the provisions of  
 1089 § 46.2-2108.6, ~~whether the proposed operation is justified by public convenience and necessity~~, the  
 1090 applicant's character and fitness, and the applicant's compliance with federal, state, and local taxes.

1091 § 46.2-2155. Power and duty of Department.

1092 The Department shall regulate and control all household goods carriers not herein exempted, doing  
 1093 business in the Commonwealth, in all matters relating to the performance of their duties as such carriers  
 1094 and their rates and charges therefor, which rates and charges shall be filed with and subject to approval  
 1095 by the Department by individual household goods carriers or by groups of such carriers, and correct  
 1096 abuses by such carriers. To that end the Department may prescribe reasonable rules, regulations, bills of  
 1097 lading, forms and reports for such carriers to administer and enforce the provisions of this chapter. The  
 1098 Department shall have the right at all times to require from such carriers special reports and statements,  
 1099 under oath, concerning their business. It shall make and enforce such requirements, rules, and  
 1100 regulations as may be necessary to prevent unjust or unreasonable discriminations by any such carrier ~~in~~  
 1101 ~~favor of, or against, any person, locality, community or connecting carrier in the matter of service,~~  
 1102 ~~schedule, efficiency of transportation or otherwise, in connection with the duties of such carriers.~~ The  
 1103 Department may prescribe and enforce such reasonable requirements, rules and regulations in the matter  
 1104 of leasing of motor vehicles as are necessary to prevent evasion of the Department's regulatory powers.

1105 § 46.2-2156. Solicitation, booking, registration by other persons prohibited; storage-in-transit.

1106 A. No person except a certificated household goods carrier, its parent, or its wholly owned subsidiary  
1107 company, or other entity under complete ownership, or an employee of the above certificated carrier  
1108 may solicit, book or register a shipment of household goods moving intrastate and only in the name of  
1109 that certificated carrier.

1110 B. No person or employee of a certificated or a noncertificated carrier may act as an employee,  
1111 representative, or agent for another certificated carrier for purpose of soliciting, booking or registering an  
1112 intrastate shipment except as provided in subsection A of this section. No person or employee of a  
1113 certificated carrier who solicits, books or registers intrastate shipments may be employed by a  
1114 noncertificated carrier.

1115 C. A certificated household goods carrier may utilize the services of another certificated household  
1116 goods carrier or a permitted property carrier that has complied with the minimum cargo insurance  
1117 requirements of this chapter for storage and final delivery on storage-in-transit shipments at destination.  
1118 A property carrier who does not hold a household goods certificate of ~~public convenience and necessity~~  
1119 *fitness* is prohibited from delivering a shipment for a greater distance than thirty road miles from the  
1120 warehouse. The shipment must move on the bill of lading of the originating certificated household goods  
1121 carrier with the delivering certificated household goods carrier or property carrier shown on the bill of  
1122 lading. The legal liability of the shipment remains the responsibility of the originating certificated  
1123 household goods carrier.

1124 D. A household goods carrier may interchange or interline shipments with any other certificated  
1125 household goods carrier provided both carriers hold proper authority to transport the shipment from  
1126 origin to destination. The shipment must move on the bill of lading of the originating certificated  
1127 household goods carrier with the delivering certificated household goods carrier shown on the bill of  
1128 lading. The legal liability of the shipment remains the responsibility of the originating certificated  
1129 household goods carrier.

1130 § 58.1-2259. Fuel uses eligible for refund.

1131 A. A refund of the tax paid for the purchase of fuel in quantities of five gallons or more at any time  
1132 shall be granted in accordance with the provisions of § 58.1-2261 to any person who establishes to the  
1133 satisfaction of the Commissioner that such person has paid the tax levied pursuant to this chapter upon  
1134 any fuel:

1135 1. Sold and delivered to a governmental entity for its exclusive use;

1136 2. Used by a governmental entity, provided persons operating under contract with a governmental  
1137 entity shall not be eligible for such refund;

1138 3. Sold and delivered to an organization described in subdivision 2 of § 58.1-2226 or subdivision 2  
1139 of § 58.1-2250 for its exclusive use in the operation of an aircraft;

1140 4. Used by an organization described in subdivision 2 of § 58.1-2226 or subdivision 2 of § 58.1-2250  
1141 for its exclusive use in the operation of an aircraft, provided persons operating under contract with such  
1142 an organization shall not be eligible for such refund;

1143 5. Purchased by a licensed exporter and subsequently transported and delivered by such licensed  
1144 exporter to another state for sales or use outside the boundaries of the Commonwealth if the tax  
1145 applicable in the destination state has been paid, provided a refund shall not be granted pursuant to this  
1146 section on any fuel which is transported and delivered outside of the Commonwealth in the fuel supply  
1147 tank of a highway vehicle or an aircraft;

1148 6. Used by any person performing transportation under contract or lease with any transportation  
1149 district for use in a highway vehicle controlled by a transportation district created under the  
1150 Transportation District Act of 1964 (§ 15.2-4500 et seq.) and used in providing transit service by the  
1151 transportation district by contract or lease, provided the refund shall be paid to the person performing  
1152 such transportation;

1153 7. Used by any private, nonprofit agency on aging, designated by the Department for the Aging,  
1154 providing transportation services to citizens in highway vehicles owned, operated or under contract with  
1155 such agency;

1156 8. Used in operating or propelling highway vehicles owned by a nonprofit organization that provides  
1157 specialized transportation to various locations for elderly or disabled individuals to secure essential  
1158 services and to participate in community life according to the individual's interest and abilities;

1159 9. Used in operating or propelling buses owned and operated by a county or the school board thereof  
1160 while being used to transport children to and from public school or from school to and from educational  
1161 or athletic activities;

1162 10. Used by buses owned or solely used by a private, nonprofit, nonreligious school while being  
1163 used to transport children to and from such school or from such school to and from educational or  
1164 athletic activities;

1165 11. Used by any county or city school board or any private, nonprofit, nonreligious school  
1166 contracting with a private carrier to transport children to and from public schools or any private,

1167 nonprofit, nonreligious school, provided the tax shall be refunded to the private carrier performing such  
1168 transportation;

1169 12. Used in operating or propelling the equipment of volunteer firefighting companies and of  
1170 volunteer rescue squads within the Commonwealth used actually and necessarily for firefighting and  
1171 rescue purposes;

1172 13. Used in operating or propelling motor equipment belonging to counties, cities and towns, if  
1173 actually used in public activities;

1174 14. Used for a purpose other than in operating or propelling highway vehicles, watercraft or aircraft;

1175 15. Used off-highway in self-propelled equipment manufactured for a specific off-road purpose,  
1176 which is used on a job site and the movement of which on any highway is incidental to the purpose for  
1177 which it was designed and manufactured;

1178 16. Proven to be lost by accident, including the accidental mixing of (i) dyed diesel fuel with  
1179 tax-paid motor fuel, (ii) gasoline with diesel fuel, or (iii) undyed diesel fuel with dyed kerosene, but  
1180 excluding fuel lost through personal negligence or theft;

1181 17. Used in operating or propelling vehicles used solely for racing other vehicles on a racetrack;

1182 18. Used in operating or propelling unlicensed highway vehicles and other unlicensed equipment  
1183 used exclusively for agricultural or horticultural purposes on lands owned or leased by the owner or  
1184 lessee of such vehicles and not operated on or over any highway for any purpose other than to move it  
1185 in the manner and for the purpose mentioned. The amount of refund shall be equal to the amount of the  
1186 taxes paid less one-half cent per gallon on such fuel so used which shall be paid by the Commissioner  
1187 into the state treasury to the credit of the Virginia Agricultural Foundation Fund;

1188 19. Used in operating or propelling commercial watercraft. The amount of refund shall be equal to  
1189 the amount of the taxes paid less one and one-half cents per gallon on such fuel so used which shall be  
1190 paid by the Commissioner into the state treasury to be credited as provided in subsection D of  
1191 § 58.1-2289. If any applicant so requests, the Commissioner shall pay into the state treasury, to the  
1192 credit of the Game Protection Fund, the entire tax paid by such applicant for the purposes specified in  
1193 subsection D of § 58.1-2289. If any applicant who is an operator of commercial watercraft so requests,  
1194 the Commissioner shall pay into the state treasury, to the credit of the Marine Fishing Improvement  
1195 Fund, the entire tax paid by such applicant for the purposes specified in § 28.2-208;

1196 20. Used in operating stationary engines, or pumping or mixing equipment on a highway vehicle if  
1197 the fuel used to operate such equipment is stored in an auxiliary tank separate from the fuel tank used to  
1198 propel the highway vehicle, and the highway vehicle is mechanically incapable of self-propulsion while  
1199 fuel is being used from the auxiliary tank; or

1200 21. Used in operating or propelling recreational and pleasure watercraft.

1201 B. 1. Any person purchasing fuel for consumption in a solid waste compacting or ready-mix concrete  
1202 highway vehicle, or a bulk feed delivery truck, where the vehicle's equipment is mechanically or  
1203 hydraulically driven by an internal combustion engine that propels the vehicle, is entitled to a refund in  
1204 an amount equal to 35 percent of the tax paid on such fuel. For purposes of this section, a "bulk feed  
1205 delivery truck" means bulk animal feed delivery trucks utilizing power take-off (PTO) driven auger or  
1206 air feed discharge systems for off-road deliveries of animal feed.

1207 2. Any person purchasing fuel for consumption in a vehicle designed or permanently adapted solely  
1208 and exclusively for bulk spreading or spraying of agricultural liming materials, chemicals, or fertilizer,  
1209 where the vehicle's equipment is mechanically or hydraulically driven by an internal combustion engine  
1210 that propels the vehicle, is entitled to a refund in an amount equal to 55 percent of the tax paid on such  
1211 fuel.

1212 C. Any person purchasing any fuel on which tax imposed pursuant to this chapter has been paid may  
1213 apply for a refund of the tax if such fuel was consumed by a highway vehicle used in operating an  
1214 urban or suburban bus line or a taxicab service. This refund also applies to a common carrier of  
1215 passengers which has been issued a certificate of public convenience and necessity pursuant to  
1216 ~~§§ 46.2-2005 and 58.1-2204~~ § 46.2-2075 or 46.2-2099.4 providing regular route service over the  
1217 highways of the Commonwealth. No refund shall be granted unless the majority of the passengers using  
1218 such bus line, taxicab service or common carrier of passengers do so for travel of a distance of not  
1219 more than 40 miles, one way, in a single day between their place of abode and their place of  
1220 employment, shopping areas or schools.

1221 If the applicant for a refund is a taxicab service, he shall hold a valid permit from the Department to  
1222 engage in the business of a taxicab service. No applicant shall be denied a refund by reason of the fee  
1223 arrangement between the holder of the permit and the driver or drivers, if all other conditions of this  
1224 section have been met.

1225 Under no circumstances shall a refund be granted more than once for the same fuel. The amount of  
1226 refund under this subsection shall be equal to the amount of the taxes paid, except refunds granted on  
1227 the tax paid on fuel used by a taxicab service shall be in an amount equal to the tax paid less \$0.01 per  
1228 gallon on the fuel used.

1229 Any refunds made under this subsection shall be deducted from the urban highway funds allocated to  
1230 the highway construction district, pursuant to Article 1.1 (§ 33.1-23.01 et seq.) of Chapter 1 of Title  
1231 33.1, in which the recipient has its principal place of business.

1232 Except as otherwise provided in this chapter, all provisions of law applicable to the refund of fuel  
1233 taxes by the Commissioner generally shall apply to the refunds authorized by this subsection. Any  
1234 county having withdrawn its roads from the secondary system of state highways under provisions of  
1235 § 11 Chapter 415 of the Acts of 1932 shall receive its proportionate share of such special funds as is  
1236 now provided by law with respect to other fuel tax receipts.

1237 D. Any person purchasing fuel for consumption in a vehicle designed or permanently adapted solely  
1238 and exclusively for bulk spreading or spraying of agricultural liming materials, chemicals, or fertilizer,  
1239 where the vehicle's equipment is mechanically or hydraulically driven by an internal combustion engine  
1240 that propels the vehicle, is entitled to a refund in an amount equal to 55 percent of the tax paid on such  
1241 fuel.

1242 E. Refunds resulting from any fuel shipments diverted from Virginia shall be based on the amount of  
1243 tax paid for the fuel less discounts allowed by § 58.1-2233.

1244 F. Any person who is required to be licensed under this chapter and is applying for a refund shall  
1245 not be eligible for such refund if the applicant was not licensed at the time the refundable transaction  
1246 was conducted.

1247 § 58.1-2402. Levy.

1248 A. There is hereby levied, in addition to all other taxes and fees of every kind now imposed by law,  
1249 a tax upon the sale or use of motor vehicles in Virginia, other than (i) vehicles with a gross vehicle  
1250 weight rating or gross combination weight rating of 26,001 pounds or more, or (ii) a sale to or use by a  
1251 person for rental as an established business or part of an established business or incidental or germane to  
1252 such business.

1253 There shall also be levied a tax upon the rental of a motor vehicle in Virginia, without regard to  
1254 whether such vehicle is required to be licensed by the Commonwealth. However, such tax shall not be  
1255 levied upon a rental to a person for re-rental as an established business or part of an established  
1256 business, or incidental or germane to such business.

1257 The amount of the tax to be collected shall be determined by the Commissioner by the application of  
1258 the following rates against the gross sales price or gross proceeds:

1259 1. Three percent of the sale price of each motor vehicle sold in Virginia. If such motor vehicle is a  
1260 manufactured home as defined in § 36-85.3, the tax shall be three percent of the sale price of each such  
1261 manufactured home sold in this Commonwealth; if such vehicle is a mobile office as defined in  
1262 § 58.1-2401, the tax shall be two percent of the sale price of each mobile office sold in this  
1263 Commonwealth.

1264 2. Three percent of the sale price of each motor vehicle, or three percent of the sale price of each  
1265 manufactured home as defined in § 36-85.3, or two percent of the sale price of each mobile office as  
1266 defined in § 58.1-2401, not sold in Virginia but used or stored for use in this Commonwealth. When any  
1267 such motor vehicle or manufactured home is first used or stored for use in Virginia six months or more  
1268 after its acquisition, the tax shall be based on its current market value.

1269 3. Four percent of the gross proceeds from the rental in Virginia of any motor vehicle, except those  
1270 with a gross vehicle weight rating or gross combination weight rating of 26,001 pounds or more.

1271 4. In addition to the tax levied pursuant to subdivision A 3, a tax of four percent of the gross  
1272 proceeds shall be levied on the rental in Virginia of any daily rental vehicle, whether or not such vehicle  
1273 is required to be licensed in the Commonwealth.

1274 5. In addition to all other applicable taxes and fees, a fee of two percent of the gross proceeds shall  
1275 be imposed on the rental in Virginia of any daily rental vehicle, whether or not such vehicle is required  
1276 to be licensed in the Commonwealth. For purposes of this chapter, the rental fee shall be implemented,  
1277 enforced, and collected in the same manner that rental taxes are implemented, enforced, and collected.

1278 6. The minimum tax levied on the sale of any motor vehicle in the Commonwealth shall be \$35,  
1279 except as provided by those exemptions defined in § 58.1-2403.

1280 7. *Zero percent of the sale price of each truck, tractor truck, trailer, or semitrailer, with a gross  
1281 vehicle weight rating or gross combination weight rating of 26,001 pounds or more sold, used, or stored  
1282 for use in the Commonwealth.*

1283 B. A transaction taxed under subdivision A 1 shall not also be taxed under subdivision A 2, nor shall  
1284 the same transaction be taxed more than once under either subdivision. A motor vehicle subject to the  
1285 tax imposed under subdivision A 3 shall be subject to the tax under either subdivision A 1 or A 2 when  
1286 it ceases to be used for rental as an established business or part of an established business, or incidental  
1287 or germane to such business.

1288 C. Any motor vehicle, trailer or semitrailer exempt from this tax under subdivision 1 or 2 of  
1289 § 58.1-2403 shall be subject to the tax, based on the current market value when such vehicle is no

1290 longer owned, rented or used by the United States government or any governmental agency, or the  
 1291 Commonwealth of Virginia or any political subdivision thereof. Further, any motor vehicle, trailer or  
 1292 semitrailer exempt from the tax imposed by this chapter under subdivision 11 of § 58.1-2403 or  
 1293 §§ 46.2-663 through 46.2-674 shall be subject to the tax, based on the current market value, when such  
 1294 vehicle is subsequently licensed to operate on the highways of this Commonwealth.

1295 D. Any person who with intent to evade or to aid another person to evade the tax provided for  
 1296 herein, falsely states the selling price of a vehicle on a bill of sale, assignment of title, application for  
 1297 title, or any other document or paper submitted to the Commissioner pursuant to any provisions of this  
 1298 title or Title 46.2, shall be guilty of a Class 3 misdemeanor.

1299 E. Effective January 1, 1997, any amount designated as a "processing fee" and any amount charged  
 1300 by a dealer for processing a transaction, which is required to be included on a buyer's order pursuant to  
 1301 subdivision A 10 of § 46.2-1530, shall be subject to the tax.

1302 § 58.1-2426. Application to Commissioner for correction; appeal.

1303 A. Any person assessed with any tax administered by the Department pursuant to this chapter may,  
 1304 within 30 days from the date of such assessment, apply for relief to the Commissioner. Such application  
 1305 shall be in the form prescribed by the Department, and shall fully set forth the grounds upon which the  
 1306 taxpayer relies and all facts relevant to the taxpayer's contention. The Commissioner may also require  
 1307 such additional information, testimony, or documentary evidence as he deems necessary to a fair  
 1308 determination of the application.

1309 B. On receipt of a written notice of intent to file under subsection A, the Commissioner shall refrain  
 1310 from collecting the tax until the time for filing hereunder has expired, unless he determines that  
 1311 collection is in jeopardy.

1312 C. Any person against whom an order or decision of the Commissioner has been adversely rendered  
 1313 relating to the tax imposed by this chapter may, within fifteen days of such order or decision, appeal  
 1314 from such order or decision to the Circuit Court of the City of Richmond.

1315 § 58.1-2701. (Contingent expiration date - see Editor's notes) Amount of tax.

1316 A. Except as provided in subsection B, every motor carrier shall pay a road tax equivalent to \$0.21  
 1317 per gallon calculated on the amount of motor fuel, diesel fuel or liquefied gases (which would not exist  
 1318 as liquids at a temperature of sixty degrees Fahrenheit and a pressure of 14.7 pounds per square inch  
 1319 absolute), used in its operations within the Commonwealth.

1320 The tax imposed by this chapter shall be in addition to all other taxes of whatever character imposed  
 1321 on a motor carrier by any other provision of law.

1322 B. In lieu of the tax imposed in subsection A, motor carriers registering qualified highway vehicles  
 1323 that are not registered under the International Registration Plan shall pay a fee of \$150 per year for each  
 1324 qualified highway vehicle *regardless of whether such vehicle will be included on the motor carrier's*  
 1325 *IFTA return*. The fee is due and payable when the vehicle registration fees are paid pursuant to the  
 1326 provisions of Article 7 (§ 46.2-685 et seq.) of Chapter 6 of Title 46.2.

1327 If a vehicle becomes a qualified highway vehicle before the end of its registration period, the fee due  
 1328 at the time the vehicle becomes a qualified highway vehicle shall be prorated monthly to the registration  
 1329 expiration month. Fees paid under this subsection shall not be refunded unless a full refund of the  
 1330 registration fee paid is authorized by law.

1331 C. All taxes and fees paid under the provisions of this chapter shall be credited to the Highway  
 1332 Maintenance and Operating Fund, a special fund within the Commonwealth Transportation Fund.

1333 § 58.1-2701. (Contingent effective date - see Editor's notes) Amount of tax.

1334 A. Except as provided in subsection B, every motor carrier shall pay a road tax equivalent to  
 1335 nineteen and one-half cents per gallon calculated on the amount of motor fuel, diesel fuel or liquefied  
 1336 gases (which would not exist as liquids at a temperature of sixty degrees Fahrenheit and a pressure of  
 1337 14.7 pounds per square inch absolute), used in its operations within the Commonwealth.

1338 The tax imposed by this chapter shall be in addition to all other taxes of whatever character imposed  
 1339 on a motor carrier by any other provision of law.

1340 B. In lieu of the tax imposed in subsection A, motor carriers registering qualified highway vehicles  
 1341 that are not registered under the International Registration Plan shall pay a fee of \$100 per year for each  
 1342 qualified highway vehicle, *regardless of whether such vehicle will be included on the motor carrier's*  
 1343 *IFTA return*. The fee is due and payable when the vehicle registration fees are paid pursuant to the  
 1344 provisions of Article 7 (§ 46.2-685 et seq.) of Chapter 6 of Title 46.2.

1345 If a vehicle becomes a qualified highway vehicle before the end of its registration period, the fee due  
 1346 at the time the vehicle becomes a qualified highway vehicle shall be prorated monthly to the registration  
 1347 expiration month. Fees paid under this subsection shall not be refunded unless a full refund of the  
 1348 registration fee paid is authorized by law.

1349 C. All taxes and fees paid under the provisions of this chapter shall be credited to the Highway  
 1350 Maintenance and Operating Fund, a special fund within the Commonwealth Transportation Fund.

1351 2. That §§ 46.2-696, 46.2-2084, 46.2-2097, 46.2-2097.1, and 46.2-2099.6 of the Code of Virginia are

1352 repealed.
