A *BILL to authorize the issuance of special license plates bearing the legend IN REMEMBRANCE, APRIL 16, 2007.*

Be it enacted by the General Assembly of Virginia:

1. *§ 1. Special license plates bearing the legend IN REMEMBRANCE, APRIL 16, 2007; fees.*

A. *On receipt of an application and payment of the fee prescribed by this section, and following the provisions of § 46.2-725 of the Code of Virginia other than those relating to the fee for the plates and its disposition, the Commissioner of the Department of Motor Vehicles shall issue to the applicant special license plates bearing the legend IN REMEMBRANCE, APRIL 16, 2007.*

B. *The annual fee for plates issued pursuant to this section shall be \$25 in addition to the prescribed fee for state license plates. For each such \$25 fee collected in excess of 1,000 registrations pursuant to this section, \$15 shall be paid into the state treasury and credited to a special nonreverting fund known as the VTV Family Outreach Foundation Fund established within the Department of Accounts. These funds shall be paid annually to the VTV Family Outreach Foundation and used to support its operation and programs in Virginia, such as (i) providing services, solace, and assistance to victims and their families impacted by campus tragedy; (ii) creating programs to secure and make safe colleges in the Commonwealth, including, but not limited to, research, anti-bullying programs, education, and programs to address at-risk youth and young adults; and (iii) creating a living legacy for all those who died on April 16, 2007, in the tragedy on the Virginia Tech campus. All other fees imposed under the provisions of this section shall be paid to and received by the Commissioner of the Department of Motor Vehicles and paid by him into the state treasury and set aside as a special fund to be used to meet the necessary expenses incurred by the Department of Motor Vehicles.*
