10104329D **SENATE JOINT RESOLUTION NO. 15** 1 AMENDMENT IN THE NATURE OF A SUBSTITUTE 2 3 4 5 6 (Proposed by the Senate Committee on Privileges and Elections on January 19, 2010) (Patron Prior to Substitute—Senator Martin) Proposing an amendment to Section 8 of Article II of the Constitution of Virginia, relating to electoral 7 boards, registrars, and officers of election. 8 RESOLVED by the Senate, the House of Delegates concurring, a majority of the members elected to 9 each house agreeing, That the following amendment to the Constitution of Virginia be, and the same 10 hereby is, proposed and referred to the General Assembly at its first regular session held after the next general election of members of the House of Delegates for its concurrence in conformity with the 11 provisions of Section 1 of Article XII of the Constitution of Virginia, namely: 12 Amend Section 8 of Article II of the Constitution of Virginia as follows: 13 14 ARTICLE II FRANCHISE AND OFFICERS 15 Section 8. Electoral boards; registrars and officers of election. 16 There shall be in each county and city an electoral board composed of three members, selected as 17 provided by law. In the appointment of the electoral boards, representation, as far as practicable, shall be 18 19 given to each of the two political parties which, at the general election next preceding their appointment, 20 cast the highest and the next highest number of votes. The present members of such boards shall 21 continue in office until the expiration of their respective terms; thereafter their successors shall be 22 appointed for the term of three years. Any vacancy occurring in any board shall be filled by the same 23 authority for the unexpired term. 24 The General Assembly may provide for county or city electoral boards or general registrars or 25 methods of their selection, including permission for two or more units of government to share the electoral boards or general registrars required by this section, provided that such units have agreed to 26 27 share clerks of the court in accordance with Article VII, Section 4 of this Constitution, without regard to 28 the provisions of this section, either (1) by general law to become effective in a county or city when 29 submitted to the qualified voters thereof in an election held for such purpose and approved by a 30 majority of those voting therein in each such county or city or (2) by special act upon the request, made after such an election, of each county or city affected. No such law shall reduce the term of any person 31 32 holding an office at the time the election is held. 33 Each electoral board shall appoint the officers of election and general registrar for its county or city. 34 In appointing such officers of election, representation, as far as practicable, shall be given to each of the 35 two political parties which, at the general election next preceding their appointment, cast the highest and 36 next highest number of votes. 37 No person, nor the deputy of any person, who is employed by or holds any office or post of profit 38 or emolument, or who holds any elective office of profit or trust, under the governments of the United 39 States, the Commonwealth, or any county, city, or town, shall be appointed a member of the electoral

No person, nor the deputy or the employee of any person, who holds any elective office of profit or trust under the government of the United States, the Commonwealth, or any county, city, or town of the Commonwealth, shall be appointed an assistant registrar or officer of
