SENATE JOINT RESOLUTION NO. 431

Commending Boston Properties.

WHEREAS, Boston Properties was honored by the Greater Reston Chamber of Commerce and Reston Interfaith, Inc., with a prestigious 2011 Best of Reston Award; and

WHEREAS, the Best of Reston Awards were established to recognize individuals, businesses, and organizations that have demonstrated a strong commitment to serving the greater Reston community and improving the lives of others; and

WHEREAS, a premier national developer and leading builder in Reston and Reston Town Center, Boston Properties sets an excellent example of how a corporation can successfully integrate community stewardship into its corporate culture; and

WHEREAS, Boston Properties' commitment to quality signature design has contributed to the vitality and economic health of Reston; its development philosophy goes beyond traditional bricks and mortar to efforts that enhance the quality of life for all who live and work in and visit the Reston community; and

WHEREAS, Boston Properties believes that its corporate success is an opportunity for the company and its employees to give back to the community and advance civic participation, a corporate philosophy embraced by employees at all levels of the organization; and

WHEREAS, this commitment is seen in Boston Properties' leadership role in advancing the organization of the Western Alliance for Rail to Dulles and gaining landowners' support for the complex legal and financial issues that would bring the Metro to the region; and
