WHEREAS, DeAngelo Eugene Hall, a native of Chesapeake, and outstanding cornerback for the Washington Redskins, was selected as the 2011 Pro Bowl Most Valuable Player; and

8 WHEREAS, as a young man, DeAngelo Hall developed a strong love for the game of football and 9 after playing at Deep Creek High School, went on to play at Virginia Tech, where he was named to the First Team All-American; and 10

WHEREAS, drafted eighth overall in the 2004 National Football League (NFL) Draft, DeAngelo 11 12 Hall began his professional career playing for the Atlanta Falcons; after playing briefly for the Oakland 13 Raiders, DeAngelo Hall is now a formidable force for the Washington Redskins; and

14 WHEREAS, one of the NFL's top players, DeAngelo Hall was selected to the Pro Bowl in his first year of professional play; in week seven of the 2010 football season, he tied an NFL record with four 15 16 interceptions in one game; and

WHEREAS, one of only 19 players in the history of the NFL to intercept four passes in a game, 17 DeAngelo Hall will have his jersey inducted into the Pro Football Hall of Fame for his extraordinary 18 19 accomplishment: and

20 WHEREAS, in the 2011 Pro Bowl held in the beautiful state of Hawaii, DeAngelo Hall was named 21 the Most Valuable Player for his interception and 34-yard fumble return for a touchdown that helped the 22 National Football Conference defeat the American Football Conference, 55-41; and

23 WHEREAS, a man of character with a compassionate heart, DeAngelo Hall has used the resources 24 and public attention he has garnered as a professional football player to support numerous worthy 25 organizations; and

WHEREAS, as a young man, DeAngelo Hall and his family faced great tragedy with limited 26 27 resources when his older brother, Kevin, died a violent death; and

28 WHEREAS, determined to make a difference and help other families who have had to deal with the 29 results of violence, DeAngelo Hall established the DeAngelo Hall Foundation with the goal of 30 decreasing youth violence and aiding families and survivors of violent crimes; and

31 WHEREAS, the DeAngelo Hall Foundation helps youth avoid violence through the support of 32 self-empowerment and anti-violence programs; and 33

WHEREAS, DeAngelo Hall is a devoted husband and father of four; and

34 WHEREAS, a man of remarkable accomplishment, DeAngelo Hall has been supported in his professional football career and community service efforts by his incredible and inspiring mother, Joan 35 36 Hall, and his family; now, therefore, be it

37 RESOLVED by the Senate, the House of Delegates concurring, That the General Assembly 38 commend DeAngelo Eugene Hall on his selection as the 2011 Pro Bowl Most Valuable Player; and, be 39 it
