10	Be it enacted by the General Assembly of Virginia:
11	1. That § 53.1-231.2 of the Code of Virginia is amended and reenacted as follows:
12	§ 53.1-231.2. Restoration of the civil right to be eligible to register to vote to certain persons.
13	This section shall apply to any person who is not a qualified voter because of a felony conviction,
14	who seeks to have his right to register to vote restored and become eligible to register to vote, and who
15	meets the conditions and requirements set out in this section.
16	Any person who is not a qualified voter because of a felony conviction, other than a person (i)
17	convicted of a violent felony as defined in § 19.2-297.1 or in subsection C of § 17.1-805 and any crime
18	ancillary thereto, or (ii) convicted of a felony pursuant to §§ 18.2-248, 18.2-248.01, 18.2-248.1,
19	18.2-255, 18.2-255.2 or § 18.2-258.02, or (iii) convicted of a felony pursuant to § 24.2-1016, may
20	petition the circuit court of the county or city in which he was convicted of a felony, or the circuit court
21	of the county or city in which he presently resides, for restoration of shall have his civil right to be
22	eligible to register to vote through the process set out in this section. On such petition, the court may
23	approve the petition for restoration to the person of his right if the court is satisfied from the evidence
24	presented that the petitioner has completed, five or more years previously, service automatically restored
25	upon the completion of any sentence and any modification of sentence including probation, parole, and
26	suspension of sentence; that the petitioner has demonstrated eivic responsibility through community or
27	comparable service; and that the petitioner has been free from criminal convictions, excluding traffic
28	infractions, for the same period, and the payment in full of any restitution, fines, costs, and fees assessed
29 20	against the person as a result of the felony conviction.
30	If the court approves the petition, it shall so state in an order, provide a copy of the order to the
31	petitioner, and transmit its order to the Secretary of the Commonwealth. The order shall state that the
32	petitioner's right to be eligible to register to vote may be restored by the date that is 90 days after the
33	date of the order, subject to the approval or denial of restoration of that right by the Governor. The
34 25	Secretary of the Commonwealth shall transmit the order to the Governor who may grant or deny the
35	petition for restoration of the right to be eligible to register to vote approved by the court order. The
36	Secretary of the Commonwealth shall send, within 90 days of the date of the order, to the petitioner at the address stated on the court's order, a certificate of restoration of that right or notice that the
