7 Be it enacted by the General Assembly of Virginia:

That § 2.2-4002 of the Code of Virginia is amended and reenacted and that the Code of 8 1. 9 Virginia is amended by adding in Article 2.3 of Chapter 32 of Title 58.1 a section numbered 10 58.1-3219.7 as follows: 11

§ 2.2-4002. Exemptions from chapter generally.

12 A. Although required to comply with § 2.2-4103 of the Virginia Register Act (§ 2.2-4100 et seq.), the following agencies shall be exempted from the provisions of this chapter, except to the extent that they are specifically made subject to §§ 2.2-4024, 2.2-4030 and 2.2-4031: 13 14

15 1. The General Assembly.

16 2. Courts, any agency of the Supreme Court, and any agency that by the Constitution is expressly 17 granted any of the powers of a court of record.

3. The Department of Game and Inland Fisheries in promulgating regulations regarding the 18 19 management of wildlife and for all case decisions rendered pursuant to any provisions of Chapters 2 20 (§ 29.1-200 et seq.), 3 (§ 29.1-300 et seq.), 4 (§ 29.1-400 et seq.), 5 (§ 29.1-500 et seq.), and 7 (§ 29.1-700 et seq.) of Title 29.1. 21 22

4. The Virginia Housing Development Authority.

23 5. Municipal corporations, counties, and all local, regional or multijurisdictional authorities created 24 under this Code, including those with federal authorities.

25 6. Educational institutions operated by the Commonwealth, provided that, with respect to § 2.2-4031, 26 such educational institutions shall be exempt from the publication requirements only with respect to 27 regulations that pertain to (i) their academic affairs, (ii) the selection, tenure, promotion and disciplining 28 of faculty and employees, (iii) the selection of students, and (iv) rules of conduct and disciplining of 29 students.

30 7. The Milk Commission in promulgating regulations regarding (i) producers' licenses and bases, (ii) 31 classification and allocation of milk, computation of sales and shrinkage, and (iii) class prices for producers' milk, time and method of payment, butterfat testing and differential. 32 33

8. The Virginia Resources Authority.

9. Agencies expressly exempted by any other provision of this Code.

35 10. The Department of General Services in promulgating standards for the inspection of buildings for 36 asbestos pursuant to § 2.2-1164.

37 11. The State Council of Higher Education for Virginia, in developing, issuing, and revising 38 guidelines pursuant to § 23-9.6:2.

39 12. The Commissioner of Agriculture and Consumer Services in adopting regulations pursuant to 40 subsection B of § 3.2-6002 and in adopting regulations pursuant to § 3.2-6023.

41 13. The Commissioner of Agriculture and Consumer Services and the Board of Agriculture and 42 Consumer Services in promulgating regulations pursuant to subsections B and D of § 3.2-3601, 43 subsection B of § 3.2-3701, § 3.2-4002, subsections B and D of § 3.2-4801, §§ 3.2-5121 and 3.2-5206, 44 and subsection A of § 3.2-5406.

45 14. The Board of Optometry when specifying therapeutic pharmaceutical agents, treatment guidelines, and diseases and abnormal conditions of the human eye and its adnexa for TPA-certification of 46 optometrists pursuant to Article 5 (§ 54.1-3222 et seq.) of Chapter 32 of Title 54.1. 47

15. The Virginia War Memorial Foundation. **48**

49 16. The State Board of Education, in developing, issuing, and revising guidelines pursuant to 50 § 22.1-203.2.

17. The Virginia Racing Commission, (i) when acting by and through its duly appointed stewards or 51 in matters related to any specific race meeting or (ii) in promulgating technical rules regulating actual 52 53 live horse racing at race meetings licensed by the Commission.

- 55 19. The Virginia Economic Development Partnership Authority.
- 56 20. The Board of Agriculture and Consumer Services in adopting, amending or repealing regulations

21. The Insurance Continuing Education Board pursuant to § 38.2-1867.

59 22. The Board of Health in promulgating the list of diseases that shall be reported to the Department 60 of Health pursuant to § 32.1-35 and in adopting, amending or repealing regulations pursuant to 61 subsection C of § 35.1-14 that incorporate the Food and Drug Administration's Food Code pertaining to 62 restaurants or food service.

63 23. (Expires January 1, 2014) The Secretary of Natural Resources in setting a date of closure for the 64 Chesapeake Bay purse seine fishery for Atlantic menhaden for reduction purposes pursuant to 65 § 28.2-1000.2.

66 24. The Board of Pharmacy when specifying special subject requirements for continuing education 67 for pharmacists pursuant to § 54.1-3314.1.

68 25. The Virginia Department of Veterans Services when promulgating rules and regulations pursuant 69 to § 58.1-3219.7.

70 B. Agency action relating to the following subjects shall be exempted from the provisions of this 71 chapter: 72

- 1. Money or damage claims against the Commonwealth or agencies thereof.
- 2. The award or denial of state contracts, as well as decisions regarding compliance therewith.
- 74 3. The location, design, specifications or construction of public buildings or other facilities.
- 75 4. Grants of state or federal funds or property.
- 76 5. The chartering of corporations.

77 6. Customary military, militia, naval or police functions.

78 7. The selection, tenure, dismissal, direction or control of any officer or employee of an agency of 79 the Commonwealth.

- 80 8. The conduct of elections or eligibility to vote. 81
 - 9. Inmates of prisons or other such facilities or parolees therefrom.
- 10. The custody of persons in, or sought to be placed in, mental, penal or other state institutions as 82 83 well as the treatment, supervision, or discharge of such persons.
- 84 11. Traffic signs, markers or control devices.
- 85 12. Instructions for application or renewal of a license, certificate, or registration required by law.
- 86 13. Content of, or rules for the conduct of, any examination required by law.
- 14. The administration of pools authorized by Chapter 47 (§ 2.2-4700 et seq.) of this title. 87

88 15. Any rules for the conduct of specific lottery games, so long as such rules are not inconsistent 89 with duly adopted regulations of the State Lottery Board, and provided that such regulations are 90 published and posted.

91 16. Orders condemning or closing any shellfish, finfish, or crustacea growing area and the shellfish, 92 finfish or crustacea located thereon pursuant to Article 2 (§ 28.2-803 et seq.) of Chapter 8 of Title 28.2.

93 17. Any operating procedures for review of child deaths developed by the State Child Fatality 94 Review Team pursuant to § 32.1-283.1.

95 18. The regulations for the implementation of the Health Practitioners' Monitoring Program and the activities of the Health Practitioners' Monitoring Program Committee pursuant to Chapter 25.1 96 97 (§ 54.1-2515 et seq.) of Title 54.1.

98 19. The process of reviewing and ranking grant applications submitted to the Commonwealth Neurotrauma Initiative Advisory Board pursuant to Chapter 3.1 (§ 51.5-12.1 et seq.) of Title 51.5. 99

- 20. Loans from the Small Business Environmental Compliance Assistance Fund pursuant to Article 4 100 (§ 10.1-1197.1 et seq.) of Chapter 11.1 of Title 10.1. 101
- 102 21. The Virginia Breeders Fund created pursuant to § 59.1-372.
- 103 22. The types of pari-mutuel wagering pools available for live or simulcast horse racing.

104 23. The administration of medication or other substances foreign to the natural horse.

105 C. Minor changes to regulations published in the Virginia Administrative Code under the Virginia Register Act, Chapter 41 (§ 2.2-4100 et seq.) of this title, made by the Virginia Code Commission 106 pursuant to § 30-150, shall be exempt from the provisions of this chapter. 107

§ 58.1-3219.7. Commissioner of the Department of Veterans Services; rules and regulations; appeal.

108 109 A. The Commissioner of the Department of Veterans Services shall promulgate rules and regulations 110 governing the administration and implementation of the property tax exemption under this article. Such rules and regulations shall include, but not be limited to, written guidance for veterans residing in the 111 112 Commonwealth and for commissioners of the revenue or other assessing officers relating to the determination of eligibility for the property tax exemption under this article and procedures for 113 appealing a decision of the Commissioner of the Department of Veterans Services to a circuit court 114 pursuant to subsection B. The Commissioner of the Department of Veterans Services may also provide 115 written guidance to, and respond to requests for information from, veterans residing in the 116

Commonwealth and commissioners of the revenue or other assessing officers regarding the exemption 117

118 under this article, including interpretation of the provisions of Article X, Section 6-A of the Constitution **119** of Virginia and this article.

B. The Commissioner of the Department of Veterans Services shall hear and decide appeals by veterans residing in the Commonwealth from a denial of their application pursuant to § 58.1-3219.6 by a commissioner of the revenue or other assessing officer. However, such appeal shall be limited to appeals based upon a finding of fact regarding eligibility criteria set forth in Article X, Section 6-A of

124 the Constitution of Virginia and this article. The Commissioner of the Department of Veterans Services 125 shall not be authorized to hear or decide appeals regarding a dispute over the assessed value of any

126 property. Nothing in this section shall be construed to limit the appeal of a decision of the

127 Commissioner of the Department of Veterans Services by either party to the circuit court in the locality

128 in which the veteran resides.

129 2. That an emergency exists and this act is in force from its passage.
