10	Be it enacted by the General Assembly of Virginia:
11	1. That §§ 2.2-1401 and 2.2-4310 of the Code of Virginia are amended and reenacted as follows:
12	§ 2.2-1401. Definitions.
13	As used in this chapter unless the context requires a different meaning:
14	"Certification" means the process by which a business is determined to be a small, women-owned, or
15	minority-owned business for the purpose of reporting small, women-owned, and minority-owned
16 17	business participation in state contracts and purchases pursuant to §§ 2.2-1404 and 2.2-1405. "Minority individual" means an individual who is a citizen of the United States or a legal resident
18	alien and who satisfies one or more of the following definitions:
10 19	1. "African American" means a person having origins in any of the original peoples of Africa and
20	who is regarded as such by the community of which this person claims to be a part.
21	2. "Asian American" means a person having origins in any of the original peoples of the Far East,

43	as defined in the federal Small Business Act (15 U.S.C. § 631 et seq.), as amended, and relevant
44	regulations promulgated thereto. A business shall be deemed to be located in Virginia if the business
45	has been organized pursuant to Virginia law or maintains a principal place of business within Virginia.
46 47	"State agency" means any authority, board, department, instrumentality, institution, agency, or other unit of state government. "State agency" shall not include any county, city, or town.
48	"Women-owned business" means a business that is at least 51% 51 percent owned by one or more
49	women who are U.S. citizens or legal resident aliens, or in the case of a corporation, partnership, or
50	limited liability company or other entity, at least 51% 51 percent of the equity ownership interest is
51	owned by one or more women who are citizens of the United States or legal resident aliens, and both
52	the management and daily business operations are controlled by one or more women.
53	§ 2.2-4310. Discrimination prohibited; participation of small, women-owned, minority-owned, and
54	service disabled veteran-owned business.
55 56	A. In the solicitation or awarding of contracts, no public body shall discriminate against a bidder or
50 57	offeror because of race, religion, color, sex, national origin, age, disability, status as a service disabled veteran, or any other basis prohibited by state law relating to discrimination in employment. Whenever
58	solicitations are made, each public body shall include businesses selected from a list made available by

59 the Department of Minority Business Enterprise.

60 B. All public bodies shall establish programs consistent with this chapter to facilitate the participation of small businesses and businesses owned by women, minorities, and service disabled veterans in 61 62 procurement transactions. The programs established shall be in writing and shall comply with the 63 provisions of any enhancement or remedial measures authorized by the Governor pursuant to subsection 64 C or, where applicable, by the chief executive of a local governing body pursuant to § 15.2-965.1, and 65 shall include specific plans to achieve any goals established therein. State agencies shall submit annual progress reports on small, women-women-owned, and minority-owned business procurement and on 66 service disabled veteran-owned business procurement to the Department of Minority Business Enterprise 67 in a form specified by the Department of Minority Business Enterprise. The Department of Minority 68 69 Business Enterprise shall make information on service disabled veteran-owned procurement available to 70 the Department of Veterans Services upon request.

C. Whenever there exists (i) a rational basis for small business enhancement or (ii) a persuasive 71 analysis that documents a statistically significant disparity between the availability and utilization of 72 women- women-owned and minority-owned businesses, the Governor is authorized and encouraged to 73 74 require state agencies to implement appropriate enhancement or remedial measures consistent with 75 prevailing law.

D. In the solicitation or awarding of contracts, no state agency, department or institution shall 76 77 discriminate against a bidder or offeror because the bidder or offeror employs ex-offenders unless the 78 state agency, department or institution has made a written determination that employing ex-offenders on 79 the specific contract is not in its best interest. 80

E. As used in this section:

81 "Minority individual" means an individual who is a citizen of the United States or a legal resident 82 alien and who satisfies one or more of the following definitions:

83 1. "African American" means a person having origins in any of the original peoples of Africa and who is regarded as such by the community of which this person claims to be a part. 84

85 2. "Asian American" means a person having origins in any of the original peoples of the Far East, Southeast Asia, the Indian subcontinent, or the Pacific Islands, including but not limited to Japan, China, 86 87 Vietnam, Samoa, Laos, Cambodia, Taiwan, Northern Mariana, the Philippines, a U.S. territory of the 88 Pacific, India, Pakistan, Bangladesh, or Sri Lanka and who is regarded as such by the community of 89 which this person claims to be a part.

"Minority-owned business" means a business that is at least 51% 51 percent owned by one or more 96 97 minority individuals who are U.S. citizens or legal resident aliens, or in the case of a corporation, 98 partnership, or limited liability company or other entity, at least 51% 51 percent of the equity ownership 99 interest in the corporation, partnership, or limited liability company or other entity is owned by one or 100 more minority individuals who are U.S. citizens or legal resident aliens, and both the management and 101 daily business operations are controlled by one or more minority individuals.

102 "Service disabled veteran" means a veteran who (i) served on active duty in the United States military ground, naval, or air service, (ii) was discharged or released under conditions other than 103 dishonorable, and (iii) has a service-connected disability rating fixed by the United States Department of 104 105 Veterans Affairs.

"Service disabled veteran business" means a business that is at least 51% 51 percent owned by one 106 107 or more service disabled veterans or, in the case of a corporation, partnership, or limited liability 108 company or other entity, at least 51% 51 percent of the equity ownership interest in the corporation, partnership, or limited liability company or other entity is owned by one or more individuals who are 109 110 service disabled veterans and both the management and daily business operations are controlled by one 111 or more individuals who are service disabled veterans.

"Small business" means a business independently owned and controlled by one or more individuals 112 113 who are U.S. citizens or legal resident aliens, and together with affiliates, has 250 or fewer employees, or annual gross receipts of \$10 million or less averaged over the previous three years. One or more of 114 the individual owners shall control both the management and daily business operations of the small 115 business located in Virginia that meets the definition of a small business concern as defined in the 116 federal Small Business Act (15 U.S.C. § 631 et seq.), as amended, and relevant regulations promulgated thereto. A business shall be deemed to be located in Virginia if the business has been organized 117 118 119 pursuant to Virginia law or maintains a principal place of business within Virginia.

"State agency" means any authority, board, department, instrumentality, institution, agency, or other 120
