2 3 4 5 6 A BILL to amend the Code of Virginia by adding in Chapter 1 of Title 54.1 a section numbered 7 54.1-118, relating to professions and occupations; expediting the issuance of licenses and the 8 issuance of temporary licenses for spouses of military service members.

9 Be it enacted by the General Assembly of Virginia:

1. That the Code of Virginia is amended by adding in Chapter 1 of Title 54.1 a section numbered 10 11 54.1-118 as follows:

12 § 54.1-118. Expediting the issuance of licenses, etc., to spouses of military service members; issuance 13 of temporary licenses, etc.

14 A. Notwithstanding any other law to the contrary and unless an applicant is found by the board to 15 have engaged in any act that would constitute grounds for disciplinary action, a regulatory board within the Department of Professional and Occupational Regulation or the Department of Health Professions 16 17 or any other board named in this title shall expedite the issuance of a license, permit, certificate, or other document, however styled or denominated, required for the practice of any business, profession, or 18 occupation in the Commonwealth to an applicant whose application has been deemed complete by the 19 20 board and (i) who holds the same or similar license, permit, certificate, or other document required for 21 the practice of any business, profession, or occupation issued by another jurisdiction; (ii) whose spouse is the subject of a military transfer to the Commonwealth; and (iii) who left employment to accompany 22 23 the applicant's spouse to Virginia, if, in the opinion of the board, the requirements for the issuance of 24 the license, permit, certificate, or other document in such other jurisdiction are substantially equivalent 25 to those required in the Commonwealth.

26 B. If a board is unable to (i) complete the review of the documentation provided by the applicant or 27 (ii) make a final determination regarding substantial equivalency within 30 days of the receipt of a completed application, the board shall issue a temporary license, permit, or certificate, provided the 28 29 applicant otherwise meets the qualifications set out in subsection A. Any temporary license, permit, or 30 certification issued pursuant to this subsection shall be limited for a period not to exceed six months 31 and shall authorize the applicant to engage in the profession or occupation while the board completes its review of the documentation provided by the applicant or the applicant completes any specific 32 33 requirements that may be required in Virginia that were not required in the jurisdiction in which the 34 applicant holds the license, permit, or certificate. 35

C. The provisions of this section shall apply regardless of whether a regulatory board has entered 36 into a reciprocal agreement with the other jurisdiction pursuant to subsection B of § 54.1-103.

37 D. Any regulatory board may require the applicant to provide documentation it deems necessary to 38 make a determination of substantial equivalency.

39 2. That the provisions of this act shall become effective on July 1, 2012, except that the provisions 40 of subsection B of § 54.1-118 added in this act establishing the requirement to issue a temporary 41 license, permit, or certification shall become effective on July 1, 2014.
