| 12 | limited to domestic relations matters, traffic infraction cases, and criminal cases (except cases involving |
| 13 | the death penalty), as well as appeals from the decisions of administrative agencies; and |
| 14 | WHEREAS, the Court of Appeals of Virginia has extensively developed the case law concerning |
| 15 | matters within the ambit of its appellate jurisdiction during its 27-year existence [; and WILEPEAS in mits of the court of Annuals of Virginia, the court of the Sugram. |
| 16 | WHEREAS, in spite of the creation of the Court of Appeals of Virginia, the caseload of the Supreme |
| 17 18 | Court of Virginia continues to preclude it from granting petitions for appeals in many cases in which appellate review is sought]; now, therefore, be it |

| $\bar{23}$ | the Court of Appeals of Virginia and whether the quality of appellate review would be served by |
| 24 | expanding that capacity. |
| 25 | Technical assistance shall be provided to the Judicial Council of Virginia by the Executive Secretary |
| 26 | of the Supreme Court of Virginia. All agencies of the Commonwealth shall provide assistance to the |
| 27 | Judicial Council of Virginia for this study, upon request. |
| 28 | The Judicial Council of Virginia shall complete its meetings for the first year by November 30, |
