 management analyst with the United States General Accounting Office, including 17 years as an
 assistant director; and

WHEREAS, Fred Yohey brought a wealth of community service experience to the Town of
Dumfries, having previously served as chair of the Town of Dumfries Board of Zoning Appeals,
member and chair of the Prince William-Manassas Regional Jail Board, and executive vice president of
the Potomac Senior High School Athletic Boosters Club; and
