That § 2.2-4301 of the Code of Virginia is amended and reenacted as follows: 11 § 2.2-4301. Definitions. 12 13 As used in this chapter: 14 "Affiliate" means an individual or business that controls, is controlled by, or is under common 15 control with another individual or business. A person controls an entity if the person owns, directly or 16 indirectly, more than 10 percent of the voting securities of the entity. For the purposes of this definition "voting security" means a security that (i) confers upon the holder the right to vote for the election of 17 members of the board of directors or similar governing body of the business or (ii) is convertible into, 18 19 or entitles the holder to receive, upon its exercise, a security that confers such a right to vote. A general 20 partnership interest shall be deemed to be a voting security. 21 "Best value," as predetermined in the solicitation, means the overall combination of quality, price, 22 and various elements of required services that in total are optimal relative to a public body's needs. 23 "Business" means any type of corporation, partnership, limited liability company, association, or sole 24 proprietorship operated for profit. 25 'Competitive negotiation" is a method of contractor selection that includes the following elements: 26 1. Issuance of a written Request for Proposal indicating in general terms that which is sought to be 27 procured, specifying the factors that will be used in evaluating the proposal and containing or 28 incorporating by reference the other applicable contractual terms and conditions, including any unique 29 capabilities or qualifications that will be required of the contractor. 30 2. Public notice of the Request for Proposal at least 10 days prior to the date set for receipt of 31 proposals by posting on the Department of General Services' central electronic procurement website or other appropriate websites. Additionally, public bodies shall publish in a newspaper of general circulation in the area in which the contract is to be performed so as to provide reasonable notice to the 32 33 34 maximum number of offerors that can be reasonably anticipated to submit proposals in response to the 35 particular request. Posting on the Department of General Services' central electronic procurement website 36 shall be required of any state public body. Local public bodies are encouraged to utilize the Department 37 of General Services' central electronic procurement website to provide the public with centralized visibility and access to the Commonwealth's procurement opportunities. In addition, proposals may be 38 39 solicited directly from potential contractors. 40 3. a. Procurement of professional services. The public body shall engage in individual discussions 41 with two or more offerors deemed fully qualified, responsible and suitable on the basis of initial responses and with emphasis on professional competence, to provide the required services. Repetitive 42 informal interviews shall be permissible. The offerors shall be encouraged to elaborate on their 43 qualifications and performance data or staff expertise pertinent to the proposed project, as well as 44 alternative concepts. In addition, offerors shall be informed of any ranking criteria that will be used by 45 the public body in addition to the review of the professional competence of the offeror. The Request for 46 47 Proposal shall not, however, request that offerors furnish estimates of man-hours or cost for services. At the discussion stage, the public body may discuss nonbinding estimates of total project costs, including, 48 49 but not limited to, life-cycle costing, and where appropriate, nonbinding estimates of price for services. Proprietary information from competing offerors shall not be disclosed to the public or to competitors. 50 51 At the conclusion of discussion, outlined in this subdivision, on the basis of evaluation factors published 52 in the Request for Proposal and all information developed in the selection process to this point, the 53 public body shall select in the order of preference two or more offerors whose professional qualifications and proposed services are deemed most meritorious. Negotiations shall then be conducted, beginning 54 55 with the offeror ranked first. If a contract satisfactory and advantageous to the public body can be negotiated at a price considered fair and reasonable, the award shall be made to that offeror. Otherwise, 56 57 negotiations with the offeror ranked first shall be formally terminated and negotiations conducted with 58 the offeror ranked second, and so on until such a contract can be negotiated at a fair and reasonable

price. Notwithstanding the foregoing, if the terms and conditions for multiple awards are included in theRequest for Proposal, a public body may award contracts to more than one offeror.

61 Should the public body determine in writing and in its sole discretion that only one offeror is fully
62 qualified, or that one offeror is clearly more highly qualified and suitable than the others under
63 consideration, a contract may be negotiated and awarded to that offeror.

64 A contract for architectural or professional engineering services relating to construction projects may 65 be negotiated by a public body, for multiple projects provided (i) the projects require similar experience and expertise, (ii) the nature of the projects is clearly identified in the Request for Proposal, and (iii) the 66 contract term is limited to one year or when the cumulative total project fees reach the maximum cost 67 68 authorized in this paragraph, whichever occurs first. For state public bodies, such contract, except those 69 awarded for environmental, location, design and inspection work regarding highways and bridges by the Commissioner of Highways may be renewable for four additional one-year terms at the option of the 70 71 public body. For local public bodies, including metropolitan planning organizations or planning district commissions, such contract may be renewable for four additional one-year terms at the option of the 72 73 public body. Under such contract, (a) the fair and reasonable prices, as negotiated, shall be used in 74 determining the cost of each project performed, (b) except those awarded for environmental, location, 75 design and inspection work regarding highways and bridges by the Commissioner of Highways, the sum of all projects performed in one contract term shall not exceed \$500,000 \$1.5 million or, in the case of a 76 77 state agency, as defined in § 2.2-4347, such greater amount as may be determined by the Director of the 78 Department of General Services, not to exceed \$1 million, except that in any locality or any authority, 79 sanitation district, metropolitan planning organization or planning district commission with a population 80 in excess of 80,000, the sum of all such projects shall not exceed \$5 million; and (c) except those awarded for environmental, location, design and inspection work regarding highways and bridges by the 81 Commissioner of Highways or for architectural and engineering services for rail and public 82 transportation projects by the Director of the Department of Rail and Public Transportation, the project 83 fee of any single project shall not exceed \$100,000 [\$1.5 million \$200,000] or, in the case of a state 84 85 agency, such greater amount as may be determined by the Director of the Department of General Services not to exceed [\$200,000 \$400,000], except that in any locality or any authority or sanitation 86 district with a population in excess of 80,000, such fee shall not exceed \$1 \$2 million. Any unused 87 88 amounts from the first contract term shall not be carried forward to the additional term. Competitive 89 negotiations for such contracts may result in awards to more than one offeror provided (1) the Request 90 for Proposal so states and (2) the public body has established procedures for distributing multiple 91 projects among the selected contractors during the contract term. Notwithstanding any other provision in 92 this section, for contracts for environmental location, design and inspection work regarding highways 93 and bridges by the Commissioner of Highways, the initial contract term shall be limited to two years or when the cumulative total project fees reach \$5 million, whichever occurs first. Such contract may be 94 95 renewable for two additional one-year terms at the option of the Commissioner, and the sum of all 96 projects in each one-year term shall not exceed \$5 million. For architectural and engineering services for 97 rail and public transportation projects by the Director of the Department of Rail and Public 98 Transportation, the sum of all projects in one contract term shall not exceed \$2 million and such 99 contract may be renewable for two additional one-year terms at the option of the Commissioner.

100 Multiphase professional services contracts satisfactory and advantageous to the Department of 101 Transportation for environmental, location, design and inspection work regarding highways and bridges 102 may be negotiated and awarded based on a fair and reasonable price for the first phase only, when 103 completion of the earlier phases is necessary to provide information critical to the negotiation of a fair 104 and reasonable price for succeeding phases.

105 Multiphase professional services contracts satisfactory and advantageous to a local public body, 106 including metropolitan planning organizations and planning district commissions, for environmental, 107 location, design and inspection work regarding construction of infrastructure projects may be negotiated and awarded based on qualifications at a fair and reasonable price for the first phase only, when 108 109 completion of the earlier phases is necessary to provide information critical to the negotiation of a fair and reasonable price for succeeding phases. Prior to the procurement of any such contract, the local 110 public body shall state the anticipated intended total scope of the project and determine in writing that 111 the nature of the work is such that the best interests of such public body require awarding the contract. 112

113 b. Procurement of other than professional services. Selection shall be made of two or more offerors 114 deemed to be fully qualified and best suited among those submitting proposals, on the basis of the 115 factors involved in the Request for Proposal, including price if so stated in the Request for Proposal. Negotiations shall then be conducted with each of the offerors so selected. Price shall be considered, but 116 117 need not be the sole determining factor. After negotiations have been conducted with each offeror so selected, the public body shall select the offeror which, in its opinion, has made the best proposal, and 118 119 shall award the contract to that offeror. When the terms and conditions of multiple awards are so 120 provided in the Request for Proposal, awards may be made to more than one offeror. Should the public body determine in writing and in its sole discretion that only one offeror is fully qualified, or that oneofferor is clearly more highly qualified than the others under consideration, a contract may be negotiatedand awarded to that offeror.

"Competitive sealed bidding" is a method of contractor selection, other than for professional services,which includes the following elements:

126 1. Issuance of a written Invitation to Bid containing or incorporating by reference the specifications
127 and contractual terms and conditions applicable to the procurement. Unless the public body has provided
128 for prequalification of bidders, the Invitation to Bid shall include a statement of any requisite
129 qualifications of potential contractors. When it is impractical to prepare initially a purchase description
130 to support an award based on prices, an Invitation to Bid may be issued requesting the submission of
131 unpriced offers to be followed by an Invitation to Bid limited to those bidders whose offers have been
132 qualified under the criteria set forth in the first solicitation.

133 2. Public notice of the Invitation to Bid at least 10 days prior to the date set for receipt of bids by 134 posting on the Department of General Services' central electronic procurement website or other 135 appropriate websites. In addition, public bodies may publish in a newspaper of general circulation. 136 Posting on the Department of General Services' central electronic procurement website shall be required 137 of any state public body. Local public bodies are encouraged to utilize the Department of General 138 Services' central electronic procurement website to provide the public with centralized visibility and 139 access to the Commonwealth's procurement opportunities. In addition, bids may be solicited directly 140 from potential contractors. Any additional solicitations shall include businesses selected from a list made 141 available by the Department of Minority Business Enterprise.

142 3. Public opening and announcement of all bids received.

4. Evaluation of bids based upon the requirements set forth in the invitation, which may include
special qualifications of potential contractors, life-cycle costing, value analysis, and any other criteria
such as inspection, testing, quality, workmanship, delivery, and suitability for a particular purpose, which
are helpful in determining acceptability.

5. Award to the lowest responsive and responsible bidder. When the terms and conditions of multipleawards are so provided in the Invitation to Bid, awards may be made to more than one bidder.

"Construction" means building, altering, repairing, improving or demolishing any structure, buildingor highway, and any draining, dredging, excavation, grading or similar work upon real property.

"Construction management contract" means a contract in which a party is retained by the owner to
 coordinate and administer contracts for construction services for the benefit of the owner, and may also
 include, if provided in the contract, the furnishing of construction services to the owner.

154 "Design-build contract" means a contract between a public body and another party in which the party 155 contracting with the public body agrees to both design and build the structure, roadway or other item 156 specified in the contract.

157 "Goods" means all material, equipment, supplies, printing, and automated data processing hardware158 and software.

"Informality" means a minor defect or variation of a bid or proposal from the exact requirements of
the Invitation to Bid, or the Request for Proposal, which does not affect the price, quality, quantity or
delivery schedule for the goods, services or construction being procured.

"Multiphase professional services contract" means a contract for the providing of professional
services where the total scope of work of the second or subsequent phase of the contract cannot be
specified without the results of the first or prior phase of the contract.

165 "Nonprofessional services" means any services not specifically identified as professional services in166 the definition of professional services.

167 "Potential bidder or offeror" for the purposes of §§ 2.2-4360 and 2.2-4364 means a person who, at 168 the time a public body negotiates and awards or proposes to award a contract, is engaged in the sale or 169 lease of goods, or the sale of services, insurance or construction, of the type to be procured under the 170 contract, and who at such time is eligible and qualified in all respects to perform that contract, and who 171 would have been eligible and qualified to submit a bid or proposal had the contract been procured 172 through competitive sealed bidding or competitive negotiation.

173 "Professional services" means work performed by an independent contractor within the scope of the
174 practice of accounting, actuarial services, architecture, land surveying, landscape architecture, law,
175 dentistry, medicine, optometry, pharmacy or professional engineering. "Professional services" shall also
176 include the services of an economist procured by the State Corporation Commission.

"Public body" means any legislative, executive or judicial body, agency, office, department, authority,
post, commission, committee, institution, board or political subdivision created by law to exercise some
sovereign power or to perform some governmental duty, and empowered by law to undertake the
activities described in this chapter. "Public body" shall include any metropolitan planning organization or
planning district commission which operates exclusively within the Commonwealth of Virginia.

182 "Public contract" means an agreement between a public body and a nongovernmental source that is183 enforceable in a court of law.

184 "Responsible bidder" or "offeror" means a person who has the capability, in all respects, to perform
185 fully the contract requirements and the moral and business integrity and reliability that will assure good
186 faith performance, and who has been prequalified, if required.

187 "Responsive bidder" means a person who has submitted a bid that conforms in all material respects188 to the Invitation to Bid.

189 "Reverse auctioning" means a procurement method wherein bidders are invited to bid on specified 190 goods or nonprofessional services through real-time electronic bidding, with the award being made to 191 the lowest responsive and responsible bidder. During the bidding process, bidders' prices are revealed 192 and bidders shall have the opportunity to modify their bid prices for the duration of the time period 193 established for bid opening.

194 "Services" means any work performed by an independent contractor wherein the service rendered
195 does not consist primarily of acquisition of equipment or materials, or the rental of equipment, materials
196 and supplies.

197 "Sheltered workshop" means a work-oriented rehabilitative facility with a controlled working
198 environment and individual goals that utilizes work experience and related services for assisting the
199 handicapped person to progress toward normal living and a productive vocational status.
