9	Be it enacted by the General Assembly of Virginia:
10	1. That the Code of Virginia is amended by adding in Article 4 of Chapter 29 of Title 54.1
11	sections numbered 54.1-2957.16 through 54.1-2957.19 as follows:
12	§ 54.1-2957.16. Kinesiotherapist; definitions.
13	"Kinesiotherapist" means any person licensed by the Board to engage in the practice of
14 15	kinesiotherapy.
15 16	"Practice of kinesiotherapy" means that branch of the healing arts that is concerned with, upon medical referral and direction, the application of scientifically based exercise principles adapted to
17	enhance the strength, endurance, and mobility of individuals with functional limitations or those
18	requiring extended physical conditioning.
19	§ 54.1-2957.17. Unlawful to practice without a license.
20	A. It shall be unlawful for any person to practice kinesiotherapy in the Commonwealth without a
21	valid unrevoked license issued by the Board.
22	B. The Board shall promulgate regulations establishing requirements to ensure continuing
23 24	competency of kinesiotherapists, which may include continuing education, testing, or such other requirements as the Board may determine to be necessary.
2 <del>4</del> 25	C. In promulgating continuing competency requirements, the Board shall consider (i) the need to
26	promote ethical practice, (ii) an appropriate standard of care, (iii) patient safety, (iv) application of new
27	medical technology, (v) appropriate communication with patients, and (vi) knowledge of the changing
28	health care system.
29 20	§ 54.1-2957.18. Requirements for licensure as a kinesiotherapist.
30 31	An applicant for licensure as a kinesiotherapist shall submit evidence, verified by affidavit and
31 32	satisfactory to the Board, that the applicant: 1. Is 18 years of age or older;
33	2. Is a graduate of a program of kinesiotherapy accredited by the Committee on Accreditation of
34	Allied Health Education Programs or is a graduate of a school outside of the United States or Canada
35	that is acceptable to the Board; and
36	3. Has satisfactorily passed an examination approved by the Board.
37 38	§ 54.1-2957.19. Unprofessional conduct of kinesiotherapists. Any kinesiotherapist licensed by the Board shall be considered guilty of unprofessional conduct if he:
30 39	1. Engages in the practice of kinesiotherapy under a false or assumed name or impersonates another
40	practitioner of a like, similar, or different name;
41	2. Knowingly and willfully commits any act that is a felony under the laws of the Commonwealth or
42	the United States, or any act that is a misdemeanor under such laws and involves moral turpitude;
43	3. Aids or abets, has professional contact with, or lends his name to any person known to him to be
44 45	<i>practicing kinesiotherapy illegally;</i> 4. Conducts his practice in such a manner as to be a danger to the health and welfare of his
<b>4</b> 5 <b>46</b>	<i>a.</i> Conducts his practice in such a manner as to be a danger to the health and weighte of his patients or to the public;
47	5. Is unable to practice with reasonable skill or safety because of illness or substance abuse;
<b>48</b>	6. Publishes in any manner an advertisement that violates Board regulations governing advertising;
<b>49</b>	7. Performs any act likely to deceive, defraud, or harm the public;
50 51	8. Violates any provision of statute or regulation, state or federal, relating to controlled substances;
51 52	9. Violates or cooperates with others in violating any of the provisions of this chapter or regulations of the Board; or
52 53	10. Engages in sexual contact with a patient concurrent with and by virtue of the practitioner/patient
54	relationship or otherwise engages at any time during the course of the practitioner/patient relationship
55	in conduct of a sexual nature that a reasonable patient would consider lewd and offensive.
