## VIRGINIA ACTS OF ASSEMBLY - CHAPTER

2 An Act to amend the Code of Virginia by adding a section numbered 58.1-332.2, relating to credits for 3 income taxes paid to other states or foreign countries.

### Approved

#### Be it enacted by the General Assembly of Virginia: 6 7

#### 1. That the Code of Virginia is amended by adding a section numbered 58.1-332.2 as follows: 8

§ 58.1-332.2. Definition of income tax.

9 A. For purposes of the credits in §§ 58.1-332 and 58.1-332.1, the term "income tax" is a term of art 10 that refers to a specific type of tax levied on earned and unearned income and shall not include any other type of tax merely because it may be measured by or referenced to gross or net income. An 11 12 income tax includes, but is not limited to, a tax imposed on all income of an individual if a resident, or all income of an individual from the jurisdiction's sources if a nonresident; however, an income tax so 13 14 imposed may incorporate other provisions that grant exemptions, exclusions, deductions, subtractions, 15 credits, or other preferences for specific types of income, expenses, individuals, or other criteria.

16 B. An income tax shall not include:

17 1. A tax conditioned upon the exercise of any franchise, privilege, or business within the jurisdiction 18 even though the tax is measured or based upon gross or net income derived therefrom, but such 19 measure does not include income that the person exercising such franchise, privilege, or business may 20 receive from other sources within the jurisdiction.

21 2. License and occupation taxes, which are payable in respect to the privilege of engaging in or 22 carrying on a particular business or vocation, even though the amount of tax payable by an individual 23 may be measured by the amount of business which he transacts or his earnings therefrom, but such 24 measure does not include income that the person engaging in or carrying on a particular business or 25 vocation may receive from other sources within the jurisdiction.

26 C. The credits in §§ 58.1-332 and 58.1-332.1 shall apply only when the tax imposed in the other 27 state or foreign country is substantially similar to the tax imposed by Article 2 (§ 58.1-320 et seq.), as 28 defined by this section. The nomenclature used to describe the tax of the other jurisdiction shall not be 29 binding on Virginia for this purpose whether such nomenclature is that of the other jurisdiction's legislature or courts or the United States Congress or courts. 30

2. That this act is effective for taxable years beginning on and after January 1, 2007. 31

3. That the provisions of this act are declaratory of existing law. 32

33 4. That an emergency exists and this act is in force from its passage. [S 681]
