6 WHEREAS, the Honorable Elmon Taylor Gray, a proud alumnus of Virginia Military Institute,
7 admired business leader, noted philanthropist, and former member of the Senate of Virginia, entered into
8 eternal rest on September 27, 2011; and

9 WHEREAS, Élmon Taylor Gray, born on May 1, 1925, attended Virginia Military Institute (VMI) in
10 the fall of 1942 and interrupted his studies in 1944 to join the United States Navy, serving on
11 minesweepers in the South Pacific; after distinguished service as an ensign, he was honorably discharged
12 in 1946, whereupon he returned to VMI and earned his undergraduate degree in 1947; and

WHEREAS, upon completion of his military service and education, Elmon Taylor Gray joined the
family's business, Gray Lumber Company, in Waverly; in 1992, as GrayCo, the company expanded from
timber and lumber into a diversified real estate holding company in which he served as president for
many years; at the time of his death he served as chairman; and

17 WHEREAS, Elmon Taylor Gray began his long illustrious career of public service to the
18 Commonwealth with his appointment to the Sussex County School Board in 1963; in 1971, Elmon
19 Taylor Gray was elected to the Senate of Virginia, occupying the seat that had been held by his father,
20 Senator Garland Gray, and ably represented the citizens of part of Chesterfield County and the Counties
21 of Prince George, Surry, and Sussex and the Cities of Colonial Heights, Hopewell, and Petersburg; and

WHEREAS, during his two decades of service in the Senate of Virginia, Elmon Taylor Gray, widely respected by colleagues of both parties, served with great passion and energy as a member of the Senate Committees on Commerce and Labor, Education and Health, Finance, Transportation, and Rules; and

WHEREAS, mindful of the importance of education to his own success, Elmon Taylor Gray
 championed many groundbreaking improvements in higher education through his vision and leadership
 while serving as the longtime chairman of the Senate Committee on Education and Health; and

28 WHEREAS, a highly regarded business leader, Elmon Taylor Gray brought his expertise in manufacturing and land development to the legislative process and is credited with helping to build and sustain the economy of Southside Virginia for over a generation; and

WHEREAS, during his legislative career, Elmon Taylor Gray was instrumental in the creation of the Virginia Horse Center in Lexington and the passage of legislation establishing Virginia's King holiday; he was active in efforts to build a horse racing track in Hampton Roads after the approval of pari-mutuel betting in 1987; he was an advocate for gasoline retailers and the trucking industry; and, nearing retirement from the Senate in 1992, he worked with colleagues to reconfigure his district, the 16th Senatorial District, which resulted in the election of the district's first African American senator; and

WHEREAS, a devoted alumnus, Elmon Taylor Gray was a generous philanthropist and stalwart supporter of VMI, raising millions for the school's endowment and supporting its longstanding educational mission; he served as president of the Board of Visitors from 1964 to 1966, as president of the VMI Alumni Association from 1971 to 1973; and as co-general chairman and one of the lead contributors of The VMI Campaign, the first capital campaign which lasted from 1978 to 1990, during which time many endowments were established to support the institution; and

WHEREAS, Elmon Taylor Gray was generous with his time, talents, and resources, and served as a
member of numerous organizations, including the boards of Universal Leaf Tobacco, Dominion
Resources, First & Merchants National Bank, and James River Bankshares, Ltd.; as trustee emeritus of
Elon University; as a trustee of the Virginia Historical Society, Historic Petersburg Foundation, and the
Jamestown-Yorktown Foundation, due to his great love of Virginia history; and

WHEREAS, his faithful devotion to Southside Virginia and genuine spirit of community service
earned Elmon Taylor Gray many accolades, awards, and recognition during his lifetime, among them the
Virginia Military Institute Foundation Distinguished Service Award in 1977; the New Market Medal in
1980—VMI's highest honor; the Virginia Military Institute Keydet Club's Spirit of VMI Award in 1991;
the Gray-Minor Stadium, named in his honor in 2007; and the Harry F. Byrd, Jr., '35 Public Service
Award in March 2009, in recognition of his outstanding service to the Commonwealth; and

55 WHEREAS, Elmon Taylor Gray took particular pride in the creation of the Appomattox Regional

56 Governor's School for the Arts and Technology in Petersburg, which continues to prepare talented and 57 skilled young thinkers and artists from the Southside area for advanced study; and

58 WHEREAS, in retirement, Elmon Taylor Gray continued his keen interest in politics and was 59 actively involved in the family business, including a land development project in eastern Henrico; and

60 WHEREAS, his family, friends, and colleagues will forever and lovingly treasure the many stories,61 bellowing laughter, and even the occasional scowl of the dapper gentleman from Waverly; and

WHEREAS, predeceased by his wife of 62 years, Pamela, Elmon Taylor Gray will be fondly
remembered and greatly missed by his children, Katharine, Garland, and Bruce, and their families; his
colleagues on both sides of the aisle; and the citizens of the Commonwealth; now, therefore, be it

RESOLVED by the Senate, the House of Delegates concurring, That the General Assembly hereby
 note with great sadness the loss of the Honorable Elmon Taylor Gray, former member of the Senate of
 Virginia; and, be it
