SENATE JOINT RESOLUTION NO. 248

Offered March 5, 2012

Celebrating the life of Dr. Samuel Alfred Madden, Sr.

6 WHEREAS, Dr. Samuel Alfred Madden, Sr., the third son of the Reverend Willie Jackson Madden
7 and Ida Wilhoite Madden, was born on October 9, 1911, in Culpeper, and departed this life on October
8 27, 2011; and

9 WHEREAS, Samuel Alfred Madden, Sr., attended Culpeper grade school and Hillside High School
10 in Durham, North Carolina; he earned the bachelor of arts degree at Virginia State University and the
11 master of arts and doctor of education degrees from Columbia University's Teachers College in New
12 York; and

WHEREAS, he began his teaching career in Culpeper in a one-room school donated to the
community by his grandfather, and Samuel Alfred Madden, Sr., taught adult education at the close of
the school day in the church pastored by his father; and

WHEREAS, Samuel Alfred Madden, Sr., devoted his entire life to educating others; he was a teacher
and supervisor of adult education for the Works Progress Administration (WPA), a New Deal agency
established to train and employ unskilled workers, serving also as an instructor for one of the agency's
literacy programs opened in Virginia; he became supervisor of adult education for the State Board of
Education; and

WHEREAS, three years after the Pearl Harbor attack by the Japanese on December 7, 1941, Samuel
Alfred Madden, Sr., was drafted into the United States Army, where he served for three years as a
non-commissioned plans and training officer in an Armed Forces Examining and Entrance Station during
World War II; and

WHEREAS, while in the United States Army, Samuel Alfred Madden, Sr., continued to teach,
 instructing newly drafted soldiers in basic literacy skills and mathematics, which enabled these soldiers
 to continue their training and enter active duty service; and

WHEREAS, after the end of his military service, Samuel Alfred Madden, Sr., became a member of
the faculty at Virginia State University, where he served as instructor and professor of education and as
director of the Division of Field Services, now the School of Continuing Education, from which he
retired as dean in 1978 and was awarded professor emeritus status; he continued to conduct summer
classes for Virginia's Eastern Shore teachers during his retirement; and

WHEREAS, Samuel Alfred Madden, Sr., received numerous awards and honors during his lifetime,
 among them the National University Continuing Education Association's Bittner Service Citation, the
 Jefferson Award of the American Institute for Public Service, the George F. Hixon Fellowship Award
 presented by the Petersburg Kiwanis Luncheon Club, and a resolution presented by the Chesterfield
 County Board of Supervisors in recognition of his 100th birthday; and

WHEREAS, Samuel Alfred Madden, Sr., gave liberally of his time, talents, and resources to cultural,
community, and professional organizations; he held offices in several social and professional
organizations, was a volunteer for the Salvation Army and Foster Grandparents program, assisted in the
founding of the Petersburg Symphony Orchestra and served as president of the board during the
orchestra's formative years; he was a member of the historic Gillfield Baptist Church, Alpha Phi Alpha
fraternity, Sigma Pi Phi fraternity, and the Petersburg Kiwanis Luncheon Club; and

44 WHÉREÁS, Samuel Alfred Madden, Sr., died "full of years"; his life is worthy of emulation and his 45 loved ones will treasure his memory and legacy; now, therefore, be it
