10	Be it enacted by the General Assembly of Virginia:
11	1. That § 33.1-346 of the Code of Virginia is amended and reenacted as follows:
12	§ 33.1-346. Dumping trash, companion animals, etc., on highway, right-of-way, or private
13	property; penalty.
14	A. It shall be unlawful for any person to dump or otherwise dispose of trash, garbage, refuse, litter,
15	cigarettes, a companion animal for the purpose of disposal, or other unsightly matter, on public
16	property, including a public highway, right-of-way, property adjacent to such highway or right-of-way,
17	or on private property without the written consent of the owner thereof or his agent. A violation of this
18	section is a Class 1 misdemeanor.
19 20	B. When any If a person is arrested for a violation of this section, and the matter alleged to have been illegally dumped or disposed of has been ejected from a motor vehicle or transported to the
20 21	disposal site in a motor vehicle, the arresting officer may comply with the provisions of § 46.2-936 in
21 22	making such arrest.
23	When a violation of the provisions of this section has been observed by any person, and the matter
23 24	illegally dumped or disposed of has been is ejected or removed from a motor vehicle, the owner or
25	operator of such motor vehicle shall be is rebuttably presumed to be the person ejecting or disposing of
26	such matter. However, such presumption shall be rebuttable by competent evidence.
27	C. Any person convicted of a violation of this section shall be guilty of a misdemeanor punishable
28	by confinement in jail for not more than 12 months and a fine of not less than \$250 or more than
29	\$2,500, either or both.
30	In lieu of the imposition of confinement in jail the criminal penalty in subsection A, the court may
31	order the defendant to perform community service in litter abatement activities, provided that if the
32	offense involves a cigarette or cigarettes, the court shall order the payment of a \$100 civil penalty
33	payable to the Litter Control and Recycling Fund established in § 10.1-1422.01 in addition to the
34	imposition of such community service.
35	D. The governing bodies of counties, cities and towns are hereby authorized to adopt ordinances not
36	in conflict with the provisions of this section, and may repeal, amend or modify such ordinances.
37	E. The provisions of this section shall not apply to the lawful disposal of such matter in landfills.
