6 **Be it enacted by the General Assembly of Virginia:**7 **1. That § 6.2-618 of the Code of Virginia is amended and reenacted as follows:**8 **§ 6.2-618. Identification of joint accounts.**9 A. Every financial institution in the Commonwealth offering joint accounts to its depositors shall
10 either:11 1. ~~Maintain~~ Use two separate forms for the creation of joint accounts, one of which shall be clearly
12 labeled "JOINT ACCOUNT WITH SURVIVORSHIP" and the other of which shall be clearly labeled
13 "JOINT ACCOUNT - NO SURVIVORSHIP," ~~both of which shall be made available to all~~ *provided that*
14 *a financial institution electing to use separate forms is not required to maintain both forms or make*
15 *both forms available to persons opening joint accounts and may, in its discretion, elect to make one or*
16 *both forms available to persons opening joint accounts; or*17 2. ~~Maintain~~ Use one form for the creation of such accounts that shall contain the two labels "JOINT
18 ACCOUNT WITH SURVIVORSHIP" and "JOINT ACCOUNT - NO SURVIVORSHIP," with
19 appropriate blank space or lines beside such labels for the parties to sign in order to indicate the type of
20 account desired, which signature requirement shall be in addition to any signature verification form.21 B. The forms provided for in subdivision A 1 may be identical in all respects except for the labels
22 therein specified. This section shall not be construed to prevent any financial institution from changing
23 from one method of identification to the other method of identification at any time, nor to require a
24 financial institution making such a change to make any changes to the forms of its existing accounts.25 C. The forms described in subsection A shall include disclosures to inform persons opening joint
26 accounts of the disposition of such accounts upon a party's death. Disclosures in a form substantially
27 similar to the following shall satisfy the requirements of this section:28 Joint Account With Survivorship - On the death of a party to the account, the deceased party's
29 ownership in the account passes to the surviving party or parties to the account.30 Joint Account - No Survivorship - On the death of a party to the account, the deceased party's
31 ownership in the account passes as a part of the party's estate under the party's will, trust, or by
32 intestacy.

33 D. This section is not applicable to joint accounts created before July 1, 1980.
