2 *An Act to amend and reenact § 19.2-13 of the Code of Virginia, relating to special conservators of the*
 3 *peace; museums of the Commonwealth.*

6 **Be it enacted by the General Assembly of Virginia:**7 **1. That § 19.2-13 of the Code of Virginia is amended and reenacted as follows:**8 **§ 19.2-13. Special conservators of the peace; authority; jurisdiction; registration; bond; liability**
 9 **of employers; penalty; report.**

10 A. Upon the application of (i) any sheriff or chief of police of any county, city, or town or; (ii) any
 11 corporation authorized to do business in the Commonwealth or; (iii) the owner, proprietor, or authorized
 12 custodian of any place within the Commonwealth; or (iv) any museum owned and managed by the
 13 Commonwealth, a circuit court judge of any county or city shall appoint special conservators of the
 14 peace who shall serve as such for such length of time as the court may designate, but not exceeding
 15 four years under any one appointment, upon a showing by the applicant of a necessity for the security
 16 of property or the peace and presentation of evidence that the person or persons to be appointed as a
 17 special conservator of the peace possess a valid registration issued by the Department of Criminal
 18 Justice Services in accordance with the provisions of subsection B. However, a judge may deny the
 19 appointment for good cause, and shall state the specific reasons for the denial in writing in the order
 20 denying the appointment. The order of appointment may provide that a special conservator of the peace
 21 shall have all the powers, functions, duties, responsibilities and authority of any other conservator of the
 22 peace within such geographical limitations as the court may deem appropriate within the confines of the
 23 county, city or town that makes application or within the county, city or town where the corporate
 24 applicant is located, limited, except as provided in subsection E, to the judicial circuit wherein
 25 application has been made, whenever such special conservator of the peace is engaged in the
 26 performance of his duties as such. The order may also provide that the special conservator of the peace
 27 is a "law-enforcement officer" for the purposes of Article 4 (§ 37.2-808 et seq.) of Chapter 8 of Title
 28 37.2; or Article 16 (§ 16.1-335 et seq.) of Chapter 11 of Title 16.1. The order may also provide that the
 29 special conservator of the peace is authorized to use the seal of the Commonwealth in a badge or other
 30 credential of office as the court may deem appropriate. The order may also provide that the special
 31 conservator of the peace may use the title "police" on any badge or uniform worn in the performance of
 32 his duties as such. The order may also provide that a special conservator of the peace who has
 33 completed the minimum training standards established by the Department of Criminal Justice Services,
 34 has the authority to affect arrests, using up to the same amount of force as would be allowed to a
 35 law-enforcement officer employed by the Commonwealth or any of its political subdivisions when
 36 making a lawful arrest. The order also may (i) (a) require the local sheriff or chief of police to conduct
 37 a background investigation which may include a review of the applicant's school records, employment
 38 records, or interviews with persons possessing general knowledge of the applicant's character and fitness
 39 for such appointment and (ii) (b) limit the use of flashing lights and sirens on personal vehicles used by
 40 the conservator in the performance of his duties. Prior to granting an application for appointment, the
 41 circuit court shall ensure that the applicant has met the registration requirements established by the
 42 Criminal Justice Services Board.

43 B. Effective September 15, 2004, no person shall seek appointment as a special conservator of the
 44 peace from a circuit court judge without possessing a valid registration issued by the Department of
 45 Criminal Justice Services, except as provided in this section. Applicants for registration may submit an
 46 application on or after January 1, 2004. A temporary registration may be issued in accordance with
 47 regulations established by the Criminal Justice Services Board while awaiting the results of a state and
 48 national fingerprint search. However, no person shall be issued a temporary registration until he has (i)
 49 complied with, or been exempted from the compulsory minimum training standards as set forth in this
 50 section, (ii) submitted his fingerprints on a form provided by the Department to be used for the conduct
 51 of a national criminal records search and a Virginia criminal history records search, and (iii) met all
 52 other requirements of this article and Board regulations. No person with a criminal conviction for a
 53 misdemeanor involving (a) moral turpitude, (b) assault and battery, (c) damage to real or personal
 54 property, (d) controlled substances or imitation controlled substances as defined in Article 1 (§ 18.2-247
 55 et seq.) of Chapter 7 of Title 18.2, (e) prohibited sexual behavior as described in Article 7 (§ 18.2-61 et
 56 seq.) of Chapter 4 of Title 18.2, (f) firearms, or (g) any felony, shall be registered as a special

57 conservator of the peace. All appointments for special conservators of the peace shall become void on
58 September 15, 2004, unless they have obtained a valid registration issued by the Department of Criminal
59 Justice Services.

60 C. Each person registered as or seeking registration as a special conservator of the peace shall be
61 covered by (i) a cash bond, or a surety bond executed by a surety company authorized to do business in
62 the Commonwealth, in a reasonable amount to be fixed by the Board, not to be less than \$10,000,
63 conditioned upon the faithful and honest conduct of his business or employment; or (ii) evidence of a
64 policy of liability insurance or self-insurance in an amount and with coverage as fixed by the Board.
65 Any person who is aggrieved by the misconduct of any person registered as a special conservator of the
66 peace and recovers a judgment against the registrant, which is unsatisfied in whole or in part, may bring
67 an action in his own name against the bond or insurance policy of the registrant.

68 D. Individuals listed in § 19.2-12, individuals who have complied with or been exempted pursuant to
69 subsection A of § 9.1-141, individuals employed as law-enforcement officers as defined in § 9.1-101
70 who have met the minimum qualifications set forth in § 15.2-1705 shall be exempt from the registration
71 requirements in subsections A through C. Further, individuals appointed under subsection A and
72 employed by a private corporation or entity that meets the requirements of subdivision (ii) of the
73 definition of criminal justice agency in § 9.1-101, shall be exempt from the registration requirements of
74 subsection A and from subsections B and C provided they have met the minimum qualifications set
75 forth in § 15.2-1705. The Department of Criminal Justice Services shall, upon request by the circuit
76 court, provide evidence to the circuit court of such employment prior to appointing an individual special
77 conservator of the peace. The employing agency shall notify the circuit court within 30 days after the
78 date such individual has left employment and all powers of the special conservator of the peace shall be
79 void. Failure to provide such notification shall be punishable by a fine of \$250 plus an additional \$50
80 per day for each day such notice is not provided.

81 E. When the application is made, the circuit court shall specify in the order of appointment the name
82 of the sheriff or chief of police of the applicant county, city, town or the name of the corporation,
83 business or other applicant authorized under subsection A and the geographic jurisdiction of the special
84 conservator of the peace. Court appointments shall be limited to the judicial circuit wherein application
85 has been made. In the case of a corporation or other business, the court appointment may also include,
86 for good cause shown, any real property owned or leased by the corporation or business, including any
87 subsidiaries, in other specifically named cities and counties, but shall provide that the powers of the
88 special conservator of the peace do not extend beyond the boundaries of such real property. Effective
89 July 1, 2004, the clerk of the appointing circuit court shall transmit a copy of the order of appointment
90 that shall specify the following information: the person's complete name, address, date of birth, social
91 security number, gender, race, height, weight, color of hair, color of eyes, firearm authority or limitation
92 as set forth in subsection F, date of the order, and other information as may be required by the
93 Department of State Police. The Department of State Police shall enter the person's name and other
94 information into the Virginia Criminal Information Network established and maintained by the
95 Department pursuant to Chapter 2 (§ 52-12 et seq.) of Title 52. The Department of State Police may
96 charge a fee not to exceed \$10 to cover its costs associated with processing these orders. Each special
97 conservator of the peace so appointed on application shall present his credentials to the chief of police
98 or sheriff or his designee of all jurisdictions where he has conservator powers. If his powers are limited
99 to certain areas owned or leased by a corporation or business, he shall also provide notice of the exact
100 physical addresses of those areas. Each special conservator shall provide a temporary registration letter
101 issued by the Department of Criminal Justice Services prior to seeking an appointment by the circuit
102 court. Once the applicant receives the appointment from the circuit court the applicant shall file the
103 appointment order with the Department of Criminal Justice Services in order to receive his special
104 conservator of the peace photo registration card.

105 If any such special conservator of the peace is the employee, agent or servant of another, his
106 appointment as special conservator of the peace shall not relieve his employer, principal or master, from
107 civil liability to another arising out of any wrongful action or conduct committed by such special
108 conservator of the peace while within the scope of his employment.

109 Effective July 1, 2002, no person employed by a local school board as a school security officer, as
110 defined in § 9.1-101, shall be eligible for appointment as a conservator for purposes of maintaining
111 safety in a public school in the Commonwealth. All appointments of special conservators of the peace
112 granted to school security officers as defined in § 9.1-101 prior to July 1, 2002 are void.

113 F. The court may limit or prohibit the carrying of weapons by any special conservator of the peace
114 initially appointed on or after July 1, 1996, while the appointee is within the scope of his employment
115 as such.
