2 An Act to amend the Code of Virginia by adding a section numbered 22.1-299.4, relating to Teach For 3 America licenses.

Approved

Be it enacted by the General Assembly of Virginia: 6

7 1. That the Code of Virginia is amended by adding a section numbered 22.1-299.4 as follows: 8 § 22.1-299.4. Teach For America license.

9 A. Notwithstanding any provision of law to the contrary, the Board shall issue a two-year provisional 10 license, hereafter referred to as the Teach For America license, to any participant in Teach For America, a nationwide nonprofit organization focused on closing the academic achievement gaps 11 12 between students in high-income and low-income areas, who submits an application and meets the 13 following criteria:

14 1. Holds, at minimum, a baccalaureate degree from a regionally accredited institution of higher 15 education;

16 2. Has met the requirements prescribed by the Board for all endorsements sought or has met the 17 qualifying scores on the content area assessment prescribed by the Board for the endorsements sought;

18 3. Possesses good moral character according to criteria developed by the Board; 19

4. Has been offered and has accepted placement in Teach For America;

20 5. Has successfully completed pre-service training and is participating in the professional development requirements of Teach For America, including teaching frameworks, curricula, lesson 21 22 planning, instructional delivery, classroom management, assessment and evaluation of student progress, 23 classroom diversity, and literacy development;

24 6. Has an offer of employment from a local school board to teach in a public elementary or 25 secondary school in the Commonwealth or a preschool program that receives state funds pursuant to 26 subsection C of § 22.1-199.1; and

27 7. Receives a recommendation from the employing school division for a Teach For America license 28 in the endorsement area in which the individual seeks to be licensed.

29 B. In addition to the criteria set forth in subsection A, any individual who seeks an endorsement in 30 early childhood, early/primary, or elementary education shall either (i) agree to complete such 31 coursework in the teaching of reading as may be prescribed by the Board pursuant to regulation during 32 the first year of employment or (ii) achieve a passing score on a reading instructional assessment 33 prescribed by the Board pursuant to regulation.

34 C. Teachers issued a Teach For America provisional license shall not be eligible for continuing 35 contract status while employed under the authority of a Teach For America license and shall be subject to the probationary terms of employment specified in § 22.1-303. 36

37 D. The Board may extend any Teach For America license for one additional year upon request of 38 the employing school division, provided that no Teach For America license shall exceed a total of three 39 years in length.

40 E. Notwithstanding any provision of law to the contrary, upon completion of at least two years of 41 full-time teaching experience in a public elementary or secondary school in the Commonwealth or a 42 preschool program that receives state funds pursuant to subsection C of § 22.1-199.1, an individual 43 holding a Teach For America license shall be eligible to receive a renewable license if he has (i) 44 achieved satisfactory scores on all professional teacher assessments required by the Board and (ii) 45 received satisfactory evaluations at the conclusion of each year of employment.

F. Notwithstanding any provision of law to the contrary, the Board shall issue a Teach For America 46 license to any individual who (i) has completed two years of successful teaching in the Teach For 47 **48** America program in another state, (ii) is not eligible to receive a renewable license, and (iii) meets the 49 criteria set forth in subsection A.
