- Be it enacted by the General Assembly of Virginia: 6
- 7 1. That §§ 35.1-25 and 35.1-26 of the Code of Virginia are amended and reenacted as follows: 8 § 35.1-25. Exemptions. 9
 - The provisions of this title applicable to restaurants shall not apply to:
 - 1. Boardinghouses that do not accommodate transients;
 - 2. Cafeterias operated by industrial plants for employees only;
- 3. Churches,; fraternal, or school, and social organizations,; organizations that are exempt from 12 taxation under § 501(c)(3) of the Internal Revenue Code; and volunteer fire departments and rescue 13 squads, which hold occasional dinners, bazaars, and other fund raisers of one or two days' duration, at 14 15 which food (i) prepared in the homes of members Θr ; (ii) prepared in the kitchen of the church, school, 16 or organization; or (iii) purchased or donated from a restaurant licensed pursuant to Chapter 3 (§ 35.1-18 et seq.) is offered for sale to the public. Restaurants licensed pursuant to Chapter 3 that 17 18 donate or sell food to the entities identified in this subdivision shall not be required to apply for any 19 additional permits from, or pay any additional permit application fees to, the Department for the 20 proposed occasional dinner, bazaar, or other fund raiser;
- 21 4. Grocery stores, including the delicatessen portion which that is a part of a grocery store selling 22 exclusively for off-premises consumption, and places manufacturing or selling packaged or canned 23 goods;
- 24 5. Churches which that serve meals consisting of food prepared in the homes of members or in the 25 kitchen of the church or purchased or donated from a restaurant licensed pursuant to Chapter 3 26 (§ 35.1-18 et seq.) for their members or their invited guests; or
- 27 6. Convenience stores or gas stations that are subject to the Department of Agriculture and Consumer 28 Services' Rules and Regulations Pertaining to the Sanitary and Operating Procedures in Retail Food 29 Stores Establishment Regulations or any regulations subsequently adopted and that (i) have 15 or fewer 30 seats at which food is served to the public on the premises of the convenience store or gas station and 31 (ii) are not associated with a national or regional restaurant chain. Notwithstanding this exemption, such 32 convenience stores or gas stations shall remain responsible for collecting any applicable local meals tax.
- 33 § 35.1-26. Cities, counties, and towns may by ordinance exempt certain fairs, youth athletic 34 activities and fund-raisers.
- 35 The governing body of any county, city, or town may provide by ordinance that this title shall not apply to: 36
- 37 1. Food booths at fairs, if such booths are promoted or sponsored by any political subdivision of the 38 Commonwealth or by any charitable nonprofit organization or group thereof.
- 39 2. Concession stands at youth athletic activities, if such stands are promoted or sponsored by either a 40 youth athletic association or by any charitable nonprofit organization or group thereof which has been 41 recognized as being a part of the recreational program of the political subdivision where the association 42 or organization is located by an ordinance or resolution of such political subdivision.
- 43 3. Organizations that are exempt from taxation under § 501(c)(3) of the Internal Revenue Code that hold occasional fund-raisers for the duration of the event at which food is prepared by such organization 44 45 and is offered for sale to the public.
- 46 The ordinance shall provide that the health officer of the county, city, or town in which the fair or 47 activity is held, or a qualified person designated by him, shall exercise such supervision of the sale of **48** food as the ordinance may prescribe.
