6 WHEREAS, United States Army Sergeant Aaron Xavier Wittman of Chester became the first United 7 States combat casualty in the War on Terror in 2013 when he died on January 10, 2013, while 8 conducting combat operations in Kyogyani District, Nangarhar Province, Afghanistan; and

9 WHEREAS, Aaron Wittman, the son of Major Duane Wittman, USA (Ret.), and his wife, Carol, was 10 an outstanding athlete at L. C. Bird High School, lettering in wrestling and soccer, and was a member 11 of the Chesterfield Soccer Club; and

WHEREAS, Aaron Wittman followed in his family's proud tradition of study at The Citadel, The 12 Military College of South Carolina, and service to the country in the United States Armed Forces by 13 14 enrolling at The Citadel after graduating from high school; and

WHEREAS, while a student, Aaron Wittman joined the South Carolina National Guard and elected 15 16 to interrupt his studies at The Citadel for two years so that he could deploy with his National Guard Unit to Afghanistan in 2007; and 17

WHEREAS, Aaron Wittman served for one year with the 218th Brigade Combat Team in Forward 18 19 Operating Base Shkin, a very hostile and rugged region of Afghanistan, while conducting combat operations and training Afghan Army forces, and earned the Combat Infantryman's Badge before returning to The Citadel to complete his degree, graduating in 2009; and 20 21

WHEREAS, a highly trained Soldier fluent in the Pashto language and Airborne qualified, Sergeant 22 23 Wittman enlisted in the United States Army in 2010 and was assigned to the 3rd Battalion, 69th Armor 24 Regiment, 1st Brigade Combat Team, 3rd Infantry Division at Fort Stewart, Georgia; and

25 WHEREAS, Sergeant Wittman deployed for his second combat tour to Afghanistan in November 26 2012: and

27 WHEREAS, on January 10, 2013, Sergeant Wittman died from injuries sustained returning fire to 28 protect and save the lives of his combat team when his unit, which was on mounted patrol, came under 29 small arms fire; and

30 WHEREAS, an outstanding Soldier who honorably represented his family, school, and country, Sergeant Wittman earned several awards over the course of his distinguished military career, including a 31 posthumous Purple Heart and Bronze Star; and 32

33 WHEREAS, Sergeant Wittman's family has served above and beyond the call of duty in the War on Terror, with his father, Major Duane Wittman, USA (Ret.); his brother, Captain Nicholas Wittman, 34 USMC; and his sister, Amber Wittman, a 10-year United States Navy Corpsman, serving combat tours, 35 while his mother, Carol, has demonstrated great courage and fortitude as her loved ones have traveled to 36 37 perilous places around the world to ensure the safety of their fellow Americans at home; and

38 WHEREAS, a true American patriot exhibiting the United States Army Values of Loyalty, Duty, 39 Respect, Selfless Service, Honor, Integrity, and Personal Courage and known for his winning smile, 40 contagious sense of humor, and positive attitude, Sergeant Wittman leaves behind to cherish his memory 41 his parents, Duane and Carol; siblings, Nicholas and Amber, and their families; and numerous other family members, friends, and fellow Soldiers; now, therefore, be it 42

RESOLVED by the House of Delegates, the Senate concurring, That the General Assembly hereby 43 note with great sadness the loss of a beloved son and brother and courageous patriot, Sergeant Aaron 44 45 Xavier Wittman; and, be it
