| 11              | 1. That §§ 16.1-220 and 17.1-708 of the Code of Virginia are amended and reenacted as follows:   |
| 12              | § 16.1-220. Meetings; active members must give notice of inability to attend; special session  |
| 13              | concerning motor vehicle and traffic laws.   |
| 14              | The Conference shall meet at least once in each calendar year at the call of the president and at such   |
| 15              | other times as may be designated by him or by the executive committee, but in no case more often than  |
| 16              | once every other year, for the purpose of discussing and considering means and methods of improving  |
| 17              | the administration of justice in this the Commonwealth. If any active member shall for any cause be  |
| 18              | unable to attend, he shall promptly notify the president. Unless excused from attendance, it shall be the  |
| 19              | duty of each active member to attend and remain throughout the proceedings of the Conference.  |
| 20              | In conjunction with said meetings and as a part thereof, the Conference shall conduct a session at   |
| 21<br>22        | least once each year devoted to the consideration of and instruction on the Commonwealth's motor vehicle and traffic laws and their proper administration. Unless excused from attendance, it shall be the |

Unless excused from attendance, it shall be the duty of each active member to attend and remain throughout the proceedings of the Conference.
