11	Be it enacted by the General Assembly of Virginia:
12	1. That the Code of Virginia is amended by adding in Chapter 13 of Title 22.1 an article
13	numbered 1.2:1, consisting of sections numbered 22.1-212.16:1 through 22.1-212.16:5, as follows:
14	Article 1.2:1.
15	Virginia Public School Improvement Program.
16	§ 22.1-212.16:1. Virginia Public School Improvement Program; purpose; criteria.
17	A. There is hereby established the Virginia Public School Improvement Program (the "Program") to:
18	(i) stimulate the development of innovative programs in public education; (ii) provide opportunities for
19	innovative instruction and assessment; (iii) meet the educational needs of academically low-performing
20	students; (iv) increase student academic performance; (v) facilitate the employment of master teachers
21	and highly experienced administrators; (vi) utilize research-based best practices and educational
22	innovations in curricula, classroom instruction, and management; (vii) promote family and community
23	involvement in the education of the students; (viii) provide alternative and innovative instruction, school
24	scheduling, management, and structure; (ix) establish educational excellence as a benchmark; $(x)$
25	achieve cost efficiencies; (xi) streamline and simplify certain regulatory requirements; and (xii) provide
26	parents and students more educational options within their school divisions.
27	B. Local school boards may designate or approve for participation in the Program any public school
28	within its school division that (i) has not applied for, converted to, or received permission from the
29	local school board to operate as a public charter school, pursuant to § 22.1-212.5, or (ii) a majority of
30	parents and teachers of students at the school have petitioned the school board to participate in the
31	Program, or (iii) the school board has determined that, notwithstanding having satisfied the
32	requirements of the Standards of Learning and Standards of Accreditation, less than 81 percent of the
33	students enrolled in a public school within the school division have failed to demonstrate proficiency in
34	reading and less than 79 percent of the students enrolled have failed to demonstrate proficiency in
35	mathematics for three consecutive school years.
36	§ 22.1-212.16:2. Funding of Program.
37	A local school board that elects to designate or approve public schools within its school division for
38	participation in the Program shall continue to receive its proportion of state basic school aid without
	reduction or proration of costs for educational and support programs offered by the school division.
40 41	§ 22.1-212.16:3. Local authority; exemption from regulatory requirements; rescindment of
42	designation or approval. A. Pursuant to the provisions of this article and constitutional principles, local school boards shall
43	maintain and exercise authority over public schools within the school division that have been designated
<b>4</b> 4	or approved by the school board to participate in the Program.
45	B. Public schools participating in the Program shall operate free from specified school division
46	policies and state regulations, and, as public schools, shall be subject to the requirements of the
47	Standards of Quality, including the Standards of Learning and the Standards of Accreditation, and
48	applicable federal laws and regulations prohibiting racial, ethnic, and gender discrimination, and
49	governing special education and equity programs, and disclosure of scholastic records and other
50	personal identifiable information.
51	C. The local school board shall execute a contract with the public schools designated or approved to
52	participate in the Program that shall reflect all agreements regarding the release of the public school
53	from school division policies and from state regulations, consistent with the requirements of this section.
54	The local school board, on behalf of the public school, shall request the release from state regulations
55	from the Board of Education.
56	D. The local school board may rescind the designation or approval of a public school's participation
57	in the Program, if (i) the public school makes application to operate as a charter school, pursuant to
58	§ 22.1-212.5, or (ii) a majority of parents and teachers of students at the school petition the school

59 board to rescind the school's participation in the Program, or (iii) the school board determines that, in addition to satisfying the requirements of the Standards of Learning and Standards of Accreditation, 95 60 61 percent or more of the students enrolled in a public school participating in the Program have demonstrated proficiency in (i) reading and read and comprehend on or above grade level, and (ii) 62 63 have demonstrated proficiency in mathematics at or above grade level for three consecutive school 64 years. The school board may also rescind the designation or approval of a school's participation in the 65 Program if the public school violates the terms of the contract, pursuant to this section, or if 50 percent or more of the students enrolled in a participating public school fail to achieve satisfactory academic 66 progress toward the school's stated academic goals each school year for two consecutive school years. 67 68 § 22.1-212.16:4. Annual reporting requirements. Local school boards shall report annually the designation or approval of public schools participating 69

in the Program to the Board of Education, as may be determined by the Board. Such report shall specify the purpose of the designation or approval; the number, census, and a detailed description of the academic program offered by each participating public school; and the academic progress achieved and other accomplishments of the public school while a participant in the Program.

74 § 22.1-212.16:5. Board of Education guidelines.

To facilitate statewide uniformity of the Program, the Board of Education shall establish guidelines
to assist local school boards in the implementation of the Program and shall provide technical
assistance to local school boards as may be requested.
