9 10	Be it enacted by the General Assembly of Virginia:
11	1. That § 19.2-390.3 of the Code of Virginia is amended and reenacted as follows:
12	§ 19.2-390.3. Child Pornography Images Registry; maintenance; access.
13	A. The Office of the Attorney General, in cooperation with the Department of State Police, shall
14	keep and maintain a Child Pornography Registry to be located within the State Police, separate and apart
15 16	from all other records maintained by either department. The purpose of the Registry shall be to assist the efforts of law-enforcement agencies statewide to protect their communities from repeat child
17	pornographers and to protect children from becoming victims of criminal offenders by aiding in
18	identifying victims and perpetrators. Criminal justice agencies, including law-enforcement agencies, may
19	request of the State Police a search and comparison of child pornography images contained within the
20	Registry with those images obtained by criminal justice agencies during the course of official
21 22	investigations. B. The Registry shall include images of sexually explicit visual material in any form including any
22 23	picture, photograph, drawing, sculpture, motion picture film, digital image or similar visual
24	representation, presented as evidence and used in any conviction for any offense enumerated in
25	§§ 18.2-374.1 and 18.2-374.1:1.
26	C. Registry information provided under this section shall be used for the purposes of the
27 28	administration of criminal justice or for the protection of the public in general and children in particular. Use of the information or the images contained therein for purposes not authorized by this section is
20 29	prohibited and a willful violation of this section with the intent to harass or intimidate another shall be
3 0	punished as a Class 6 felony.
31	D. The Virginia Criminal Information Network and any form or document used by the Department
32	of State Police to disseminate information from the Registry shall provide notice that any unauthorized
33 34	possession, use or dissemination of the information or images is a crime punishable as a Class 6 felony. E All data records and reports related to shild abuse and exploitation and all abstracts of such
34 35	<i>E.</i> All data, records, and reports related to child abuse and exploitation and all abstracts of such data, records, and reports that are in the possession of the Department pursuant to this section shall be
36	confidential and exempt from the Virginia Freedom of Information Act (§ 2.2-3700 et seq.) and the
37	Government Data Collection and Dissemination Practices Act (§ 2.2-3800 et seq.).
38	F. The provisions of Chapter 20.1 (§ 2.2-2005 et seq.) of Title 2.2 shall not apply to this section.
