10	Be it enacted by the General Assembly of Virginia:
11 1	1. That §§ 24.2-101 and 24.2-706 of the Code of Virginia are amended and reenacted as follows:
12	§ 24.2-101. Definitions.
13	As used in this title, unless the context requires a different meaning:
14	"Candidate" means a person who seeks or campaigns for an office of the Commonwealth or one of
15 i	its governmental units in a general, primary, or special election and who is qualified to have his name
	placed on the ballot for the office. "Candidate" shall include a person who seeks the nomination of a political party or who, by reason of receiving the nomination of a political party for election to an
	office, is referred to as its nominee. For the purposes of Chapters 8 (§ 24.2-800 et seq.), 9.3 (§ 24.2-945
	et seq.), and 9.5 (§ 24.2-955 et seq.), "candidate" shall include any write-in candidate. However, no
	write-in candidate who has received less than 15 percent of the votes cast for the office shall be eligible
	to initiate an election contest pursuant to Article 2 (§ 24.2-803 et seq.) of Chapter 8. For the purposes of
	Chapters 9.3 (§ 24.2-945 et seq.) and 9.5 (§ 24.2-955 et seq.), "candidate" shall include any person who
	raises or spends funds in order to seek or campaign for an office of the Commonwealth, excluding
	federal offices, or one of its governmental units in a party nomination process or general, primary, or
	special election; and such person shall be considered a candidate until a final report is filed pursuant to

27	"Central absentee voter precinct" means a precinct established by a county or city pursuant to
	§ 24.2-712 for the processing of absentee ballots for the county or city or any combination of precincts

	in Article VII, Section 4 of the Constitution of Virginia: clerk of the circuit court, attorney for the

43	"General election" means an election held in the Commonwealth on the Tuesday after the first

46	"Military-overseas ballot" means (i) a federal write-in absentee ballot; (ii) a ballot specifically
	prepared or distributed for use by a voter eligible to vote absentee under subdivision 2 of § 24.2-700 in
	accordance with this title; or (iii) an absentee ballot cast by a voter voting absentee under subdivision 2

59 "Polling place" means the structure that contains the one place provided for each precinct at which 60 the qualified voters who are residents of the precinct may vote.

61 "Precinct" means the territory designated by the governing body of a county, city, or town to be 62 served by one polling place.

63 "Primary" or "primary election" means an election held for the purpose of selecting a candidate to be 64 the nominee of a political party for election to office.

65 "Qualified voter" means a person who is entitled to vote pursuant to the Constitution of Virginia and who is (i) 18 years of age on or before the day of the election or qualified pursuant to § 24.2-403 or 66 subsection D of § 24.2-544, (ii) a resident of the Commonwealth and of the precinct in which he offers 67 to vote, and (iii) registered to vote. No person who has been convicted of a felony shall be a qualified 68 voter unless his civil rights have been restored by the Governor or other appropriate authority. No 69 70 person adjudicated incapacitated shall be a qualified voter unless his capacity has been reestablished as 71 provided by law.

72 "Qualified voter in a town" means a person who is a resident within the corporate boundaries of the town in which he offers to vote, duly registered in the county of his residence, and otherwise a qualified 73 74 voter.

75 "Referendum" means any election held pursuant to law to submit a question to the voters for 76 approval or rejection.

77 "Registered voter" means any person who is maintained on the Virginia voter registration system. All 78 registered voters shall be maintained on the Virginia voter registration system with active status unless 79 assigned to inactive status by a general registrar in accordance with Chapter 4 (§ 24.2-400 et seq.). For purposes of applying the precinct size requirements of § 24.2-307, calculating election machine requirements pursuant to Article 3 (§ 24.2-625 et seq.) of Chapter 6, mailing notices of local election 80 81 district, precinct or polling place changes as required by subdivision 13 of § 24.2-114 and § 24.2-306, 82 83 and determining the number of signatures required for candidate and voter petitions, "registered voter" 84 shall include only persons maintained on the Virginia voter registration system with active status.

85 "Registration records" means all official records concerning the registration of qualified voters and shall include all records, lists, applications, and files, whether maintained in books, on cards, on 86 87 automated data bases, or by any other legally permitted record-keeping method.

88 "Residence" or "resident," for all purposes of qualification to register and vote, means and requires 89 both domicile and a place of abode. To establish domicile, a person must live in a particular locality 90 with the intention to remain. A place of abode is the physical place where a person dwells.

91 "Special election" means any election that is held pursuant to law to fill a vacancy in office or to 92 hold a referendum. 93

'State Board" or "Board" means the State Board of Elections.

"Virginia voter registration system" or "voter registration system" means the automated central 94 95 record-keeping system for all voters registered within the Commonwealth that is maintained as provided in Article 2 (§ 24.2-404 et seq.) of Chapter 4. 96

§ 24.2-706. Duty of general registrar and electoral board on receipt of application; statement of voter. 97 98 On receipt of an application for an absentee ballot, the general registrar shall enroll the name and 99 address of each registered applicant on an absentee voter applicant list that shall be maintained in the 100 office of the general registrar with a file of the applications of the listed applicants. The list shall be 101 available for inspection and copying and the applications shall be available for inspection only by any registered voter during regular office hours. Upon request and for a reasonable fee, the State Board of 102 Elections shall provide an electronic copy of the absentee voter applicant list to any political party or 103 candidate. Such list shall be used only for campaign and political purposes. Any list made available for 104 inspection and copying under this section shall contain the post office box address in lieu of the 105 residence street address for any individual who has furnished at the time of registration or subsequently, 106 107 in addition to his street address, a post office box address pursuant to subsection B of § 24.2-418.

108 No list or application containing an individual's social security number, or any part thereof, or the 109 individual's day and month of birth, shall be made available for inspection or copying by anyone. The State Board of Elections shall prescribe procedures for local electoral boards and general registrars to 110 make the information in the lists and applications available in a manner that does not reveal social 111 security numbers or parts thereof, or an individual's day and month of birth. 112

113 The completion and timely delivery of an application for an absentee ballot shall be construed to be 114 an offer by the applicant to vote in the election.

115 The general registrar shall note on each application received whether the applicant is or is not a registered voter and notify the secretary of the electoral board. In reviewing the application for an 116 absentee ballot, the general registrar and electoral board shall not reject the application of any individual 117 because of an error or omission on any record or paper relating to the application, if such error or 118 119 omission is not material in determining whether such individual is qualified to vote absentee.

If the application has been properly completed and signed and the applicant is a registered voter of 120

the precinct in which he offers to vote, the electoral board shall, at the time when the printed ballots for
the election are available, send by the deadline set out in § 24.2-612, obtaining a certificate of mailing,
or deliver to him in person in the office of the secretary or registrar, the following items and nothing
else:

125 1. An envelope containing the folded ballot, sealed and marked "Ballot within. Do not open except 126 in presence of a witness."

127 2. An envelope, with printing only on the flap side, for resealing the marked ballot, on which 128 envelope is printed the following:

**129** "Statement of Voter."

130 "I do hereby state, subject to felony penalties for making false statements pursuant to § 24.2-1016, 131 (last, first, middle); that I am now or have been at some time that my FULL NAME is 132 since last November's general election a legal resident of \_\_\_\_\_ (STATE YOUR LEGAL RESIDENCE IN VIRGINIA including the house number, street name or rural route address, city, zip 133 134 code); that I received the enclosed ballot(s) upon application to the registrar of such county or city; that 135 I opened the envelope marked 'ballot within' and marked the ballot(s) in the presence of the witness, 136 without assistance or knowledge on the part of anyone as to the manner in which I marked it (or I am 137 returning the form required to report how I was assisted); that I then sealed the ballot(s) in this 138 envelope; and that I have not voted and will not vote in this election at any other time or place.

141 Signature of witness ....."

For elections held after January 1, 2004, instead of the envelope containing the above oath, an
envelope containing the standard oath prescribed by the presidential designee under § 101(b)(7) of the
Uniformed and Overseas Citizens Absentee Voting Act (42 U.S.C. § 1973ff et seq.) shall be sent to
voters who are qualified to vote absentee under that Act.

146 3. A properly addressed envelope for the return of the ballot to the electoral board by mail or by the147 applicant in person.

148 4. Printed instructions for completing the ballot and statement on the envelope and returning the ballot.

150 For federal elections held after January 1, 2004, for any voter who is required by subparagraph (b) of 151 42 U.S.C. § 15483 of the Help America Vote Act of 2002 to show identification the first time the voter 152 votes in a federal election in the state, the printed instructions shall direct the voter to submit with his 153 ballot (i) a copy of a current and valid photo identification or (ii) a copy of a current utility bill, bank 154 statement, government check, paycheck or other government document that shows the name and address 155 of the voter. Such individual who desires to vote by mail but who does not submit one of the forms of 156 identification specified in this paragraph may cast such ballot by mail and the ballot shall be counted as 157 a provisional ballot under the provisions of § 24.2-653. The State Board of Elections shall provide 158 instructions to the electoral boards for the handling and counting of such provisional ballots pursuant to 159 subsection B of § 24.2-653 and this section.

5. For any voter entitled to vote absentee under the Uniformed and Overseas Citizens Absentee
Voting Act (42 U.S.C. § 1973ff et seq.), information provided by the State Board specific to the voting
rights and responsibilities for such citizens, or information provided by the registrar specific to the status
of the voter registration and absentee ballot application of such voter, may be included.

164 The envelopes and instructions shall be in the form prescribed by the State Board.

165 If the applicant makes his application to vote in person under § 24.2-701 at a time when the printed ballots for the election are available, the general registrar or the secretary of the electoral board, on the 166 167 determination of the qualifications of the applicant to vote, shall provide to the applicant the items set forth in subdivisions 1 through 4, and no item shall be removed by the applicant from the office of the 168 general registrar or the secretary of the electoral board. On the request of the applicant, made no later 169 170 than 5:00 p.m. on the seventh day prior to the election in which the applicant offers to vote, the general 171 registrar or the secretary may send the items set forth in subdivisions 1 through 4 to the applicant by 172 mail, obtaining a certificate of mailing.

173 If the applicant states as the reason for his absence on election day any of the reasons set forth in 174 subdivision 2 of § 24.2-700, the electoral board, at the time when the printed ballots for the election are 175 available, shall mail by the deadline set forth in § 24.2-612 or deliver in person to the applicant in the 176 office of the secretary or general registrar the items as set forth in subdivisions 1 through 4 and, if 177 necessary, an application for registration. A certificate of mailing shall not be required. The electoral board, at the time when the printed ballots for the election are available, shall send by the deadline set 178 179 forth in § 24.2-612 the blank ballot, the form for the envelope for returning the marked ballot, and 180 instructions to the voter by electronic transmission if the voter so requests. The voted ballot shall be 181 returned to the electoral board as otherwise required by this chapter.

The State Board of Elections shall provide instructions and procedures to enable secure submission
of voted military-overseas ballots by fax or other electronic format. In the event that a ballot is
requested on or before but not sent by the deadline for making absentee ballots available under
§ 24.2-612, the electoral board shall send the blank ballot, instructions, and return envelope form to the
voter by the most expedited delivery service available or by electronic format if the voter so requests.

187 The instructions for electronic transmission and submission shall be in the form prescribed by the
188 State Board. The State Board may modify the Statement of Voter provided in subdivision 2 to make it
189 compatible with electronic submission. The statement must include language to the following effect: "I
190 understand that an election official must view my electronic submission to determine my eligibility to
191 vote and place my voted ballot in a secure container."

When the statement prescribed in subdivision 2 has been properly completed and signed by the registered voter and witnessed, his ballot shall not be subject to challenge pursuant to § 24.2-651.

The circuit courts shall have jurisdiction to issue an injunction to enforce the provisions of this section upon the application of (i) any aggrieved voter, (ii) any candidate in an election district in whole or in part in the court's jurisdiction where a violation of this section has occurred, or is likely to occur, or (iii) the campaign committee or the appropriate district political party chairman of such candidate. Any person who fails to discharge his duty as provided in this section through willful neglect of duty and with malicious intent shall be guilty of a Class 1 misdemeanor as provided in subsection A of § 24.2-1001.
