8. Fiscal Implications: Included in Fiscal Impact estimate. Currently, the judicial retirement plan provides for the mandatory retirement of judges once they attain age 70. The proposed bill would extend the mandatory retirement age to 73. The data in Item 7 includes the reduction in costs for the retiree health insurance credit program and group life insurance as well.

- **9. Specific Agency or Political Subdivisions Affected:** VRS, JRS and agencies employing judges.
- 10. Technical Amendment Necessary: No
- 11. Other Comments: The current retirement rates were extended beyond age 70 to allow analysis on this proposed change. However, it is important to keep in mind that it is not possible to predict how many members will continue to work beyond age 70. The actual impact will depend on how many judges elect to retire after age 70. If only a few judges work past age 70, the savings may be minimal.

SB 762 was incorporated by the Senate Courts of Justice Committee into this bill.
