

## 1 VIRGINIA ACTS OF ASSEMBLY — CHAPTER

2 *An Act to amend and reenact § 29.1-102 of the Code of Virginia, relating to membership of the Board*  
3 *of Game and Inland Fisheries.*

6 **Be it enacted by the General Assembly of Virginia:**7 **1. That § 29.1-102 of the Code of Virginia is amended and reenacted as follows:**8 **§ 29.1-102. Board of Game and Inland Fisheries; how constituted; meetings.**9 The Commission of Game and Inland Fisheries is continued and shall hereafter be known as the  
10 Board of Game and Inland Fisheries.

11 A. The Board shall consist of ~~not more than one member from each congressional district~~ 11  
12 *members*. Each member of the Board shall be appointed by the Governor, subject to confirmation by the  
13 General Assembly. *The members appointed shall be citizens of the Commonwealth and shall be*  
14 *knowledgeable about wildlife conservation, hunting, fishing, boating, agriculture, forestry, or habitat.*  
15 *Each Department region, as constituted on July 1, 2014, shall be represented by two members, and*  
16 *three members shall be members-at-large, each representing a different Department region.* Members  
17 shall be appointed for terms of one to four years; however, appointments shall be made in a manner  
18 whereby no more than three members shall have terms which expire in the same year. An appointment  
19 to fill a vacancy shall be made in the same manner, but only for the unexpired term. No person shall be  
20 eligible to serve more than two consecutive four-year terms. Members may be removed from office  
21 during their respective terms by the Governor.

22 B. The Board shall adopt rules and procedures for the conduct of its business that shall be set forth  
23 in a Governance Manual. The Board may establish committees to assist it with its duties and  
24 responsibilities. All decisions by a committee shall be reviewed by the Board, and shall only take effect  
25 if approved by the Board.

26 C. The Board shall elect one of its members as its chairman whose duties shall be limited to (i)  
27 presiding at all regular and called meetings of the Board; (ii) serving as the Board liaison to the  
28 Director, other Board members, and the Secretary of Natural Resources; and (iii) the other duties set  
29 forth in the Governance Manual as approved by a majority of the Board. The Board shall also elect a  
30 vice-chairman to preside in the absence of the chairman. Any additional duties of the vice-chairman  
31 shall be set forth in the Governance Manual. The Board shall annually elect one of its members as  
32 chairman and one of its members as vice-chairman. At such annual election, the chairman and  
33 vice-chairman shall not be eligible to be re-elected to their respective positions and no person shall serve  
34 more than one year as chairman and one year as vice-chairman during a four-year term.

35 D. The Board shall meet at least once every quarter of the calendar year for the transaction of  
36 business, and other meetings may be called if necessary by the chairman or at the request of any three  
37 members. The majority of the members shall constitute a quorum. Meetings shall be held in Richmond  
38 or at such other places within the Commonwealth as may be necessary.

39 **2. That this act shall not be construed to affect existing appointments for which the terms have**  
40 **not expired. However, any new appointment or appointments to fill vacancies made after the**  
41 **effective date of this act shall be made in accordance with the provisions of this act.**
