A BILL to amend and reenact § 22.1-241 of the Code of Virginia and to amend the Code of Virginia by adding a section numbered 22.1-241.1, relating to access to electronic textbooks.

Be it enacted by the General Assembly of Virginia:

10 1. That § 22.1-241 of the Code of Virginia is amended and reenacted and that the Code of Virginia is amended by adding a section numbered 22.1-241.1 as follows: 11 12

§ 22.1-241. Contracts with publishers.

13 A. Local school boards shall either enter into written term contracts or issue purchase orders on an 14 as-needed basis with publishers of textbooks approved by the Board for use in the public schools. Such 15 written contracts or purchase orders for textbooks approved by the Board shall be exempt from the 16 Virginia Public Procurement Act (§ 2.2-4300 et seq.).

The contract price shall not exceed the lowest wholesale price at which the textbooks or textbooks 17 involved in the contract are currently bid under contract anywhere in the United States. 18

19 If, subsequent to the date of any contract entered into by a local school board, the prices of 20 textbooks named in the contract are reduced or the terms of the contract are made more favorable to 21 purchase anywhere in the United States or a special or other edition of any book named in the contract is sold outside of Virginia at a lower price than contracted in the Commonwealth, the publisher shall 22 23 grant the same reduction or terms to the local school board and give the local school board the option 24 of using such special or other edition adapted for use in Virginia and at the lowest price at which such 25 special edition is sold elsewhere and the contract shall so state.

B. Contracts and purchase orders with publishers of textbooks approved by the Board shall require 26 27 the publisher to furnish an electronic file of the textbook in the National Instructional Materials 28 Accessibility Standards (NIMAS) format that will then be deposited in the National Instructional 29 Materials Access Center (NIMAC) from which accessible versions of the particular textbook may be 30 produced for students with print disabilities, as defined in 20 U.S.C. § 1474. Publishers shall deliver the 31 NIMAS file of the textbook on or before the date of delivery of the regular text version.

Contracts and purchase orders with publishers of textbooks approved by the Board for use in grades 32 33 6-12 six through 12 shall allow for the purchase of printed textbooks, printed textbooks with electronic 34 files, or electronic textbooks separate and apart from printed versions of the same textbook. Each school board shall have the authority to purchase an assortment of textbooks in any of the three forms listed 35 36 above, subject to the provisions of § 22.1-241.1.

37 C. Every school board shall order directly from the respective publishers the textbooks needed to 38 supply the public schools in the school division. The publishers shall ship the textbooks to the school 39 board. The purchase price of such textbooks shall be paid directly to the publishers by the school board.

D. With the approval of the local school board and the publisher, any private school within the 40 41 school division that so requests may purchase from the local school board's contract with the publisher. Such private school shall be fully responsible for ordering, purchasing, and receiving shipments of books 42 to be provided from the publisher pursuant to this section. The local school board shall be immune from 43 any civil liability as a result of a private school purchasing from the local school board's contract. 44 45

§ 22.1-241.1. Access to electronic textbooks.

A. It is the policy of the Commonwealth that all textbooks approved by the Board for use in grades 46 47 six through 12 shall be equally accessible to all students at school and in their residence.

B. No school board shall make electronic textbooks available for use by students in their residence 48 49 or residences unless the school board adopts a plan to ensure that on or before July 1, 2017 (i) each student in the local school division will have actual access in his residence or residences to at least one 50 51 personal computing device not shared with another student that contains an operating system and 52 hardware necessary to support the format of each electronic textbook that the school board seeks to 53 purchase and (ii) each student in the local school division will have Internet connection service capable of transmitting information at a rate that is not less than 256 kilobits per second installed in his 54 55 residence or residences.

C. The Board shall annually develop, update, and distribute to each local school division a list of 56 57 personal computing devices that comply with this section.

D. Notwithstanding subsection B, a local school board may establish a pilot program for the use of 58

8 9 59 electronic textbooks at any secondary school in the local school division provided that (i) each student 60 at the secondary school has actual access in his residence or residences to at least one personal 61 computing device not shared with another student that contains an operating system and hardware 62 necessary to support the format of each electronic textbook that the school board seeks to purchase, (ii) 63 each student at the secondary school has Internet connection service capable of transmitting information 64 at a rate that is not less than 256 kilobits per second installed in his residence or residences, and (iii) the secondary school is receiving federal funds pursuant to Title I of the federal Elementary and 65 Secondary Education Act of 1965, P.L. 89-10, as amended, or no more than 5% of the students in the 66 local school division or 300 children, whichever is greater, participate in the pilot program. 67

68 2. That the provisions of this act shall not apply to any program established by the Henry County 69 School Board prior to July 1, 2014.
