10	Be it enacted by the General Assembly of Virginia:
11	1. That §§ 59.1-310.3 and 59.1-310.5 of the Code of Virginia are amended and reenacted as
12	follows:
13	§ 59.1-310.3. Notice to customers; liability.
14	A. A tanning facility shall give each customer a written statement warning that:
15	1. Failure to use the eye protection provided to the customer by the tanning facility may result in
16	damage to the eyes;
17	2. Overexposure to ultraviolet light causes burns;
18	3. Repeated exposure may result in premature aging of the skin and skin cancer;
19	4. Abnormal skin sensitivity or burning may be caused by reactions of ultraviolet light to certain (i)
20	foods; (ii) cosmetics; or (iii) medications, including tranquilizers, diuretics, antibiotics, high blood
21	pressure medicines, or birth control pills; and
22 23	5. Any person taking a prescription or over-the-counter drug should consult a physician prior to
23 24	using a tanning device. B. Prior to allowing a prospective customer to use a tanning device, the owner or his designee shall
24 25	obtain on the written statement the signature of each customer on a duplicate of the written statement
23 26	provided to the customer under subsection A. In addition, the owner or his designee shall obtain, every
20 27	six months, the signature of the parent or legal guardian of a prospective customer who is under the
28	age of 15 and is not emancipated under Virginia law.
<b>2</b> 9	C. Compliance with the notice requirements does not affect the liability of a tanning facility owner
30	or a manufacturer of a tanning device.
31	D. The signed duplicates of the written statements provided under subsection A may be retained at a
32	location other than the tanning facility if an electronic or facsimile image of the original is readily
33	available at each of an owner's tanning facilities.
34	§ 59.1-310.5. Operational requirements.
35	A. A tanning facility shall have an operator present during operating hours. The operator shall be
36	sufficiently knowledgeable in the correct operation of the tanning devices used at the facility and shall
37	inform and assist each customer in the proper use of the tanning device.
38	B. The owner or his designee shall identify the skin type of the customer based on the Fitzpatrick
39	scale, document the skin type of the customer, and advise the customer of the customer's maximum time
40	of recommended exposure in the tanning device.
41	C. Before each use of a tanning device, the operator shall provide the customer with properly
42	sanitized protective eyewear that protects the eyes from ultraviolet radiation and allows adequate vision
43	to maintain balance. The operator shall not allow a person to use a tanning device if that person has not
44 45	been provided protective eyewear. The operator shall also instruct each customer how to use suitable
45	physical aids, such as handrails and markings on the floor, to maintain proper exposure distance as
46 47	recommended by the manufacturer of the tanning device. D. After each use of a tanning device, the owner or his designee shall clean the device with a
48	cleaner or sanitizer capable of killing bacteria from any previous use.
<b>4</b> 9	E. The tanning facility shall use a timer with an accuracy of at least plus or minus ten 10 percent of
<b>5</b> 0	any selected time interval. The facility shall limit the exposure time of a customer on a tanning device
50 51	to the maximum exposure time recommended by the manufacturer. The facility shall control the interior
52	temperature of a tanning device so that it may not exceed 100 degrees Fahrenheit.
53	F. Either each time a customer uses a tanning facility or each time a person executes or renews a
54	contract to use a tanning facility, the person shall sign a written statement acknowledging that the person
55	has read and understood the required warnings before using the device and agrees to use the protective
56	eyewear that the tanning facility provides.
57	G. An individual age 17 years or younger shall not be allowed to use any tanning device at a
58	tanning facility. The owner shall be responsible for ensuring that each customer using the tanning

facility is of legal age to do so.H. A tanning facility shall not claim, or distribute promotional material that claims that the use of a tanning device is safe, is without risk, or will result in medical or health benefits. 60 61
