10	Be it enacted by the General Assembly of Virginia:
11	1. That the Code of Virginia is amended by adding a section numbered 54.1-4201.2 as follows:
12	§ 54.1-4201.2. Firearm transactions by persons other than dealers; voluntary background checks.
13	A. The Department of State Police shall be available at every firearms show held in the
14	Commonwealth to make determinations in accordance with the procedures set out in § 18.2-308.2:2 of
15	whether a prospective purchaser or transferee is prohibited under state or federal law from possessing a
16	firearm. The Department of State Police shall establish policies and procedures in accordance with 28
17	C.F.R. § 25.6 to permit such determinations to be made by the Department of State Police.
18	Unless otherwise required by state or federal law, any party involved in the transaction may decide
19 20	whether or not to have such a determination made.
20 21	The Department of State Police may charge a reasonable fee for the determination. B. The promoter, as defined in § 54.1-4201.1, shall give the Department of State Police notice of the
$\frac{21}{22}$	time and location of a firearms show at least 30 days prior to the show. The promoter shall ensure that
$\overline{23}$	a notice that such determinations are available is prominently displayed at the show. The promoter shall
24	furnish the Department of State Police with facilities at the firearms show sufficient to permit the
25	Department of State Police to make the determinations pursuant to subsection A. The promoter shall
26	reimburse the Department of State Police for the actual costs incurred by the Department of State
27	Police for being available at the firearms show, including the costs of the necessary personnel and
28	equipment to make determinations pursuant to subsection A.
29	C. No person who sells or transfers a firearm at a firearms show after receiving a determination
30	from the Department of State Police that the purchaser or transferee is not prohibited by state or
31	federal law from possessing a firearm shall be liable for selling or transferring a firearm to such
32 33	<i>person.</i> 2. That the provisions of this act shall become effective only if approval is received from the U.S.
33 34	Department of Justice for the Department of State Police to implement the policies and procedures
35	set out in this act.
36	3. That the provisions of this act may result in a net increase in periods of imprisonment or
37	commitment. Pursuant to § 30-19.1:4, the estimated amount of the necessary appropriation cannot
38	be determined for periods of imprisonment in state adult correctional facilities; therefore, Chapter
39	806 of the Acts of Assembly of 2013 requires the Virginia Criminal Sentencing Commission to
40	assign a minimum fiscal impact of \$50,000. Pursuant to \$ 30-19.1:4, the estimated amount of the
41	necessary appropriation is \$0 for periods of commitment to the custody of the Department of
42	Juvenile Justice.
