10	Be it enacted by the General Assembly of Virginia:
11 12	1. That § 15.2-4832 of the Code of Virginia is amended and reenacted as follows:
12	§ 15.2-4832. Composition of Authority; membership; terms.
13	The Authority shall consist of 17 14 members as follows:
14	1. The chief elected officer of the governing body of each county and city embraced by the
15	Authority or, in the discretion of the chief elected officer, his designee, who shall be a current elected
16	officer of such governing body; and
17	Two members of the House of Delegates who reside in different counties or cities embraced by the
18	Authority, appointed by the Speaker of the House, to the extent practicable, from the membership of the
19	House Committee on Appropriations, the House Committee on Finance, or the House Committee on
20	Transportation;
21	One member of the Senate who resides in a county or city embraced by the Authority, appointed by
22	the Senate Committee on Rules, to the extent practicable, from the membership of the Senate Committee
23	on Finance and the Senate Committee on Transportation; and
24	2. Two citizens who reside in counties and cities embraced by the Authority, appointed by the
25	Governor. One gubernatorial appointment shall include a member of the Commonwealth Transportation
26 27	Board who resides in a county or city embraced by the Authority. The remaining gubernatorial
27 28	appointment shall be a person who has significant experience in transportation planning, finance,
20 29	engineering, construction, or management and shall be a resident of a county or city embraced by the Authority, but shall not be a resident of the same county or city as the other gubernatorial appointee to
29 30	the Authority. Neither of the two gubernatorial appointees shall be a member of the General Assembly.
30 31	Legislative Ex officio members shall serve terms coincident with their terms of office. The
31 32	gubernatorial appointee who is not a member of the Commonwealth Transportation Board shall serve for
33	a term of four years. Vacancies occurring other than by expiration of a term shall be filled for the
34	unexpired term. Vacancies shall be filled in the same manner as the original appointments.
35	In addition, the following persons shall serve as nonvoting members of the Authority: the Director of

In addition, the following persons shall serve as nonvoting members of the Authority: the Director of the Virginia Department of Rail and Public Transportation, or his designee; the Commissioner of Highways, or his designee; and the chief elected officer of one town in a county which the Authority embraces to be chosen by the Authority. The Authority shall appoint the chairman and vice-chairman. 36 37 38 39
