generously supported local organizations, including the Alexandria Symphony Orchestra, the Boys and
Girls Club, Senior Services of Alexandria, youth sports leagues, and The Fund for Alexandria's Child;

20 served as a member of the board of the Inova Alexandria Hospital, a past president of the Rotary Club

WHEREAS, known for his selfless charitable work and support for community organizations, T. J.Fannon was named as one of the Living Legends of Alexandria in 2009; and

WHEREAS, T. J. Fannon also earned the At Home in Alexandria Community Spirit Award in
October 2013 for his work with an organization that helps older Alexandria residents continue living in
their own homes; and
WHEREAS, an avid outdoorsman, T. J. Fannon enjoyed skiing, sailing, bicycling, and hiking at
