HOUSE JOINT RESOLUTION NO. 66

Proposing an amendment or amendments to Section 6 of Article II of the Constitution of Virginia, relating to districts for the United States House of Representatives and the General Assembly; criteria for redistricting; establishment of the Virginia Redistricting Commission.

RESOLVED by the House of Delegates, the Senate concurring, a majority of the members elected to each house agreeing, That the following amendment to the Constitution of Virginia be, and the same hereby is, proposed and referred to the General Assembly at its first regular session held after the next general election of members of the House of Delegates for its concurrence in conformity with the provisions of Section 1 of Article XII of the Constitution of Virginia, namely:

Amend Section 6 of Article II of the Constitution of Virginia as follows:

ARTICLE II

FRANCHISE AND OFFICERS

Section 6. ~~Apportionment~~ *Districts for the House of Representatives and General Assembly; Virginia Redistricting Commission.*

(a) Members of the House of Representatives of the United States and members of the Senate and of the House of Delegates of the General Assembly shall be elected from electoral districts established by the ~~General Assembly~~ *Virginia Redistricting Commission*. Every electoral district shall be composed of contiguous and compact territory and shall be so constituted as to give, as nearly as is practicable, representation in proportion to the population of the district. ~~The General Assembly shall reapportion the Commonwealth into electoral districts in accordance with this section in the year 2011 and every ten years thereafter.~~

~~Any such decennial reapportionment law shall take effect immediately and not be subject to the limitations contained in Article IV, Section 13, of this Constitution.~~

The districts delineated in the decennial reapportionment law shall be implemented for the November general election for the United States House of Representatives, Senate, or House of Delegates, respectively, that is held immediately prior to the expiration of the term being served in the year that the reapportionment law is required to be enacted. A member in office at the time that a decennial redistricting law is enacted shall complete his term of office and shall continue to represent the district from which he was elected for the duration of such term of office so long as he does not move his residence from the district from which he was elected. Any vacancy occurring during such term shall be filled from the same district that elected the member whose vacancy is being filled.

(b) *To the extent consistent with subsection (a), district boundaries shall coincide with the boundaries of political subdivisions of the Commonwealth. The number of counties and cities divided among more than one district shall be as few as practicable. When there is a choice between dividing local political subdivisions, the more populous subdivisions shall be divided before the less populous.*

(c) *No district shall be drawn for the purpose of favoring a political party or incumbent legislator or member of Congress. In establishing districts, no use shall be made of any of the following data:*

(1) *Addresses of incumbent legislators or members of Congress.*

(2) *Political affiliation of registered voters.*

(3) *Previous election results.*

(4) *Demographic information, other than population counts, except as required by the Constitution and laws of the United States.*

(d) *After the next and every subsequent decennial census of the United States, the districts for the House of Representatives, Senate, and House of Delegates shall be established, and the members of the House of Representatives, Senate, and House of Delegates shall be apportioned among the districts, respectively, by the Virginia Redistricting Commission. The Commission shall consist of thirteen members, none of whom shall be a member or employee of the Congress of the United States or of the General Assembly. The members of the Commission shall be appointed with due consideration to geographic diversity and in the manner provided herein.*

(e) *There first shall be appointed twelve members as follows:*

(1) *Two members, to be appointed by the President pro tempore of the Senate;*

(2) *Two members, to be appointed by the Speaker of the House of Delegates;*

59 (3) Two members, to be appointed by the leader in the Senate of the political party holding the most
60 seats in the Senate, other than the political party of the President pro tempore;

61 (4) Two members, to be appointed by the leader in the House of Delegates of the political party
62 holding the most seats in the House of Delegates, other than the political party of the Speaker; and

63 (5) Four members, two to be appointed by the chairman of the state committee of the political party
64 whose candidate for the office of Governor received the largest number of votes at the most recent
65 gubernatorial election, and two to be appointed by the chairman of the state committee of the political
66 party whose candidate for the office of Governor received the next largest number of votes at the most
67 recent gubernatorial election.

68 Appointments to the Commission under this subsection shall be made on or before July 1 of the year
69 in which such census is taken and shall be certified to the Secretary of the Commonwealth on or before
70 July 15 of that year. Each partisan delegation so appointed shall appoint one of its members as its
71 chairman, who shall have authority to make such certifications and to perform other tasks as the
72 members of that delegation shall reasonably require.

73 (f) There then shall be appointed one member to serve as an independent member. The independent
74 member shall have been a resident of the Commonwealth for the preceding five years but shall not have
75 held public or political party office in the Commonwealth during that period. The independent member
76 shall be appointed upon the vote of at least seven of the previously appointed members of the
77 Commission on or before August 15 of the year in which the census is taken, and those members shall
78 certify that appointment to the Secretary of the Commonwealth on or before September 1 of that year. If
79 the previously appointed members are unable to appoint an independent member within the time allowed
80 for such appointment, they shall so certify to the Supreme Court not later than that September 1 and
81 shall include in that certification the names of the two person who, in the members' final vote for
82 appointment of the independent member, received the greatest number of votes. Not later than
83 September 15 following receipt of that certification, the Supreme Court shall by majority vote of its full
84 authorized membership select, of the two persons so named, the one more qualified by education,
85 occupational experience, and demonstrated ability to represent the best interests of the people of the
86 Commonwealth to be the independent member. The Court shall certify that selection to the Secretary of
87 the Commonwealth not later than the following October 1.

88 (g) The term of office for each member of the Commission shall expire upon the appointment of the
89 first member of the succeeding Commission. Vacancies in the member of the Commission occurring
90 prior to the certification by the Commission of the districts for the House of Representatives, Senate,
91 and House of Delegates, or during any period in which the districts established by the Commission may
92 be or are under challenge in court shall be filled in the same manner as the original appointments were
93 made within five days of their occurrence. In the case of a vacancy in the membership of the
94 independent member, if the other members of the Commission are unable to fill that vacancy within that
95 five-day period, they shall submit certification of such inability within three days of the expiration of the
96 period to the Supreme Court, which shall select the person to fill the vacancy within five days of receipt
97 of that certification.

98 (h) The independent member shall serve as the Chairman of the Commission. The Commission shall
99 meet to organize as soon as may be practicable after certification of the appointment of the independent
100 member, but not later than December 1 of the year in which the census is taken. At the organizational
101 meeting, the members of the Commission shall determine organizational matters as they deem
102 appropriate. Thereafter, a meeting of the Commission may be called by the Chairman or upon the
103 request of seven members. Seven members of the Commission shall constitute a quorum at any meeting
104 thereof for the purpose of taking any action.

105 (i) The Commission, by a majority of the whole number of its members, shall certify the
106 establishment of Senate and House of Delegates districts and the apportionment of members of the
107 Senate and the House of Delegates, respectively, to the Secretary of the Commonwealth within one
108 month of the receipt by the Governor of the official decennial census of the United States for Virginia,
109 or by April 1 of the year following the year in which the census is taken, whichever date is later.

110 (j) The Commission, by a majority of the whole number of its members, shall certify the
111 establishment of House of Representatives districts to the Secretary of the Commonwealth within three
112 months of the receipt by the Governor of the official decennial census of the United States for Virginia,
113 or by June 1 of the year following the year in which the census is taken, whichever date is later.

114 (k) The Commission, convened in an open public meeting and by a majority of the whole number of
115 its members, shall certify the establishment of districts. The Commission shall give at least twenty-four
116 hours' public notice of the meeting. Any vote by the Commission upon a proposal to certify the
117 establishment of a district plan shall be taken by roll call and shall be recorded, and the vote of any
118 member in favor of any district plan shall nullify any vote that that member shall previously have cast
119 during the life of the Commission in favor of a different district plan. If the Commission is unable to
120 certify the establishment of districts by the time required due to the inability of a plan to achieve seven

votes, the two district plans receiving the greatest number of votes, but not fewer than five votes, shall be submitted to the Supreme Court, which shall select and certify whichever of the two plans submitted conforms most closely to the requirements of this Constitution and the Constitution and laws of the United States.

(l) The Commission shall hold at least three public hearings in different parts of the Commonwealth on districts for the House of Representatives, Senate, and House of Delegates. The Commission shall, subject to the constraints of time and convenience, review plans for the establishment of districts submitted by members of the public.

(m) Meetings of the Commission shall be held at convenient times and locations. Meetings may be closed to the public with the exception of the public hearings required by subsection (l) and the portion of meetings at which the establishment of districts is certified as prescribed by subsections (i), (j), and (k).

(n) The General Assembly shall appropriate the funds necessary for the efficient operation of the Commission. The Commission shall have authority to employ staff and access resources sufficient for its operation.

(o) Notwithstanding any provision to the contrary of this Constitution and except as otherwise required by the Constitution or laws of the United States, no court of the Commonwealth other than the Supreme Court shall have jurisdiction over any judicial proceeding challenging the appointment of members to the Commission or any action, including the establishment of districts, by the Commission or other public officer or body under the provisions of this section.

(p) The districts established for the House of Representatives, Senate, or House of Delegates shall be used thereafter at any election of members of the House of Representatives, Senate, or House of Delegates, respectively, and shall remain unaltered through the next year ending in zero in which a federal census for the Commonwealth is taken. Members of the House of Representatives, Senate, or House of Delegates in office at the time districts are established by the Commission shall complete their terms of office and continue to represent their districts as constituted at the time of their election to office. Any vacancy occurring in the House of Representatives, Senate, or House of Delegates shall be filled from the district as constituted when the member whose vacancy is being filled was elected to office.

(q) If a plan certified by the Commission is declared unlawful, the Commission shall reorganize and adopt another district plan in the same manner as herein required and within the period of time prescribed by the court or within such shorter period as may be necessary to ensure that the new plan is effective for the next succeeding election for all members of the House of Representatives, Senate, or House of Delegates.
