A BILL to amend and reenact §§ 51.1-1402 and 51.1-1403 of the Code of Virginia, relating to health insurance credits for certain retired employees.

Be it enacted by the General Assembly of Virginia:

1. That §§ 51.1-1402 and 51.1-1403 of the Code of Virginia are amended and reenacted as follows:

§ 51.1-1402. Health insurance credits for retired local government employees.

A. Retired local government employees, whose localities have elected to participate in the Virginia Retirement System, including the hybrid retirement program described in § 51.1-169, who have rendered at least 15 years of total creditable service under the System shall receive a health insurance credit to their monthly retirement allowance, which shall be applied to reduce the retired member's health insurance premium cost, provided the retiree's employer elects to participate in the credit program. The amount of each monthly health insurance credit payable under this section shall be ~~\$1.50~~ \$4 for each full year of the retired member's creditable service; ~~not to exceed a maximum monthly credit of \$45;~~ however, each former member whose retirement was for disability, a participant receiving long-term disability pursuant to § 51.1-1157 or 51.1-1165, or a member of the hybrid retirement program receiving long-term disability pursuant to coverage under subsection A of § 51.1-1153 shall receive a *maximum* monthly health insurance credit ~~of \$45 that is the greater of (i) \$120, (ii) \$4 per year for each year of creditable service at the time of disability retirement, or (iii) \$4 per year for each year of creditable service at the time of eligibility for long-term disability.~~ Eligibility for the credit shall be determined in a manner prescribed by the Virginia Retirement System. Any member who elects to defer his retirement pursuant to subsection C of § 51.1-153 shall be entitled to receive the allowable credit provided by this section on the effective date of his retirement.

B. Those retired employees who purchase an alternative policy from a carrier or organization of their own choosing shall be eligible to receive a credit in the amount specified in subsection C. Eligibility for the credit and payment of the credit shall be determined in a manner prescribed by the Virginia Retirement System.

C. The credit shall be in the amount provided in subsection A or the amount of premium paid for the personal health insurance policy, whichever is less.

D. The cost of the monthly health insurance credit payable under this section shall be borne by the locality.

E. The Virginia Retirement System shall actuarially determine the amount necessary to fund all credits provided under this section, reflect the cost of such credits in the applicable employer contribution rate pursuant to § 51.1-145, and prescribe such terms and conditions as are necessary to carry out the provisions of this section. The costs associated with the administration of the health insurance credit program provided for in this section shall be recovered from the health insurance credit trust fund.

§ 51.1-1403. Health insurance credits for retired constitutional officers, employees of constitutional officers, general registrars, employees of general registrars, and local social service employees.

A. A local officer, as defined in § 51.1-124.3, general registrar, employee of a general registrar, or an employee of a local social services board, retired under the Virginia Retirement System, including the hybrid retirement program described in § 51.1-169, who rendered at least 15 years of total creditable service under the System shall receive a health insurance credit to his monthly retirement allowance, which shall be applied to reduce the retired member's health insurance premium cost. The amount of each monthly health insurance credit payable under this section shall be ~~\$1.50~~ \$4 for each full year of the retired member's creditable service; ~~not to exceed a maximum monthly credit of \$45;~~ however, each former member whose retirement was for disability, a participant receiving long-term disability pursuant to § 51.1-1157 or 51.1-1165, or a member of the hybrid retirement program receiving long-term disability pursuant to coverage under subsection A of § 51.1-1153 shall receive a *maximum* monthly health insurance credit ~~of \$45 that is the greater of (i) \$120, (ii) \$4 per year for each year of creditable service at the time of disability retirement, or (iii) \$4 per year for each year of creditable service at the time of eligibility for long-term disability.~~ Eligibility for the credit shall be determined in a manner

59 prescribed by the Virginia Retirement System. Any member who elects to defer his retirement pursuant
60 to subsection C of § 51.1-153 shall be entitled to receive the allowable credit provided by this section
61 on the effective date of his retirement. The cost of such credit shall be borne by the Commonwealth.

62 B. In addition to the health insurance credit authorized in subsection A, localities which participate in
63 the Virginia Retirement System may elect to provide an additional health insurance credit of \$1 per
64 month for each full year of the retired member's creditable service, not to exceed a maximum monthly
65 credit of \$30. The costs of such additional health insurance credit shall be borne by the locality.

66 C. 1. Those retired employees who purchase an alternative personal health insurance policy from a
67 carrier or organization of their own choosing shall be eligible to receive a credit in the amount specified
68 in subdivision C 2. Eligibility for the credit and payment of the credit shall be determined in a manner
69 prescribed by the Virginia Retirement System.

70 2. The credit shall be in (i) the amount provided in subsection A, or subsection A and subsection B
71 if the additional credit authorized by subsection B is provided or (ii) the amount of premium paid for
72 the personal health insurance policy, whichever is less.

73 D. Any person included in the membership of a retirement system provided by Chapter 1
74 (§ 51.1-124.1 et seq.), 2 (§ 51.1-200 et seq.), 2.1 (§ 51.1-211 et seq.), or 3 (§ 51.1-300 et seq.) who (i)
75 rendered at least 15 years of total creditable service as a local officer as defined in § 51.1-124.3 or as an
76 employee of a local social services board or combined service as a general registrar or an employee of a
77 general registrar and (ii) after terminating service as a local officer or employee of a local social
78 services board or general registrar or as an employee of a general registrar, was employed by a local
79 government that does not elect to provide a health insurance credit under § 51.1-1402, shall be eligible
80 for the credit provided by subsection A, provided that the retired employee is participating in a health
81 insurance plan. The Commonwealth shall be charged with the credit as provided for in subsection A. In
82 such case, the health insurance credit shall be determined based upon the amount of state service or
83 service as a local officer or service as an employee of a local social services board or combined service
84 as a general registrar or an employee of a general registrar, whichever is greater.

85 E. The Virginia Retirement System shall (i) actuarially determine the amount necessary to fund all
86 credits provided under this section, (ii) reflect the cost of such credits in the applicable employer
87 contribution rate pursuant to § 51.1-145, and (iii) prescribe such terms and conditions as are necessary to
88 carry out the provisions of this section. The costs associated with the administration of the health
89 insurance program provided for in this section shall be recovered from the health insurance credit trust
90 fund.
