14105103D 1 **SENATE BILL NO. 172** 2 AMENDMENT IN THE NATURE OF A SUBSTITUTE 3 (Proposed by the House Committee on Education 4 5 6 on February 19, 2014) (Patron Prior to Substitute—Senator Stuart) A BILL to amend and reenact § 22.1-271.5 of the Code of Virginia, relating to student-athletes; 7 concussion guidelines and policies. 8 Be it enacted by the General Assembly of Virginia: 9 1. That § 22.1-271.5 of the Code of Virginia is amended and reenacted as follows: § 22.1-271.5. Guidelines and policies and procedures on concussions in student-athletes. 10 11 A. The Board of Education shall develop and distribute to each local school division guidelines on policies to inform and educate coaches, student-athletes, and their parents or guardians of the nature and 12 risk of concussions, criteria for removal from and return to play, and risks of not reporting the injury 13 14 and continuing to play, and the effects of concussions on student-athletes' academic performance. 15 B. Each local school division shall develop policies and procedures regarding the identification and 16 handling of suspected concussions in student-athletes. Such policies shall require: 17 1. In order to participate in any extracurricular physical activity, each student-athlete and the student-athlete's parent or guardian shall review, on an annual basis, information on concussions 18 provided by the local school division. After having reviewed materials describing the short- and 19 20 long-term health effects of concussions, each student-athlete and the student-athlete's parent or guardian 21 shall sign a statement acknowledging receipt of such information, in a manner approved by the Board of 22 Education: and 23 2. A student-athlete suspected by that student-athlete's coach, athletic trainer, or team physician of 24 sustaining a concussion or brain injury in a practice or game shall be removed from the activity at that 25 time. A student-athlete who has been removed from play, evaluated, and suspected to have a concussion or brain injury shall not return to play that same day nor until (i) evaluated by an appropriate licensed 26 health care provider as determined by the Board of Education and (ii) in receipt of written clearance to 27 28 return to play from such licensed health care provider. 29 The licensed health care provider evaluating student-athletes suspected of having a concussion or 30 brain injury may be a volunteer. 31 C. Each non-interscholastic youth sports program utilizing public school property shall either (i) 32 establish policies and procedures regarding the identification and handling of suspected concussions in student-athletes, consistent with either the local school division's policies and procedures developed in 33 34 compliance with this section or the Board's Guidelines for Policies on Concussions in Student-Athletes, 35 or (ii) follow the local school division's policies and procedures as set forth in subsection B. In addition, 36 local school divisions may provide the guidelines to organizations sponsoring athletic activity for 37 student-athletes on school property. Local school divisions shall not be required to enforce compliance 38 with such policies. 39 D. As used in this section, "non-interscholastic youth sports program" means a program organized 40 for recreational athletic competition or recreational athletic instruction for youth. 2. That the Board of Education shall review and revise the guidelines as necessary, pursuant to 41 subsection A of § 22.1-271.5 of the Code of Virginia, and shall work with the Virginia High School 42 League, the Department of Health, the Virginia Athletic Trainers Association, the Virginia 43 Physical Therapy Association, representatives of the Children's Hospital of the King's Daughters 44 and the Children's National Medical Center, the Brain Injury Association of Virginia, the 45 American Academy of Pediatrics, the Virginia College of Emergency Physicians, the Virginia 46 Academy of Family Physicians, the Virginia Association of School Nurses, a representative from a 47 non-interscholastic youth sports program, and any other interested stakeholders. **48**
