Be it enacted by the General Assembly of Virginia:

7 1. That §§ 3.2-6581 and 3.2-6582 of the Code of Virginia are amended and reenacted as follows: 8 § 3.2-6581. Definitions. 9

As used in this article:

"Adequate confinement" means that, while on the property of its owner and not under the direct 10 11 supervision and control of the owner or custodian, a hybrid canine shall be confined in a humane manner in a securely enclosed and locked structure of sufficient height and design to: (i) prevent the 12 13 animal's escape; or if the hybrid canine is determined to be a dangerous dog pursuant to § 3.2-6540, the 14 structure shall prevent direct contact with any person or animal not authorized by the owner to be in 15 direct contact with the hybrid canine; and (ii) provide a minimum of 100 square feet of floor space for each adult animal. Tethering of a hybrid canine not under the direct supervision and control of the 16 17 owner or custodian shall not be considered adequate confinement.

18 "Hybrid canine" means any animal that is or can be demonstrated to be a hybrid of the domestic dog 19 and any other species of the Canidae family; that at any time has been permitted, registered, licensed, 20 or advertised as such; or that at any time has been or is permitted, registered, licensed, advertised or otherwise described, represented, or represented as a hybrid canine, wolf or covote reported as such by 21 22 its owner to a licensed veterinarian, law-enforcement officer, animal control officer, humane investigator, 23 official of the Department of Health, or State Veterinarian's representative.

24 "Responsible ownership" means the ownership and humane care of a hybrid canine in such a manner 25 as to comply with all laws and ordinances regarding hybrid canines and prevent endangerment by the 26 animal to public health and safety. 27

§ 3.2-6582. Hybrid canine ordinance; penalty.

28 A. Any locality may, by ordinance, establish a permit system to ensure the adequate confinement and 29 responsible ownership of hybrid canines. Such ordinance may include requirements pertaining to: (i) the 30 term and expiration date of the permit; (ii) the number of hybrid canines that may be owned by a 31 permittee; (iii) identification tags or tattooing of the animal; (iv) where the animal may be kept; (v) 32 handling of the animal while not on the property of the owner; and (vi) information required to be 33 provided when applying for a permit, such as the sex, color, height, vaccination records, length, or 34 identifying marks of the hybrid canine. The ordinance shall not require that hybrid canines be disposed 35 of by the owner unless the owner fails to obtain or renew any required permit or violates a provision of 36 the ordinance or any other law pertaining to the responsible ownership of the hybrid canine. The locality 37 may impose a permit fee to cover the cost of the permitting system.

38 B. Violation of an ordinance enacted pursuant to this section subsection A is a Class 3 misdemeanor 39 for the first violation and a Class 1 misdemeanor for any subsequent violation. The ordinance may 40 require a violator to surrender the hybrid canine for euthanasia in accordance with § 3.2-6562.

41 C. The provisions of this section subsections A and B shall not affect any ordinance adopted prior to 42 July 1, 1997.

43 D. Any locality may, by ordinance, prohibit the keeping of hybrid canines. SB444ER
