### VIRGINIA ACTS OF ASSEMBLY - CHAPTER

2 An Act to amend and reenact § 8.01-465.23 of the Code of Virginia, to amend the Code of Virginia by adding in Chapter 17.2 of Title 8.01 sections numbered 8.01-465.13:1 through 8.01-465.13:11, and 3 to repeal §§ 8.01-465.6 through 8.01-465.13 of the Code of Virginia, relating to the Uniform 4 5 Foreign-Country Money Judgments Recognition Act.

8 Be it enacted by the General Assembly of Virginia:

9 1. That § 8.01-465.23 of the Code of Virginia is amended and reenacted and that the Code of 10 Virginia is amended by adding in Chapter 17.2 of Title 8.01 sections numbered 8.01-465.13:1 11 through 8.01-465.13:11 as follows:

12 CHAPTER 17.2. UNIFORM FOREIGN COUNTRY MONEY JUDGMENTS FOREIGN-COUNTRY MONEY JUDGMENTS 13 14 **RECOGNITION ACT.** 

15 § 8.01-465.13:1. Definitions.

As used in this chapter:

"Foreign country" means a government other than any of the following: the United States; a state, 17 18 district, commonwealth, territory, or insular possession of the United States; or a government with 19 regard to which the decision in the Commonwealth as to whether to recognize a judgment of that 20 government's courts is initially subject to determination under the Full Faith and Credit Clause of the 21 United States Constitution. 22

"Foreign-country judgment" means a judgment of a court of a foreign country.

## § 8.01-465.13:2. Applicability.

A. Except as otherwise provided in subsection B, this chapter applies to a foreign-country judgment to the extent that the judgment:

1. Grants or denies recovery of a sum of money; and

2. Under the law of the foreign country where rendered, is final, conclusive, and enforceable.

28 B. This chapter does not apply to a foreign-country judgment, even if the judgment grants or denies 29 recovery of a sum of money, to the extent that the judgment is:

30 1. A judgment for taxes; 31

2. A fine or other penalty; or

32 3. A judgment for divorce, support, or maintenance, or other judgment rendered in connection with 33 domestic relations.

34 C. A party seeking recognition of a foreign-country judgment has the burden of establishing that this 35 chapter applies to the foreign-country judgment. 36

### § 8.01-465.13:3. Standards for recognition of foreign-country judgment.

37 A. Except as otherwise provided in subsections B and C, a court of the Commonwealth shall 38 recognize a foreign-country judgment to which this chapter applies.

39 B. A court of the Commonwealth shall not recognize a foreign-country judgment if:

40 1. The judgment was rendered under a judicial system that does not provide impartial tribunals or 41 procedures compatible with the requirements of due process of law; 42

2. The foreign court did not have personal jurisdiction over the defendant; or 43

3. The foreign court did not have jurisdiction over the subject matter.

C. A court of the Commonwealth need not recognize a foreign-country judgment if:

45 1. The defendant in the proceeding in the foreign court did not receive notice of the proceeding in sufficient time to enable the defendant to defend; 46

2. The judgment was obtained by fraud that deprived the losing party of an adequate opportunity to 47 48 present its case;

49 3. The judgment or the cause of action on which the judgment is based is repugnant to the public 50 policy of the Commonwealth or of the United States; 51

4. The judgment conflicts with another final and conclusive judgment;

5. The proceeding in the foreign court was contrary to an agreement between the parties under 52 53 which the dispute in question was to be determined otherwise than by proceedings in that foreign court; 54 6. In the case of jurisdiction based only on personal service, the foreign court was a seriously

55 inconvenient forum for the trial of the action;

56 7. The judgment was rendered in circumstances that raise substantial doubt about the integrity of the SB473ER

57 rendering court with respect to the judgment; or

58 8. The specific proceeding in the foreign court leading to the judgment was not compatible with the 59 requirements of due process of law.

60 D. A party resisting recognition of a foreign-country judgment has the burden of establishing that a 61 ground for nonrecognition stated in subsection B or C exists.

#### 62 § 8.01-465.13:4. Personal jurisdiction.

63 A. A foreign-country judgment may not be refused recognition for lack of personal jurisdiction if:

64 1. The defendant was served with process personally in the foreign country;

65 2. The defendant voluntarily appeared in the proceeding, other than for the purpose of protecting 66 property seized or threatened with seizure in the proceeding or of contesting the jurisdiction of the court 67 over the defendant;

68 3. The defendant, before the commencement of the proceeding, had agreed to submit to the 69 jurisdiction of the foreign court with respect to the subject matter involved;

70 4. The defendant was domiciled in the foreign country when the proceeding was instituted or was a 71 corporation or other form of business organization that had its principal place of business in, or was 72 organized under the laws of, the foreign country;

73 5. The defendant had a business office in the foreign country and the proceeding in the foreign court 74 involved a cause of action arising out of business done by the defendant through that office in the 75 foreign country; or

76 6. The defendant operated a motor vehicle or airplane in the foreign country and the proceeding 77 involved a cause of action arising out of that operation.

78 B. The list of bases for personal jurisdiction in subsection A is not exclusive. The courts of the 79 Commonwealth may recognize bases of personal jurisdiction other than those listed in subsection A as 80 sufficient to support a foreign-country judgment. 81

## § 8.01-465.13:5. Procedure for recognition of foreign-country judgment.

82 A. If recognition of a foreign-country judgment is sought as an original matter, the issue of 83 recognition shall be raised by filing an action seeking recognition of the foreign-country judgment.

84 B. If recognition of a foreign-country judgment is sought in a pending action, the issue of 85 recognition may be raised by counterclaim, cross-claim, or affirmative defense. 86

§ 8.01-465.13:6. Effect of recognition of foreign-country judgment.

87 If the court in a proceeding under § 8.01-465.13:5 finds that the foreign-country judgment is entitled 88 to recognition under this chapter then, to the extent that the foreign-country judgment grants or denies 89 recovery of a sum of money, the foreign-country judgment is:

90 1. Conclusive between the parties to the same extent as the judgment of a sister state entitled to full 91 faith and credit in the Commonwealth would be conclusive; and

92 2. Enforceable in the same manner and to the same extent as a judgment rendered in the 93 Commonwealth.

#### 94 § 8.01-465.13:7. Stay of proceedings pending appeal of foreign-country judgment.

95 If a party establishes that an appeal from a foreign-country judgment is pending or will be taken, the 96 court may stay any proceedings with regard to the foreign-country judgment until the appeal is 97 concluded, the time for appeal expires, or the appellant has had sufficient time to prosecute the appeal 98 and has failed to do so. 99

## § 8.01-465.13:8. Statute of limitations.

100 An action to recognize a foreign-country judgment must be commenced within the earlier of the time 101 during which the foreign-country judgment is effective in the foreign country or 15 years from the date 102 that the foreign-country judgment became effective in the foreign country.

#### 103 § 8.01-465.13:9. Uniformity of interpretation.

104 In applying and construing this uniform act, consideration must be given to the need to promote 105 uniformity of the law with respect to its subject matter among states that enact it.

### § 8.01-465.13:10. Saving clause. 106

This chapter does not prevent the recognition under principles of comity or otherwise of a 107 108 foreign-country judgment not within the scope of this chapter.

#### 109 § 8.01-465.13:11. Effective date.

110 This chapter applies to all actions commenced on or after July 1, 2014, in which the issue of recognition of a foreign-country judgment is raised. 111

#### § 8.01-465.23. Enforcement of foreign judgments. 112

If an action is brought to enforce a judgment of another jurisdiction expressed in a foreign money 113 and the judgment is enforceable in the Commonwealth, the enforcing judgment must be entered as 114 115 provided in § 8.01-465.20, whether or not the foreign judgment confers an option to pay in an equivalent amount of United States dollars. 116

117 A foreign judgment may be filed in accordance with Chapter 17.1 (§ 8.01-465.1 et seq.) and or 118 Chapter 17.2 (§ 8.01-465.6 8.01-465.13:1 et seq.) of this title.

119 À satisfaction or partial payment made upon the foreign judgment, on proof thereof, must be credited 120 against the amount of foreign money specified in the judgment, notwithstanding the entry of judgment 121 in the Commonwealth.

A judgment entered on a foreign-money claim only in United States dollars in another state shall be enforced in United States dollars only.

124 2. That §§ 8.01-465.6 through 8.01-465.13 of the Code of Virginia are repealed.
