- Be it enacted by the General Assembly of Virginia:

6 7 1. That § 47.1-23 of the Code of Virginia is amended and reenacted and that the Code of Virginia 8

## is amended by adding a section numbered 47.1-15.1 as follows: 9

§ 47.1-15.1. Additional prohibition on advertising; penalties.

10 A. A notary public shall not offer or provide legal advice on immigration or other legal matters, or 11 represent any person in immigration proceedings, unless such notary public is authorized or licensed to 12 practice law in the Commonwealth or is accredited pursuant to 8 C.F.R. § 292.2 to practice immigration 13 law or represent persons in immigration proceedings.

14 B. A notary public shall not assume, use, or advertise the title of "notario," "notario publico," or 15 "licenciado," or a term in a language other than English that indicates in such language that the notary 16 is authorized to provide legal advice or practice law, unless such notary public is authorized or licensed 17 to practice law in Virginia.

18 C. Any person who violates the provisions of subsection B is subject to a civil penalty not to exceed 19 \$500 for a first violation and a civil penalty not to exceed \$1,000 for a second or subsequent violation. All penalties arising under this section shall be recovered in a civil action brought by the Attorney 20 21 General in the name of the Commonwealth and the proceeds shall be deposited into the Legal Aid 22 Services Fund established in § 17.1-278.

23 D. Nothing in this section shall preempt or preclude additional civil, administrative, or criminal 24 penalties authorized by law. 25

## § 47.1-23. Grounds for removal from office.

The Secretary may revoke the commission of any notary who:

26 27 1. Submits or has submitted an application for commission and appointment as a notary public which contains a substantial and material misstatement of fact; 28

29 2. Is convicted or has been convicted of any felony under the laws of the United States or this 30 Commonwealth, or the laws of any other state, unless the notary has been pardoned for such offense, 31 has had his conviction vacated by a granting of a writ of actual innocence, or has had his rights 32 restored;

33 3. Is found to have committed official misconduct by a proceeding as provided in Chapter 5 34 (§ 47.1-24 et seq.);

35 4. Fails to exercise the powers or perform the duties of a notary public in accordance with this title, provided that if a notary is adjudged liable in any court of the Commonwealth in any action grounded in 36 fraud, misrepresentation, impersonation, or violation of the notary laws of the Commonwealth, such 37 38 notary shall be presumed removable under this section;

39 5. Performs a prohibited act pursuant to § 47.1-15 or 47.1-15.1;

40 6. Is convicted of the unauthorized practice of law pursuant to § 54.1-3904, or is a licensed attorney 41 at law whose license is suspended or revoked;

- 43 8. Becomes incapable of reading or writing the English language;

10. Fails to keep the official physical seal, journal, or device, coding, disk, certificate, card, software, 45

or passwords used to affix the notary's official electronic signature or seal under the exclusive control of 46 the notary when not in use. 47
