14103734D **SENATE BILL NO. 8** 1 2 AMENDMENT IN THE NATURE OF A SUBSTITUTE 3 (Proposed by the Senate Committee on Transportation 4 on January 22, 2014) 5 6 (Patron Prior to Substitute—Senator Garrett) A BILL to amend and reenact § 46.2-116 of the Code of Virginia, relating to registration as a tow truck 7 driver after conviction of a violent crime. 8 Be it enacted by the General Assembly of Virginia: 9 1. That § 46.2-116 of the Code of Virginia is amended and reenacted as follows: 10 § 46.2-116. Registration with Department of Criminal Justice Services required for tow truck 11 drivers; penalty. A. As used in this section and §§ 46.2-117, 46.2-118, and 46.2-119: 12 13 "Consumer" means a person who (i) has vested ownership, dominion, or title to the vehicle; (ii) is the authorized agent of the owner as defined in clause (i); or (iii) is an employee, agent, or 14 representative of an insurance company representing any party involved in a collision that resulted in a 15 police-requested tow who represents in writing that the insurance company had obtained the oral or 16 17 written consent of the title owner or his agent or the lessee of the vehicle to obtain possession of the 18 vehicle. 19 "Department" means the Department of Criminal Justice Services. 20 "Tow truck driver" means an individual who drives a tow truck as defined in § 46.2-100. 21 "Towing and recovery operator" means any person engaging in the business of providing or offering 22 to provide services involving the use of a tow truck and services incidental to use of a tow truck. 23 "Towing and recovery operator" shall not include a franchised motor vehicle dealer as defined in 24 § 46.2-1500 using a tow truck owned by a dealer when transporting a vehicle to or from a repair facility 25 owned by the dealer when the dealer does not receive compensation from the vehicle owner for towing of the vehicle or when transporting a vehicle in which the dealer has an ownership or security interest. 26 27 B. On and after January 1, 2013, no tow truck driver shall drive any tow truck without being 28 registered with the Department, except that this requirement shall not apply to any holder of a tow truck 29 driver authorization document issued pursuant to former § 46.2-2814 until the expiration date of such 30 document. Every applicant for an initial registration or renewal of registration pursuant to this section shall submit his registration application, fingerprints, and personal descriptive information to the 31 Department and a nonrefundable application fee of \$100. The Department shall forward the personal 32 descriptive information along with the applicant's fingerprints through the Central Criminal Records 33 34 Exchange to the Federal Bureau of Investigation for the purpose of obtaining a national criminal history 35 record check regarding such applicant. The cost of the fingerprinting and criminal history record check 36 shall be paid by the applicant. 37 The Central Criminal Records Exchange, upon receipt of an applicant's record or notification that no 38 record exists, shall make a report to the Department. If an applicant is denied registration as a tow truck 39 driver because of the information appearing in his criminal history record, the Department shall notify 40 the applicant that information obtained from the Central Criminal Records Exchange contributed to such 41 denial. The information shall not be disseminated except as provided in this section. 42 C. No registration shall be issued to any person who (i) is required to register as a sex offender as provided in § 9.1-901 or in a substantially similar law of any other state, the United States, or any 43 foreign jurisdiction; (ii) has been convicted of a violent crime as defined in subsection C of § 17.1-805 44 unless such person held a valid tow truck driver authorization document on January 1, 2013 issued by 45 the Board of Towing and Recovery Operators pursuant to former Chapter 28 (§ 46.2-2800 et seq.), and 46 has not been convicted of a violent crime as defined in subsection C of § 17.1805 subsequent to the 47 abolition of the Board; or (iii) has been convicted of any crime involving the driving of a tow truck, **48** 49 including drug or alcohol offenses, but not traffic infraction convictions. Any person registered pursuant 50 to this section shall report to the Department within 10 days of conviction any convictions for felonies 51 or misdemeanors that occur while he is registered with the Department. D. Any tow truck driver failing to register with the Department as required by this section is guilty 52 53 of a Class 3 misdemeanor. A tow truck driver registered with the Department shall have such 54 registration in his possession whenever driving a tow truck on the highways. E. Registrations issued by the Department pursuant to this section shall be valid for a period not to 55 exceed 24 months, unless revoked or suspended by the Department in accordance with § 46.2-117. 56 2. That an emergency exists and this act is in force from its passage. 57
