10 11	Be it enacted by the General Assembly of Virginia:
11	1. That §§ 2.2-208, 22.1-23, and 23-224 of the Code of Virginia are amended and reenacted as follows:
13	§ 2.2-208. Position established; agencies for which responsible; powers and duties.
14	A. The position of Secretary of Education (the "Secretary") is created. The Secretary shall be
15	responsible to the Governor for the following agencies: Department of Education, State Council of
16	Higher Education, Virginia Museum of Fine Arts, The Science Museum of Virginia, Frontier Culture
17	Museum of Virginia, The Library of Virginia, Jamestown-Yorktown Foundation, Board of Regents of
18	Gunston Hall, the Commission for the Arts, and the Board of Visitors of the Virginia School for the
19 20	Deaf and the Blind. The Governor may, by executive order, assign any other state executive agency to the Secretary, or reassign any agency listed above to another Secretary.
20 21	<i>B.</i> Unless the Governor expressly reserves such a power to himself, the Secretary is empowered to
22	may (i) resolve administrative, jurisdictional, or policy conflicts between any agencies or officers for
23	which he is responsible and to ( <i>ii</i> ) provide policy direction for programs involving more than a single
24	agency. He is authorized to
25	C. The Secretary may direct the preparation of alternative policies, plans, and budgets for education
26 27	for the Governor and, to that end, may require the assistance of the agencies for which he is responsible. He
28	<i>D. The Secretary</i> shall direct the formulation of a comprehensive program budget for cultural affairs
29	encompassing the programs and activities of the agencies involved in cultural affairs.
30	E. The Secretary shall consult with the agencies for which he is responsible and biennially report to
31	the General Assembly on the coordination efforts among such agencies.
32 33	§ 22.1-23. Duties in general.
33 34	The Superintendent of Public Instruction shall: 1. Serve as secretary of the Board of Education;
35	2. Provide such assistance in his office as shall be necessary for the proper and uniform enforcement
36	of the provisions of the school laws in cooperation with the local school authorities;
37	3. Prepare and furnish such forms for attendance officers, teachers and other school officials as are
38	required by law;
39 40	4. (Expires July 1, 2015) At least annually, survey all local school divisions to identify critical
40 41	shortages of teachers and administrative personnel by geographic area, by school division, or by subject matter, and report such critical shortages to each local school division and to the Virginia Retirement
42	System;
43	5. Along with the State Health Commissioner, work to combat childhood obesity and other chronic
44	health conditions that affect school-age children; and
45	6. Designate an employee of the Department of Education to serve as its liaison to the State Council
46 47	<i>of Higher Education for Virginia and the State Board for Community Colleges; and</i> 7. Perform such other duties as the Board of Education may prescribe.
48	§ 23-224. Duties of Chancellor generally.
49	(a) It shall be the duty of the A. The Chancellor of Community Colleges to shall formulate such
50	rules and regulations, and provide for such assistance in his office as shall be necessary for the proper
51	performance of the duties prescribed by the provisions of this chapter.
52 53	(b) B. The State Board shall prescribe the duties of the Chancellor, in addition to those duties
53 54	otherwise prescribed for him by law, and, in its discretion, approve the appointment by the Chancellor of such agents and employees as may be needed by the Chancellor in the exercise of the functions,
5 <del>4</del> 55	duties, and powers conferred and imposed by law and in order to effect a proper organization to carry
56	out his duties.
57	C. The Chancellor shall designate an employee of the State Board to serve as its liaison to the
58	Board of Education.
